ORDER

LALITA DEVI INSTITUTE OF MANAGEMENT & SCIENCE, 847-848, MANDI ROAD,, VILLAGE MANDI , NEW DELHI-110047, DELHI submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B. ED. Course of 1 year duration in terms of section 14(1) of NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to LALITA DEVI INSTITUTE OF MANAGEMENT & SCIENCE, 847-848, MANDI ROAD,, VILLAGE MANDI , NEW DELHI-110047, DELHI for B. ED. course with an annual intake of 100 seats, w.e.f. 21/09/2005 subject to compliance of the following conditions before commencement of the academic session.

- a. Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./ UGC is to be completed before the commencement of the session.
- b. The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session.
- c. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- d. The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- e. That the Reserve fund for an amount equal to three months salary of the Teacher & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/ institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank.

Non-compliance of the above mentioned conditions shall cause action under Section 17(1) of NCTE Act, 1993

3. The recognition is subject to the condition that the affiliating University shall ensure that, among other things, the Institution has appointed required number of faculty members (including Principal/ Head of Department), as per the norms of the NCTE / UGC / Affiliating University.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.



RECOGNITION ORDER

WHEREAS in terms of section 14(1)/15(1) of the NCTE Act, 1993, Gadde Charitable Educational Trust, Plot No. 847-848, Street/Road-Mandi Road, Village/Town/City-Mandi, Post office-Mandi, Tehsil/Taluka-Mehruali, Town/City-New Delhi, District-New Delhi-110047, Delhi has submitted an application (Code No. NRCAPP-3753) to the Northern Regional Committee of NCTE for grant of recognition for conducting B.Ed. (Increase in Intake) on 31.12.2012 in Institute of Lingayat's Laita Devi of Management and Sciences, Plot No. 847-848, Village-Mandi, Post office-Mandi, Tehsil/Taluka-Mehruali Town/City-New Delhi, District-New Delhi-110047, Delhi.

AND WHEREAS on scrutiny/verbal, veracity of the facts & figures as per the application submitted by these institutions, the documents attached therewith, the affidavit and the input received from the visiting team in the form of activity report including videography and also the reply submitted by the institution against letter of intent under clause 7(1) of the NCTE Regulations, 2014 (earlier 7(9) of the NCTE Regulations, 2009), the Northern Regional Committee in its 238th (Part-VI) Meeting held from May 20-31, 2015 is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the concerned Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, faculty, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Lingayat's Laita Devi of Management and Sciences, Plot No. 847-848, Village-Mandi, Post office-Mandi, Tehsil/Taluka-Mehruali Town/City-New Delhi, District-New Delhi-110047, Delhi for conducting B.Ed. (Increase in Intake) Secondary (Level) of Two years duration with an annual intake of 50 (1 unit) for the academic session 2015-2016 under clause 7(1) of NCTE (Recognition Norms & Procedure) Regulations, 2014 on the fulfilment of the conditions mentioned below :-

- i) The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time. The Institution shall fulfil the revised Norms relating to infrastructure, instructional facilities, enhanced amount of Endowment and Reserve Funds, Number and qualifications of Teaching Staff, Curriculum and implementation strategies in view of the change in duration/intake of programme(s) offered in the institution within the time limit allowed by NCTE.
- ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(1)(c) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- iii) The institution shall comply with the condition as laid down in the clause 8(3) of the NCTE Regulations, 2014 which provides that "An institution which has been recognized by the Council shall obtain accreditation from an accrediting agency approved by Council within five year of such recognition."
- iv) The institution shall ensure that the required number of academic staff for executing the course is always in position.
- v) As per the provisions of the NCTE Regulations, 2014 the following norms have been prescribed for staff qualifications/administrative and professional staff/terms and conditions of service etc.

NORMS AND STANDARDS FOR BACHELOR OF EDUCATION PROGRAMME LEADING TO THE BACHELOR OF EDUCATION (B.ED.) DEGREE – Regarding Staff

5.1 Academic Faculty

For an intake of two basic units of 50 students each, that is total student strength of 200, there shall be 16 full-time faculty members.

The distribution of faculty across different curricular areas shall be as under:

1. Principal / HoD	One
2. Perspectives in Education	Four

3.	Pedagogy subjects - (Maths, Science, Social Science, Languages)	Two
4.	Health and Physical Education	One
5.	Fine Arts	One
6.	Performing Arts (Music/Dance/Theatre)	One

Note: (i) The faculty positions listed under different subject categories may teach course(s) in the Teacher Education Programme across curriculum areas specified, and can state in both foundation and pedagogy course(s). If the students strength for two years is one hundred (with one basic unit) only, the number of faculty shall be reduced to 8.
(ii) Faculty can be utilized teaching in flexible manner so as to optimize academic expertise available.

5.2 Qualifications

The faculty shall possess the following qualifications:

A.	Principals / HOD
(i)	Postgraduate degree in Arts / Sciences / Social Sciences / Humanities/Commerce with minimum 55% marks; and
(ii)	M.Ed. with minimum 55% marks; and
(iii)	B.Ed in Education or in any pedagogic subject offered in the institutions; and
(iv)	Eight years of teaching experience in a secondary Teacher Education Institution. Desirable : Diploma/Degree in Education Administration or Educational Leadership.
B.	Perspectives in Education or Foundation Courses
(i)	Postgraduate degree in Social Sciences with minimum 55% marks; and
(ii)	M.Ed. degree from a recognized university with minimum 55% marks; OR
(i)	Postgraduate (MA) degree in Education with minimum 55% marks; and
(ii)	B.Ed/B.Ed. degree with minimum 55% marks.
C.	Curriculum and Pedagogic Courses
(i)	Postgraduate degree in Sciences / Mathematics /Social Sciences/Languages with minimum 55% marks; and
(ii)	M.Ed. degree minimum 55% marks

Desirable : PhD degree in Education with subject specialisations.

[Note : In case of B and C put together, for two faculty positions, a postgraduate degree in Sociology/Psychology/Philosophy with 55% marks, and B.Ed. /B.Ed.Ed. with 55% marks and three years of teaching experience in a secondary school shall be considered].

D.	Specialised Courses Physical Education
(i)	Master of Physical Education (M.P.Ed.) with minimum 55% marks. (Training/qualification in yoga education shall be desirable)

Visual Arts

(i)	Post graduate degree in Fine Arts (MFA) with minimum 55% marks.

5.3 Administrative and Professional Staff

Qualifications:

As prescribed by State Government/UT Administration concerned.

Note : In a composite institution, the Principal and academic, administrative and technical staff can be shared. There shall be one Principal and others may be termed as HoDs.

5.4 Terms and conditions of service:

The terms and conditions of service of teaching and non-teaching staff including selection procedure, pay scales, age of superannuation and other benefits shall be as per the policy of the State Government/Affiliating body.

The institutions shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014 and ensure the following before commencement of the session:-

- (a) The institution which have submitted reply to Letter of Intent and appointed staff as per provisions of the NCTE Regulations, 2014 with the approval of the affiliating body shall be required to modify/replace the required faculty as per provisions of the NCTE Regulations, 2014. The institution shall be required to submit the compliance report before the commencement of the session 2015-16.
- (b) As per the provisions of the NCTE Regulations, 2014 an institution is allowed/permited to take two units as a chain of 4 teacher education programme. Accordingly, the faculty requirements have been laid down for two units of the programme in the Regulations 2014 i.e. for 100 students in the first and the second year. However, those institutions whose applications are pending i.e. for one unit i.e. 100 students in the first and second year, the requirement of faculty shall be reduced to eight out of which five lecturers i.e. one each for Science, Social Studies, Mathematics and two for Languages and one Health and Physical Education lecturer and one Performing/Visual Art Lecturer, and one Principal or Head of the Department shall be appointed. One of the lecturers may possess a post-graduation degree in Psychology/Philosophy/Sociology if the Principal/Head of the Department possess PG degree in one of the school subjects.
- (c) The institutions having applied for D.Ed.Ed. course are being granted recognition for one unit only, as the application made by the institution was for an intake of 50 students.
- (i) The institutions whose applications were pending with the Regional offices before 1.1.2014 (the date of notification of Regulations, 2014), shall be considered for recognition as stand-alone institutions but they shall move gradually to become a composite institution but not later than 2016-17.
- (ii) As per the guidelines issued by the NCTE HQ vide letter No. 314/2014/NCTE/Reg/S dated 24th December, 2014, the institutions shall be required to fulfil the requirement of additional staff, infrastructure by 31st October, 2015 in case recognition has been granted for two units of B.Ed. course. However in respect of B.Ed. programme, under new Regulations, 2014, there is a change in basic unit size and required infrastructure, staff pattern etc., the NRC shall cause inspection of the institution by 29 Feb., 2016 for ascertaining the fulfilment of infrastructural facilities. If the institution fails to comply with these requirements, the permission given for one basic unit out of two basic units shall be withdrawn.

Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable. The affiliating body (University/State Govt.) shall also required to verify the authenticity of the land & building documents as well as requirement of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

2. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of financial accounts duly audited by a Chartered Accountant.

3. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

1. Copy of the Application Form
2. Land and Building Particulars
3. Staff Profile
4. Recognition letter
5. Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needed done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 34(1) of the NCTE Act.

Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 16 of NCTE Act, 2002 or the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The timelines for filing appeal may be seen on NCTE's website.
