ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution i.e SLD Girls College of Education, M. No. 83, Killa No. 22, 23, 1/2, M. No. 85, Killa No. 2 - Khasra No. 1/1-21, INIFID Campus, Agra Chowk, New Colony Road, Palwal - 121101, has been recognized for B.Ed course by NRC vide order No. F.NRC/NCTE/F-7/HR-871/ 31125-31191 dated 24th Oct 2007 & F.NRC/NCTE/HR-871/20-08/41044 to 41050 dated 10th March 2008 with an annual intake of 100.
- AND WHEREAS, the institution has by affidavit consented to come under New Regulations and has sought for two basic units in B.Ed., which requires additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each, subject 4. to the institution fulfilling the following conditions, namely:-
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Northern (i) Regional Committee, with required documents by October 31, 2015.
 - The institution for additional unit will be required to submit the required documents such as, land documents, non-encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in (ii) the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents, if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - The Regional Committee shall arrange for verification of documents, inspection of these premises and (iii) check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court (iv) order/reply to SCN/complaint/already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases
 - Now therefore, in light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to SLD Girls College of Education, M. No. 83, Killa No. 22, 23, 1/2, M. No. 85, Killa No. 2 - Khasra No. 1/1-21, INIFID Campus, Agra Chowk, New Colony Road, Palwal - 121101 for conducting B.Ed. programme of two years duration with an annual intake of 100 students, for two basic units of 50 students, from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

- The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
 - Sanctioned programmes along with annual intake in the institution. (a)
 - Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale (b) of pay and photograph.
 - Name of faculty members who left of joined during the last quarter. (c)
 - Names of students admitted during the current session along with qualification, Percentage of marks in the (d) qualifying examination and in the entrance test, if any, date of admission, etc.
 - Fee charged from students. (e)
 - (f) Available infrastructural facilities.
 - Facilities added during the last quarter. (g)
 - Number of books in the library, journals subscribed to and additions, if any, in the last quarter. (h)
 - The affidavit with enclosure submitted along with application. (i)
 - The institution shall be free to post additional relevant information, if is so desires. (j)
 - Any false or incomplete information on website shall render the institution liable for withdrawal of (k) recognition.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawah of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
