ORDER

Scpol,

**Indo Global College of Education, Indo Global Education City, Abhipur, Ropar - 140109, Punjab** submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for **E.T.T. Course** of Two Year duration in terms of Section 15(1) of NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Indo Global College of Education, Indo Global Education City, Abhipur, Ropar - 140109, Punjab** for an annual intake of **50 seats (Fifty Only)** in the 1<sup>st</sup> year and the same for the 2<sup>nd</sup> year in **E.T.T. Course** of Two Year Duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session :-

- Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt. / UGC is to be completed before the commencement of the session.
- The countersigned statement of all faculty members from the Registrar of the concerned affiliating body should be submitted before the commencement of the academic session 2004-2005.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition Order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management / institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank.
- Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum that they are going to adopt for the course.
- Institution if starts the training programme without prior approval / permission of competent authority / examining body regarding the curriculum they have adopted and conduct of examination for award of Diploma / Certificate, the recognition of such institution shall stand withdrawn.
- Non-compliance of the above mentioned conditions shall cause action under Section 17(1) of NCTE Act, 1993.
