## ORDER

In terms of Section 15(1) of the NCTE Act, 1993 Achariya Teacher Training Institute, No. 5, Villupuram Main Road, Villianur, Pondicherry-605110, Pondicherry had submitted an application to the Southern Regional Committee of NCTE for grant of permission for starting Elementary[Additional Intake] teacher training course of two years duration from the academic session 2004-2005 with an additional intake of 50(Fifty only) students.

- On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following.
  - The institution will ensure that the permanent building is constructed within a period of 3 years on the acquired land.
  - The institution has created an Endowment fund of Rs. 5 00 lakhs and a b. Reserve fund of Rs. 3.00 lakhs.
  - The institution has selected Eighteen teachers for the said course and the faculty list is not approved by the Director, School Education, Pondicherry.
  - Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to Achariya Teacher Training Institute, No. 5, Villupuram Main Road, Villianur, Pondicherry-605110, Pondicherry for Elementary (Additional Intake) course of two years duration from the academic session 2004-2005 with an annual intake of 150 students including existing intake of 100 students and an additional intake of 50 students subject to fulfillment of the following.
    - The institution will ensure that Eighteen faculty members are in position for an annual intake of 150 students before commencement of the course and a report to this effect shall be sent to the Committee immediately and in any case not later than one month from the date of commencement of the course. The faculty is to be approved by the Director, School Education, Pondicherry.

- b) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
- The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).
- The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report (PAR) at the end of each academic year along with a copy of the approval of the affiliating University/State Directorate of Education of the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
