### ORDER

In terms of Section 14 (1) of the NCTE Act, 1993 **District Institute of Education and Training, Uthamapalayam – 625 553, Theni District, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for **Elementary Course of Two years duration** from the academic session **2003-04** with an additional intake of **50**, to admit the students belonging to Piramalai Kallar Tribal Community

2. On scrutiny of the application submitted by the institutions, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- The institution has acquired the land for setting up the teacher education institution.
- The institution has constructed the building for conducting the course on the above mentioned land.
- The institution has selected the Principal and **Eleven** teachers for the said course, which is approved by the Director, DTERT, Chennai.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **District Institute of Education and Training, Uthamapalayam – 625 553, Theni District, Tamilnadu** of **two years duration** from the academic session **2003-04** with an annual intake of **100** students which includes the existing intake of 50 students and an additional intake of 50 students, subject to fulfillment of the following.

- The institution will ensure that **Twelve** faculty members duly approved by Directorate of Teacher Education Research and Training (DTERT) are in position for an intake of **100** students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.
- The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.

The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the Directorate of Teacher Education Research and Training (DTERT) to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Southern Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act.
