Sub : Consideration of application of DIET, Kilpennathur-604601, Tiruvannamalai District, Tamilnadu for additional section with an intake of 50 exclusively for SC/ST candidates → regarding.

Preamble :

SRC in its meeting held on 9-10 September, 1999 examined the application submitted by DIET, Kilpennathur-604601, Tiruvannamalai District, Tamilnadu for additional intake of 50 for the academic year 1999-2000 in order to clear the backlog of SC/ST vacancies in Government Educational institutions.

SRC has taken note of the facilities available in the DIETs which have been created with funds from MHRD, Government of India. Further Government of Tamilnadu through its Tribal Welfare Department has also sanctioned funds to create the facilities required and Government of Tamilnadu in G.O.Ms.No.158 dated.17.09.97 has given permission to start additional section exclusively for SC/ST candidates taking in view the lack of SC/ST qualified candidates for employment in educational institutions in the state. Taking note of the above facts, SRC decided to accord recognition to increase the intake by 50 from the academic year 1999-2000.

In exercise of the authority vested under NCTE Act, the Southern Regional Committee after considering the application for grant of permission for increase in intake, accord permission for additional section with an intake of 50 from 1999-2000 in **District Institute of Education & Training, Kilpennathur-604601, Tiruvannamalai District, Tamilnadu** subject to following conditions :

1. Teacher pupil ratio of 1:12 should be maintained as envisaged in NCTE norms.
2. The recognition is subject to the condition that the facilities in the institution are maintained in accordance with the norms prescribed by NCTE from time to time. All future developmental activities and appointment of teaching staff shall be according to NCTE norms.

The institution should send a **Compliance Report** for having maintained the facilities and staff as per NCTE norms to the Regional Committee by **31.12.1999**.


