ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 St. Anthony's Teacher Training Institute, Pavithram Village, Tiruvannamalai District-606806, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed Course on 31.12.2002.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution on 20.01.2005 with an annual intake of 50 students, with stipulation that the institution shall shift to its own premises/building within three years from the date of recognition.

AND WHEREAS, the institution vide its letter dated 21.09.2007 submitted a proposal for change of premises alongwith Rs.40,000/- at Therespuram, Pavithram Village, Thiruvannamalai-606806, Tamilnadu. Accordingly, inspection of the institution at proposed premises for shifting was conducted on 25.04.2011.

AND WHEREAS, the management/trust had suppressed the fact of two different institutions in the same building/premises and thereby had misled and violated NCTE norms and Regulations. Accordingly, a Show cause noticed was issued to the institution on 27.06.2011. The institution has submitted its reply on 19.07.2011.

AND WHEREAS, the SRC in its 211th meeting held on 21-23 September, 2011 considered the reply of the institution dt. 19.07.2011, VT report of the institution and all other related documents along with the original file of the institution and decided that shifting to new/permanent premises be permitted for D.T.Ed (APS01110) course.

NOW THEREFORE, permission is hereby accorded by SRC to St. Anthony's Teacher Training Institute, Pavithram Village, Tiruvannamalai District-606806, Tamilnadu to shift its premises to the new location / building at St. Anthony's Teacher Training Institute, Pavithram Village, Tiruvannamalai District-606806, Tamilnadu.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
