ORDER**

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **Bharathi Educational Trust, Krishnagiri District, Tamilnadu** had submitted an application to Southern Regional Committee of NCTE for grant of recognition to **Shri Bharathi Teacher Training Institute, No.4/630, Schoolagiri Bye-Pass, Royakottai-635116, Krishnagiri, Tamilnadu** for D.T.Ed-AI Course of two years duration with an annual intake of 50 students on 30.11.2004.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition vide order No. F.SRO/NCTE/TN-AI/2005-06/2375 dated 12.08.2005 with the condition to shift to own premises within 3 years.

AND WHEREAS, the SRC in its 157th meeting held on 23-24 April 2008 considered the letter received from the State Government of Tamilnadu stating some lapses that prevailed in 54 D.T.Ed institutions in Tamilnadu, Bharathi TTI, Krishnagiri was one among the 54 institutions.

AND WHEREAS, the SRC resolved to serve Showcause Notice under Section 17 to all the 54 institutions listed in the letter to explain as to why the lapses regarding infrastructural, instructional and faculty positions prevail in these institutions and the Management's of those institutions are asked to submit the reply within a period of 21 days from the date of receipt of the Notice. Accordingly notice was issued to the institution on 27.07.2008 for the following reasons:

- ❖ The principal approved by DTERT has left and Lecturers in English and Mathematics subject approved by DTERT have also left. Approval for the newly replaced staff members have not been obtained from DTERT.
- ❖ The entire building of the Teacher Training Institute is running under the asbestos roof.

AND WHEREAS, the institution has not submitted its reply even after completion of stipulated period, the matter was considered by SRC in its 191st meeting held on 20-21 April 2010 and the Committee considered the above matter and decided to serve Final Notice. Accordingly final notice was issued to the institution on 01.06.2010. The institution submitted its reply on 21.06.2010.

AND WHEREAS, the written representation was considered by SRC in its 194th meeting held on 21st-22nd July 2010 and it was decided to cause inspection of the institution for D.T.Ed. Course, under Section 17 of NCTE Act, after payment of Rs.40,000/- inspection fee and on submission of filled in Questionnaire, along with relevant supporting documents relating to building, land, including Building Completion Certificate from the competent Government Engineer and Land Use Certificate, within four weeks from the date of confirmation of the Minutes.



AND WHEREAS, a letter was issued to the institution to submit Rs. 40000/- on 03.08.2010. The institution submitted its reply on 11.08.2010 alongwith Rs.40000/-. Another letter has been issued to the institution to submit filled in Questionnaire, along with relevant supporting documents relating to building, land, including Building Completion Certificate from the competent Government Engineer and Land Use Certificate on 27.08.2010.

AND WHEREAS, Inspection of the institution for shifting of premises was conducted on 09.09.2010. The Committee in its 197th meeting held on 13th-14th October 2010 considered the VT report of the institution, VCD and other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting to permanent Building/Premises.

NOW, THEREFORE, the institution is permitted to shift from **Shri Bharathi Teacher Training Institute, No.4/630, Schoolagiri Bye-Pass, Royakottai-635116, Krishnagiri, Tamilnadu to new permanent building at Thavalam Village, Ittikal Agaram, Krishnagiri District-635122, Tamilnadu** for conducting D.T.Ed course of two years duration with an intake of 50 students.

Also order that a copy of this order be published in the Official Gazette.
