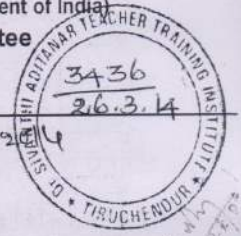

ORDER

WHEREAS, Dr. Sivanthi Aditanar Teacher Training Institute, Tirunelveli Road, Tiruchendur-628215, Thoothukudi District, Tamilnadu had submitted an application for D.T.Ed Course on 28.01.2004. The institution was granted recognition on 17.09.2004 with an annual intake of 50 students, with the condition to shift to own premises within 3 years from the date of recognition.

AND WHEREAS, the institution vide its letter dated 27.12.2007 submitted Rs.40000/- for shifting of premises.

AND WHEREAS, the SRC considered the matter in its 200th meeting held on 20th-21st January 2011 and all relevant documents and decided to cause composite inspection for all the courses to examine whether the institution fulfils all the requirements as per the norms, for the proposed programme.

AND WHEREAS, the inspection of the institution was fixed between 23rd March-2nd April 2011. The same was intimated to the institution on 04.03.2011. Accordingly, inspection of the institution was conducted on 28.03.2011.

AND WHEREAS, the SRC in its 204th meeting held on 27th-28th April 2011 considered the VT report, VCD and all the relevant documentary evidences and it was decided to serve the Show Cause Notice Under NCTE Act. Accordingly, show cause notice was issued to the institution on 27.05.2011. The institution submitted its reply on 24.06.2011.

AND WHEREAS, the SRC in its 211th meeting held on 21st-23rd September, 2011 considered the written representation/ reply for show cause notice and all the relevant documentary evidences and decided to serve the final Show cause Notice under NCTE Act.

AND WHEREAS, final Show Cause Notice was issued to the institution on 17.11.2011. The institution has not submitted reply to the Show Cause Notice even after stipulated period of 21 days from the date of issue of the Notice.

AND WHEREAS, the institution had submitted written representation only on 21.11.2012 i.e., after one year for the notice issued to the institution vide F.No.APS03260/D.T.Ed/TN/2011/28847 dtd.27.05.2011. However, the institution has not submitted any written representation for the Final Show Cause Notice dtd.17.11.2011. The institution has replied vide letter dt.09.11.2012 for the deficiencies pointed in the show cause notice:

1. Building completion certificate from the Competent Govt. authorized Engineer is to be submitted.
2. Science lab needs to be strengthened.
3. Education Technology lab is to be established.
4. Language lab is not available.
5. Earmarked area for each course D.T.Ed, B.Ed and M.Ed is to be given. The management has admitted in its reply that there is shortage of 816 sq.mts of built up area. The evidence of additional construction, if any, is to be submitted.

AND WHEREAS, based on the above points the SRC in its 237th meeting held on 05th -06th January, 2013 and decided to withdraw the recognition of D.T.Ed (APS03260) course run by Dr. Sivanthi Aditanar Teacher Training Institute, Tirunelveli Road, Tiruchendur-628215 Tamilnadu from the academic year 2013-14, in order to enable the ongoing batch of students in D.T.Ed course, if any, to complete their course.

AND WHEREAS, a withdrawal order was issued to the institution on 26.02.2013. Aggrieved by the withdrawal order of SRC institution preferred an appeal to the NCTE Hqrs.

AND WHEREAS, the Appellate Authority vide order no. F.No.89-144/2013 Appeal/9th Meeting-2013 dated 25.07.2013 has stated as follows:-

"after perusal of the documents, memorandum of appeal, affidavit and after considering oral arguments advanced during the hearing, the Council concluded that the institution did not have adequate built up area at the time of inspection and therefore, the appeal deserved to be rejected and the order of SRC confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against".

AND WHEREAS, SRC NCTE is in receipt of Court Order dtd.30.08.2013 from the Hon'ble High Court of Judicature at Madras in W.P.No.13413 of 2013, which reads as follows:

"...the impugned order is set aside and the writ petition is allowed. NCTE, SRC, Bangalore, is directed to consider the evidence of additional construction and the documents submitted by the petitioner, along with its reply dated 09.11.2012, in proper perspective, and grant recognition, within one week from the date of receipt of a copy of this order. Consequently, M.P (MD) No. 1 of 2013 is closed. No costs".

AND WHEREAS, in obedience to the court direction the reply of the institution vide dated 09.11.2012 was processed and placed before the SRC in its 256th meeting held on 04th -05th December 2013 and the committee considered the Hon'ble High Court order dated 30/08/2013, reply of the institution, and other documentary evidences and decided to serve Show cause Notice under NCTE Act, for the following:


1. The management is running B.Ed, M.Ed and D.T.Ed courses, in the same building, and no earmarked built up area for each of the course/programme is submitted. The institution has not submitted evidence of documents towards additional construction.
2. No documentary proof is being submitted by the institution regarding strengthening of Science lab.
3. No documentary proof is being submitted by the institution regarding strengthening of Education Technology lab.
4. No documentary proof is being submitted by the institution regarding strengthening of Language learning lab.

AND WHEREAS, a Show Cause Notice was issued to the institution on 09.01.2014. The institution had submitted its written representation on 30.01.2014.

AND WHEREAS, the SRC in its 264th meeting held on 01st -03rd March, 2014 has considered the reply of the institution vide letter dated 30.01.2014 all other relevant documentary evidences and decided to allow for shifting of the institution to the new premises.

NOW THEREFORE, permission is hereby accorded to **Dr. Sivanthi Aditanar Teacher Training Institute, Tirunelveli Road, Tiruchendur-628215, Thoothukudi District, Tamilnadu** to shift its premises to the new location / building which is attached to Dr. Sivanthi Aditanar College of Education, run by the same management for D.T.Ed Course, and continue recognition till further orders.

ORDER

In terms of Section 15 (1) of the NCTE Act, 1993 **Dr. Sivanthi Aditanar Teacher Training Institute, Tirunelveli Road, Tiruchendur - 628215, Thoothukudi District, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of permission for **Elementary Teacher Training Course of two years duration** from the academic session **2004-05** with an intake of **50**.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- The institution has acquired the land for setting up the teacher education institution.
- The institution will ensure that the permanent building is constructed within a period of 3 years on the acquired land.
- The institution has created an Endowment fund of Rs. 5.00 lakhs and a Reserve fund not maintained.
- The institution has selected the Principal and five teachers for the said course and the staff list is not approved by the DTERT, Chennai.

3. Now therefore, in exercise of the powers vested under Section 15(1) of the NCTE Act, 1993, the Southern Regional Committee hereby grants permission to **Dr. Sivanthi Aditanar Teacher Training Institute, Tirunelveli Road, Tiruchendur - 628215, Thoothukudi District, Tamilnadu** to offer **Elementary course of two years duration** from the academic session **2004-05** with an annual intake of **50** students, subject to fulfillment of the following.


- The institution will ensure that **6** exclusive faculty members duly approved by the state board are in position for an intake of **50** students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course. The faculty list is to be approved by the Director, DTERT, Chennai.

- b) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- c) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
4. Further, the permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Southern Regional Committee may withdraw the permission under the Provisions of Section 17(1) of the NCTE Act, 1993.
7. Recognition is subject to the outcome of petition(s) for Special Leave to Appeal (Civil) No. 13271/2004.
