ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Tiruvalluvar Educational Trust, Thiruvannamalai District, Tamilnadu has submitted an application to the Southern Regional Committee of NCTE in the name of Aravindhar Teacher Training Institute, Aravindhar Nagar, Thenpallipattu, Kalasapakkam-606751, Thiruvannamalai District, Tamilnadu for seeking grant of recognition for conducting D.T.Ed course on 30.12.2004.

- AND WHEREAS after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and the recognition was refused vide order dated 03.08.2009.
- AND WHEREAS the applicant institution preferred appeal under Section 18 of NCTE Act, before NCTE, New Delhi on 09.10.2009. The Appellate Authority remanded back the case to SRC for causing inspection of the institution to ascertain the infrastructural and instructional facilities vide order dated 12.02.2010.
- AND WHEREAS inspection of the institution was conducted on 03.06.2010. SRC in its 193rd meeting held on 21st-22nd June 2010 on careful perusal of the original file of the institution, Visiting Team Report, Video CD, other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time laid on the table, written representation from the institution, the Regional Committee decided to issue Letter of Intent for grant of recognition to D.T.Ed. course of two years duration with an annual intake of 50(Fifty only)(one unit) for the academic year 2010-11 subject to the appointment of qualified staff through duly constituted selection committee as per the Norms of NCTE/State Government/Affiliating University and be given effect before the commencement of the academic session. Accordingly letter of intent prior to recognition under clause 7(9) regulation was issued on 28.06.2010.
- AND WHEREAS the institution submitted required documents on 14.09.2010, SRC in its 196th meeting held on 15th-1th September 2010 and SRC decided to issue formal recognition to the institution.
- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Aravindhar Teacher Training Institute, Aravindhar Nagar, Thenpallipattu, Kalasapakkam-606751, Thiruvannamalai District, Tamilnadu for conducting D.T.Ed Course of two years duration with an annual intake of 50 from the academic session 2010-11 under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:

- The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or Mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
- IV. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
- 8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition letter
 - (v) Information for having fulfilled the norms & standard and other required conditions.

10. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
