ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 **Mahendra Teacher Training Institute, Salem-Attur Road, Minnampalli Valapadi Taluk, Salem District, Pin-636140, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed Course on 24.12.2004.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution for D.T.Ed course on 17.11.2006 with an annual intake of 50 students with stipulation that the institution shall shift to its own premises/building within three years from the date of recognition.

AND WHEREAS, the SRC in its 181st meeting held on 20-21 August 2009 was decided that the institution which have not shifted to the permanent premises even after the expiry of three years time limit be issued notice under section 17 of NCTE Act for further action.

AND WHEREAS, a notice was issued to the institution on 23.07.2010. The institution had submitted reply on 20.08.2010. The committee considered the matter in its 196th meeting held on 15-16 September 2010 and decided to cause inspection for shifting of premises.

AND WHEREAS, the inspection of the institution for D.T.Ed course was conducted on 16.11.2010. The SRC in its 199th meeting held on 22-23 December, 2010 considered the VT Report, VCD and all the relevant documentary evidences and decided to serve Show cause Notice under section 17 of NCTE Act. Accordingly, show cause notice was issued to the institution on 31.01.2011. The institution had submitted its reply on 23.02.2011.

AND WHEREAS, the SRC in its 202nd meeting held on 14-15 March 2011 had decided to issue Final Show Cause notice to the institution under section 17 of the NCTE Act. Accordingly, a Final show cause notice was issued to the institution on 11.04.2011. The institution had submitted its reply on 09.05.2011.

AND WHEREAS, the SRC in its 205th meeting held on 18-19 May, 2011 considered reply & found that the reply the of the institution is not convincing and hence unsatisfactory and decided to withdraw the recognition for D.T.Ed. course. Further, the Committee decided to await the reply of the institution for B.Ed (APS03664) course for the shifting inspection being done on 12.09.2010. Accordingly, withdrawal order was issued to the institution on 27.06.2011.


AND WHEREAS, the institution preferred appeal to NCTE, Hqrs and the Appellate Authority vide order dt. 04.11.2011 had reversed the withdrawal order of SRC with a direction to restoration of recognition. Accordingly, the appeal is accepted and the order of SRC dated 27.06.2011 is reversed.

AND WHEREAS, the SRC in its 214th meeting held on 28th November, 2011 considered the appellate authority order dt. 04.11.2011 and decided to restore recognition of the institution.

NOW THEREFORE, recognition accorded to the institution for D.T.Ed course with annual intake of 50 students vide order no. F.SRO/NCTE/D.T.Ed/2006-2007/9362 dated 17.11.2006 continue till further orders.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
