**ORDER**

**WHEREAS**, Sri Balaji Teacher Training Institute for Women, Tirunelveli District, Tamilnadu submitted application for seeking grant of recognition for D.T.Ed course on 11.07.2005.

**AND WHEREAS**, the application was processed and recognition order was issued to the institution on 25.05.2006 at No.62, Kalakad Road, Cheranmahadevi, Tirunelveli-627414, Tirunelveli, Tamilnadu with the condition to shift to own premises within 3 years.

**AND WHEREAS**, the institution vide its letter dated 08.02.2010 submitted Rs.40000/- for shifting of premises at No.309/5 & 311, Cherankovilpathu Village, Cheranmahadevi, Tirunelveli, Tamilnadu.

**AND WHEREAS**, accordingly the shifting inspection of the institution was fixed between 7<sup>th</sup>-11<sup>th</sup> March 2011. The same was intimated to the institution on 04.03.2011. Accordingly inspection of the institution was conducted on 08.03.2011. The management is also running B.Ed (APS04359) in the same building.

**AND WHEREAS**, the SRC in its 203<sup>rd</sup> meeting held on 31 March & 1 April 2011 considered the VT report, VCD and all the relevant documentary evidences and decided to issue Show Cause Notice under Section 17 of NCTE Act. Accordingly, Show Cause notice was issued on 5.5.2011. Reply to the Show Cause notice not received from the institution.

**AND WHEREAS**, while considering the proposal of B.Ed course, the SRC in its 205<sup>th</sup> meeting held on 18-19 May 2011 decided to re- inspect both B.Ed and D.T.Ed courses.

**AND WHEREAS**, accordingly, inspection was carried out for B.Ed and D.T.Ed courses on 27.7.2011.

**AND WHEREAS**, the SRC in its 211<sup>th</sup> meeting held on 21-23<sup>rd</sup> September 2011 considered the VT report, VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice under Section 17 of NCTE Act.

**AND WHEREAS**, accordingly, a show cause notice was issued to the institution on 15.11.2011. The institution had submitted its written representation on 21.12.2011.

**AND WHEREAS**, the SRC in its 216<sup>th</sup> meeting held on 11-12 January 2012 considered the reply of the institution vide letter dt. 21.12.2011, VT report of the institution and other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting to new premise.

**NOW THEREFORE**, recognition accorded to **Sri Balaji Teacher Training Institute for Women, 62, Kalakad Road, Cheranmahadevi, Tirunelveli District-627414, Tamilnadu** for D.T.Ed course is hereby permitted to shift to new address i.e. **Sri Balaji Teacher Training Institute for Women, No.309/5, Knowledge Temple Campus, Shri Ramachandra Nagar, Cherankovilpathu Village, Kalakkad Road, Cheranmahadevi, Tirunelveli District-627414, Tamilnadu.**

Further, in view of the fact that NCTE Regulations (Recognition Norms and Standards) 2014 as notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Recognition, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders\* made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
