ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 **Krishna Teacher Training Institute, No. 28, Peygopuram, 9th Street, Thiruvannamalai District-606601, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed Course on 01.12.2005.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution for D.T.Ed course on 26.10.2006 with an annual intake of 50 students with stipulation that the institution shall shift to its own premises/building within three years from the date of recognition.

AND WHEREAS, the institution vide its letter dated 14.07.2011 submitted bearing DD No. 972033 dtd. 06.07.2011 of Rs.40.000/- for shifting of premises along with duly filled in questionnaire. The institution required for shifting of premises to address of Krishna Teacher Training Institute, Meyyur Village & Post, Tiruvannamalai Taluk, Tiruvannamalai District-606753, Tamilnadu.

AND WHEREAS, the matter was considered by the SRC in its 209th meeting held on 31st July, 2011 and decided to cause Shifting inspection of the institution for D.T.Ed. Course, under Section 17 of NCTE Act, to verify the facts and the institution be directed to submit all relevant documents. Accordingly, the shifting inspection of the institution was conducted on 13.10.2011.

AND WHEREAS, the SRC in its 215th meeting held on 12th-13th December, 2011 considered the VT Report, VCD and all the relevant documentary evidences and decided to serve Show Cause Notice under Section 17 of NCTE Act. Accordingly, a Show Cause Notice was issued to the institution on 24.01.2012. The institution had submitted its written representation on 23.02.2012.

AND WHEREAS, further, the institution had submitted the DD bearing no. 972033 dtd. 06.07.2011 for Rs. 40,000/- towards inspection fee is enclosed. As the validity of the Demand Draft has been expired, you are requested to revalidate the Demand Draft and submit immediately to this office. Accordingly, the institution had submitted renewed DD bearing no.972033 dtd. 02.02.2012 for Rs. 40,000/-



AND WHEREAS, the SRC in its 221st meeting held on 19th-20th April, 2012 considered the reply of the institution dt. 23.02.2102 and all the relevant documentary evidences and decided to serve Final Show Cause Notice under Section 17 of NCTE Act. Accordingly, a Final Show Cause Notice was issued to the institution on 17.05.2012. The institution had submitted its written representation on 05.06.2012.

AND WHEREAS, the SRC in its 224th Meeting held on 14th-16th June, 2012 considered the written reply of the institution vide letter dt. 05.06.2012 and other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting to new premises is permitted.

NOW THEREFORE, permission is hereby accorded by SRC to **Krishna Teacher Training Institute, No. 28, Peygopuram, 9th Street, Thiruvannamalai District-606601, Tamilnadu** to shift its premises to the new location / building at **Krishna Teacher Training Institute, Meyyur Village and Post, Tiruvannamalai Taluk, Tiruvannamalai District, Pin-606 753, Tamilnadu.**
