WHEREAS, **Jairams Educational Trust, Karur; Tamilnadu** has submitted an application to the SRC, NCTE for grant of recognition to **Jairam Teacher Training Institute, Salem By-Pass Road, N.H. 07, Near Mahamariamman Temple, LNS Post, Karur District-639002, Tamilnadu** for Elementary (D.T.Ed) course of two years duration with an annual intake of 50 Students and recognition was granted to the Institution on 28/09/2006.

AND WHEREAS, the institution has submitted shifting proposal on 1/10/2009 along with D.D. of Rs. 40,000/-

AND WHEREAS, a letter has been received from **Jairam Teacher Training Institute, Karur**, on 28/07/2014 status as following :

".....we are granted recognition for conducting Elementary D.T.Ed Course of the two years duration from the academic session 2006-2007 with an annual intake of 50 students after getting the approval for principal and five faculty members by The Director, SCERT Chennai. We are admitting 50 students from the academic year 2006-2007 to 2012-2013.

In the academic year 2013-2014 and 2014-2015 we did not admit student 1 year for D.T.Ed course. So we are not in a position to conduct the course. So we want to withdrawal of the recognition of D.T.Ed course in this year. So I request you sir, Kindly withdraw the recognition and take necessary.

AND WHEREAS, the SRC in its 271st meeting held on 1st August, 2014 considered the institutions request for closure of D.T.Ed course and decided to permit the closure by withdrawing the recognition for (APS04566) D.T.Ed course with effect from 2014-2015, in order to enable the ongoing batch of students in D.T.Ed, course, if any, to complete their final year course.


AND WHEREAS, but it is made clear that the institution is debarred from making any further admission subsequent to the date of issue of this order.

AND WHEREAS, the Affiliating body / Examining board / body be informed accordingly. Further decided to return Endowment funds and Reserve fund deposited with SRC NCTE, Bangalore. after ensuring settlement of all staff claims .

NOW THEREFORE, the recognition accorded to **Sri Jairam Teacher Training Institute, Salem By-Pass Road, N.H. 07, Near Mahamariamman Temple, LNS Post, Karur District-639002, Tamilnadu** for D.T.Ed (APS04566) is hereby **withdrawn** as per the request of the institution from the academic year 2014-2015.
