ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Swaminathan Saraswathi Educational Trust, Salem, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Sri Swamy Teacher Training Institute for Women, No.4/1, Masinalcanapatti, Ayothiyapattanam, Salem-636103, Tamilnadu for Elementary(D.T.Ed) Course of two years duration from the academic session 2006-07 with an annual intake of 50 students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- The institution has acquired the land for setting up the teacher education institution.
- The institution has constructed the building for conducting the course on the above mentioned land.
- The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 lakhs.
- The institution has selected the Principal and five teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Sri Swamy Teacher Training Institute for Women, No.4/1, Masinalcanapatti, Ayothiyapattanam, Salem-636103, Tamilnadu, Tamilnadu for Elementary (D.T.Ed) course of two years duration from the academic session 2006-2007 with an annual intake of 50 students subject to fulfillment of the following.

- The institution will ensure that Principal and Five faculty members duly approved by DTERT, Chennai are in position for an intake of 50 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
