ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Pachumuthu Teacher Training Institute, Salem Main Road, Virupatchipuram Village, Dharmapuri Taluk, Dharmapuri District - 636705, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed Course on 15.02.2005.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials, granted recognition to the institution for D.T.Ed course on 24.10.2006 with an annual intake of 50 students with stipulation that the institution shall shift to its own premises/building within three years from the date of recognition.

AND WHEREAS, the SRC in its 181st meeting held on 20-21 August 2009 decided that the institution which were not shifted to the permanent premises even after the expiry of three years time limit be issued notice under Section 17 of NCTE Act for further action. Accordingly, a notice has was issued to the institution on 11.09.2009. The institution vide its letter dated 01.10.2009 had submitted Rs.40,000/towards shifting fee.

AND WHEREAS, the inspection of the institution at proposal premises for shifting was carried out on 20.10.2010. The Committee in its 198th meeting held on 24-26 November 2010 considered the VT Report, VCD and all the relevant documentary evidences and decided to serve Show cause notice under Section 17 of NCTE Act Accordingly, notice was issued to the institution on 05.01.2011. The institution submitted its reply on 25.01.2011.

AND WHEREAS, the SRC in its 201st meeting held on 22-23 February 2011 considered the reply to Show Cause Notice, VT Report, VCD and all the relevant documentary evidences and decided to serve Final Show cause Notice under Section 17 of NCTE Act. Accordingly, a final show cause notice was issued to the institution on 21.03.2011. The institution has submitted in its reply on 11.07.2011.
