### ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Amirtham Educational & Charitable Trust, Chennai had submitted an application to Southern Regional Committee of NCTE for grant of recognition to Amirtham Teacher Training Institute, No.3, Masilamani Nagar, Walajabad, Kanchipuram District-635601, Tamilnadu for D.T.Ed Course of two years duration with an annual intake of 50 students on 29.12.2005.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition vide order No. F.SRO/NCTE/D.T.Ed/2006-2007/10884 dated 05.03.2007 with the condition to shift to own premises within 3 years.

AND WHEREAS, the institution vide letter dated 26.03.2009 submitted Rs.40000/- informing about the construction of its new building. Accordingly a letter calling for documents was issued to the institution on 12.06.2009. Meanwhile, the institution submitted a letter dated 31.07.2009.

AND WHEREAS, the institution vide letter dated 26.02.2010 submitted Building Completion Certificate. Inspection of the institution for shifting of premises was conducted on 24.9.2010. The Committee in its 197<sup>th</sup> meeting held on 13<sup>th</sup>-14<sup>th</sup> October 2010 considered the VT report Dt. 24.09.2010 of the institution, VCD and other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting of the institution to the New / Permanent premises.

NOW, THEREFORE, the institution is permitted to shift from No.3, Masilamani Nagar, Walajabad, Kanchipuram District-635601, Tamilnadu to new permanent bulding at No.85, Mettu Street, Vengudi Village, Kancheepuram District-6361605, Tamilnadu for conducting D.T.Ed course of two years duration with an intake of 50 students.
