ORDER

WHEREAS, Sri Mahalakshmi Educational Trust, Coimbatore submitted an application in the name and style of Sri Mahalakshmi Teacher Training Institute, No.3/302, Mangalam, Palladam, Tirupur Taluk, Coimbatore, Tamilnadu for seeking grant of recognition for D.T.Ed course on 02.01.2006.

AND WHEREAS, the application was processed and recognition order was issued to the institution on 13.11.2006 at Sri Mahalakshmi Teacher Training Institute for Women, No.3/302, Mangalam, Palladam, Tirupur Taluk, Coimbatore, Tamilnadu with the condition to shift to own premises within 3 years.

AND WHEREAS, the institution vide letter dated 15.07.2008 submitted for a proposal for shifting to new premises alongwith Rs.40000/-. A letter was issued to the institution on 12.06.2009 calling for documents to examine the proposal for shifting of premises.

AND WHEREAS, the inspection of the institution for shifting of premises was carried out on 14.11.2010. The Committee in its 198th meeting held on 24th-26th November 2010 considered the VT Report and all the relevant documentary evidences and it was decided to serve Show cause Notice Under Section 17 of NCTE Act. Accordingly, notice was issued to the institution on 05.01.2011. The institution submitted its reply on 04.02.2011.

AND WHEREAS, the Committee considered in its 201st meeting held on 22nd-23rd February 2011 the reply to Show Cause Notice, VT Report, VCD and all the relevant documentary evidences and it was decided to serve Final Show cause Notice Under Section 17 of NCTE Act. Accordingly final show cause notice was issued to the institution on 22.03.2011.

AND WHEREAS, the institution submitted its reply on 18.04.2011 alongwith Rs.40000/-. The committee in its 204th meeting held on 27th-28th April 2011 considered the matter and decided that change of name of the Trust from "**Sri Mahalakshmi Educational Trust**" Coimbatore to "**Sri Azhagammai Charitable Aid Mission**" Coimbatore is permitted subject to payment of Rs. 40000 fee and subject to no change in the location of the institution and Nature/Structure of the management and other usual conditions.

AND WHEREAS, institution has remitted D.D of Rs. 40000/- and the same was taken into account vide receipt dt. 20.04.2011.



ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **Sri Mahalakshmi Educational Trust, Coimbatore District, Tamilnadu** has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to **Sri Mahalakshmi Teacher Training Institute for Women, No. 3/302, Mangalam, Palladam, Tirupur Taluk, Coimbatore District, Tamilnadu** for **Elementary(D.T.Ed)** course of two years duration with an annual intake of **50 (Fifty)** Students.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Sri Mahalakshmi Teacher Training Institute for Women, No. 3/302, Mangalam, Palladam, Tirupur Taluk, Coimbatore District, Tamilnadu** for conducting **Elementary(D.T.Ed)** course of two years duration with an annual intake of **50(Fifty)** students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
 - i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - iii) The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)



4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
6. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
