ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Sree Krishna Educational Charitable Trust, Nammakkal District, Tamilnadu has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Sree Krishna Teacher Training Institute for Women, S.F.No.78/2, 3&6, Sakthinaickenpalayam Namakkal-637205, Tamilnadu Elayampalayam, D.T.Ed(Additional Intake) course of two years for an additional intake of 50 (Fifty) Students.

- 2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Sree Krishna Teacher Training Institute for Women, S.F.No.78/2, 3&6, Sakthinaickenpalayam Group, Elayampalayam, Namakkal-637205, Tamilnadu for conducting Elementary D.T.Ed(Additional Intake) course of two years duration with an annual intake of 100(Hundred) students which includes the existing intake of 50(Fifty) and an additional intake of 50(Fifty) under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
 - i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - ii) The institution shall comply with the various other norms and standards prescribéd in the NCTE regulations, as amended from time to time.
 - iii) The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)

- iv) The institution will ensure that <u>Principal and Eleven</u> faculty members duly approved by DTERT, Chennai are in position for an intake of <u>100</u> students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
- 5. The institution shall make admissions only after it obtains affiliation from the examining body.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 7. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
- 8. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
