NOTICE

Whereas recognition has been granted by SRC, NCTE to **Sri Muthuari Charitable & Educational Trust, Sivagangai District, Tamilnadu** for offering **Sri Raaja Raajan Teachers Training Institute, No.1, S.K.M Building, Taluk Office Main Road, T.T. Nagar, 1st Street, Karaikudi-630002, Tamilnadu** for D.T.Ed course vide order No. 16990 dated 11.01.2008.

The State Government of Tamilnadu in its G.O. (Ms).No.94 dated 03.05.2008 has issued a procedure for affiliation of teacher training institutions post approval of SRC, NCTE. The G.O. has envisaged that the institutions after obtaining recognition from SRC, NCTE, Bangalore shall make application for grant of affiliation to the DTERT, Chennai before 31st May of the year. The DTERT shall communicate the decision of affiliation before 20th June of that year. Further, the DTERT has envisaged inspection of the applicant institution for affiliation with Principal, DIET, RDO, Executive Engineer of PWD and Chief Educational Officer of the District concerned. The inspection team shall verify the documents as envisaged in the G.O. It has been envisaged that in case of non-compliance or non-fulfillment of one or more conditions, a report will be sent to SRC, NCTE, Bangalore regarding the factual position and the affiliation will be deferred till reply is received from the SRC.

Under the provisions of above said G.O, a letter No.6808/C2/2008 dt.20.06.2008 was received from the State Government of Tamilnadu on the above institution informing the deficiencies that exist and non-maintenance of Norms and Standards prescribed for D.T.Ed course by NCTE.

The letter of the State Government referred above was placed before SRC in its 161st meeting of SRC held on 6-7 August, 2008. The SRC considered the letter of the State Government of Tamilnadu along with the application file of the institution and decided to issue notice under Section 17 of NCTE Act and to call for written representation with documentary proof/s for the following deficiencies:-

- ❖ As per the report of the Sub-Collector, Devakottai, dated 19.06.2008 has stated that part of the main building – first and second floor, admeasuring 5847 Sq.ft.ft. and the second and third floor of the Annexe building opposite to the main building admeasuring 4800 Sq.ft.ft. in all 10,647 Sq.ft.ft has been rented @ Rs.16,000/- p.m to Sri Muthumari Charitable and Educational Trust to run Sri Raja Rajan Teacher Training Institute.
- ❖ As per the Inspection of the Executive Engineer, PWD, Building (C&M) Division, Sivagangai, dated 18.06.2008 that light roofing has been provided in the open terrace of the building where workshop, canteens and Arts and Crafts sections have been proposed.
- ❖ Building plan duly approved by the Competent Authority is not produced.
- ❖ The third floor of the annexure building has temporarily roofing.

As per the **Section 17 of NCTE Act, 1993**, an opportunity is hereby given to make written representation. Before the Regional Committee passes the final order on your application, you are hereby given an opportunity for making such written representation as you may wish to make supported by documentary evidence. The institution may submit documentary proof duly certified by the competent authority with respect to the deficiencies notified as above along with an Affidavit and fresh VCD supporting removal of the above deficiencies.

Your written representation must reach this office within 30 days of the receipt of this notice.

Please note that in the event this office not receiving representation within 30 days from the receipt of this notice, it will be presumed that you do not wish to make any representation and the Regional Committee shall take decision as it deems fit and proper.
