ORDER

WHEREAS, **Sri Arunachala Trust, Thiruvannamalai District, Tamilnadu** had applied for grant of recognition to **KEC Teacher Training Institute, No.10, Kanchi Road, Vengikkal, Thiruvannamalai-606604, Tamilnadu** for **D.T.Ed-AI** Course of **two** years duration under Section 15(l) of the NCTE Act, 1993 to the Southern Regional Committee, NCTE.


2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
3. AND WHEREAS, in its 140th Meeting of SRC held on 19-20 August, 2007. The Southern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on **31.08.2007** to the applicant institution under provision to Section 15(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
7. AND WHEREAS, the applicant institution had submitted its written representation **13.09.2007** to SRC, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the Southern Regional Committee in its 147th Meeting of SRC held on 13-14th November, 2007. which came to the conclusion that recognition to the said institution be refused for the following reasons:

- The rented asbestos sheets roofed building is not suitable and not adequate.
- The existing land of 1700 sq. mts. not adequate for D.T.Ed. course.

5. NOW, THEREFORE recognition to **KEC Teacher Training Institute, No.10, Kanchi Road, Vengikkal, Thiruvannamalai-606604, Tamilnadu** for the **D.T.Ed-AI Course** in terms of section 15(3)(b) of the NCTE Act, 1993, is hereby refused.
6. If the institution is not satisfied by the above Order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
7. Also ordered that a copy of this order be published in the Official Gazette.
