**PREAMBLE :**

The The Madura Ramnad Diocesan Management Association, A.V.H. Building 1<sup>st</sup> Floor, 162 East Veli Street, Madurai District, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to D.M. & R. Teacher Training Institute, New Mission Compound, Thirumangalam, Madurai District-625706, Tamilnadu for D.T.Ed Course on 14.11.2006.

After considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on 25.09.2007 to the applicant institution under provisio to Section 15(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

Further, applicant institution had submitted the written representation on 09.11.2007. The said representation was considered by the Regional Committee on 147th Meeting of SRC held on 13-14 November, 2007. and the Committee decided to refuse recognition.

Accordingly, order of refusal was issued vide Ir.No.15420 dated. 30.11.2007.

The applicant institution preferred appeal under Section 18 of NCTE Act, before NCTE, New Delhi. The Appellate Authority considering the appeal passed an order vide.F.No.89-32/2008 dated. 10.07.2008 reversing the decision of SRC.

The NCTE Headquarters Vide Letter dated 04.07.2008 directed this office to issue the recognition orders to the institution wherever reversal of decision is there and place the decision before SRC Subsequently. Accordingly, Conditional Recognition letter was issued to the institution on 29.07.2008. The institution has submitted reply with necessary annexures and staff profile. Accordingly reply was placed before 165th Meeting of SRC held on 27-28 September, 2008. SRC decided to issue Formal recognition order.

Hence the order.

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 The Madura Ramnad Diocesan Management Association, A.V.H. Building 1<sup>st</sup> Floor, 162 East Veli Street, Madurai District, Tamilnadu has submitted an application to the Southern Regional Committee of NCTE for grant of recognition for conducting D.T.Ed-Additional Intake course with an additional intake of 20 on 14.11.2006.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **Elementary** teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **D.M. & R. Teacher Training Institute, New Mission Compound, Thirumangalam, Madurai District-625706, Tamilnadu** for conducting **D.T.Ed-Additional Intake** course of two years duration with an annual intake of **100(Hundred)** students which includes the existing intake of **80(Eighty)** students and an additional intake of **20(Twenty)** students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
  - I. **The admission of students shall be done only after affiliation by the examining body before the commencement of the academic year and the admission of students shall be completed well before the cut off date prescribed by the Examining/Affiliating body for the academic year 2008-2009 failing which the recognition will be deemed to be from the next academic year that is 2009-10.**
  - II. **Formal orders for recognition/permission will operate for 2008-2009 only if the requirement of 180 teaching days in the session would be fulfilled as per calendar of the University/ Affiliating Body.**
  - III. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
  - IV. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - V. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE( Recognition Norms & Procedure) Regulations,2007.
  - VI. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
- (i) Copy of the Application Form
  - (ii) Land and Building Particulars
  - (iii) Staff Profile
  - (iv) Recognition letter
  - (v) Information for having fulfilled the norms & standard and other required conditions.
7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
