WHEREAS, recognition was granted by the Southern Regional Committee, NCTE to James College of Education, Mananvilai, Kappiarai P.O., Near Karinkal, Kanyakumari District-629156, Tamilnadu run by James Memorial Charitable Trust, Colachel & P.O., Kanyakumari District-629251, Tamilnadu vide Order No. F.TN/SEC/SRO/NCTE/2005-2006/2792 dated 06.09.2005 for B.Ed course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, the institution vie its letter dated 24.4.2009 submitted Rs. 40000/- for shifting of premises.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit date 19.01.2015 for its willingness for adherence of provisions of new Regulations.
- **4. AND WHEREAS**, a Revised Provisional Recognition Order No. F.SRO/NCTE/APSO3622/B.Ed/TN/2015-16/65988 was issued to the institution on 30.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 5. AND WHEREAS, the inspection of the institution was conducted and the institution submitted its reply from time to time and after long deliberation the SRC in its 346th meeting held on 24th & 25th October, 2017 considered the matter and decided as under;
 - 1. Their reply is satisfactory. It removes the remaining deficiencies.
 - 2. Issue a fresh FR for B.Ed (2 units) and M.Ed (1 unit) at the new site, under the 2014 Regulations.
- 6. NOW THEREFORE, this order is issued permitting the institution i.e. James College of Education, Plot No.481/8A, 481/9A, 481/13A, 480/14, 498/5, 498/6, Kappiyarai Village,

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 8. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
