### Preamble:

White Memorial College of Education, Veeyannoor P.O. Kanyakumari District, Pin-629169, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for Secondary(B.Ed) Course.

Hon'ble High Court of Madras in W.P.7410 of 2005 has directed NCTE to cause inspection within a period of 3 months. Accordingly, an inspection was carried out on 21.06.2005. The inspection report was placed before 97<sup>th</sup> SRC meeting held during 27<sup>th</sup> July 2005.

After considering the application and other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a letter on 26.08.2005 to the applicant institution thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

The written representation submitted by the said institution dated 6.12.2005 was considered by the Regional Committee in its 106th meeting held on 15-16 December 2005 and decided to accord recognition.

Some of the institutions who have been granted recognition for the subsequent year have preferred appeal before NCTE, New Delhi to reconsider their cases of grant of recognition for the session 2005-06 itself instead of 2006-06. The NCTE, New Delhi vide.order No.F.No.89-156/2005 Appeal dated.28.9.2005 has remanded back the case to SRC with a direction to reconsider these cases immediately for grant of recognition for the session 2005-06.

SRC in its 104<sup>th</sup> meeting held on 9-10 November, 2005 has considered the legal opinion obtained in this regard and has taken decision to grant recognition to the session 2005-06 to those institutions who have submitted belated NOCs/Endorsements and also the essential documents mentioned in Appendix-1B of NCTE Regulations as one time exception.

Hence the order.

- On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
  - The institution has acquired the land for setting up the teacher education institution.
  - The institution has made arrangements for conducting the course in the own premises.
  - c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 lakhs.
  - The institution has selected the <u>Principal and Seven</u> lecturers for the said course.
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to White Memorial College of Education, Veeyannoor P.O. Kanyakumari District, Pin-629169, Tamilnadu for Secondary(B.Ed) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students subject to fulfillment of the following.
  - a. The institution will ensure that <u>Principal and Seven</u> faculty members duly approved by affiliating University are in position for an intake of <u>100</u> students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
  - b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
  - The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
  - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

 If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.

### ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution White Memorial College of Education, Veeyannoor Post, Kanyakumari District-629169, Tamilnadu has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.
- 3. AND WHEREAS, on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.
- 4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
  - The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.
  - The institution shall create additional facilities that include (a) additional built-up area, II. (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - The applicant-institution for additional unit will be required to submit the required 111. documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
  - The Regional Committees shall arrange for verification of documents, inspection of IV. these premises and c heck adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
  - 5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to White Memorial College of Education, Veeyannoor Post, Kanyakumari District-629169, Tamilnadu for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfilment of the conditions mentioned at II & III herein before 31.10.2015
  - 6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

Available infrastructural facilities;

g) Facilities added during the last quarter;

h) Number of books in the library, journals subscribed to and additions, if any, in the last

The affidavit with enclosure submitted along with application.

The institution shall be free to post additional relevant information. if it so desires.

k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
