AND WHEREAS, Kongu Naadu College of Education, Mamaangam, Ammapalayam Post, Salem District - 636302, Tamilnadu had submitted an application for B.Ed Course on 29.12.2004. The institution was granted recognition on 03.09.2005 with an annual intake of 100 students with the condition to shift to own premises within 3 years from the date of recognition (in case the course is started in temporary premises).

AND WHEREAS, SRC-NCTE has received a letter from TNTEU dated 29.01.2013 and 29.05.2013 on 29.01.2013 and 03.06.2013 regarding withdrawal of affiliation to certain colleges.

AND WHEREAS, the SRC in its 247th meeting held on 20-22 June 2013 considered the matter and noted, the disaffiliation ordered by the University on the ground that "explanation submitted by the Management of the College for the Issue of Show Cause Notice to the Kongunaadu College of Education (College Code: 11814), Salem District and resolved to withdraw the affiliation granted to the college on the basis of complaints, adverse Inspection report, dissatisfactory explanation to the Show cause notice and legal opinion stating that is a fit case for withdrawal of affiliation".

AND WHEREAS, accordingly, it is decided by the committee to withdrawn recognition of the institution with respect to the disaffiliation ordered by the University for APS0391–B.Ed course with effect from 2013-14.

AND WHEREAS, before issuance of withdrawal order, the institution has submitted its written representation on 25.06.2013 along with D.D. of Rs.40,000/- and stating that:-

"....recognition was granted by the SRC, NCTE Bangalore in APS03912 has been withdrawn with effect from the academic year 2013-14. The said decision was published in the website of the NCTE and the same is still not concluded or communicated to us. It was also stated in the minutes of the meeting that the reasons for withdrawal of recognition is due to the disaffiliation order by the Tamil Nadu Teacher's Education University, Chennai..."

AND WHEREAS, a court order has been received from Hon'ble High Court of Judicature at Madras in WP No.17714 of 2013 and M.P.No.1 to 3 of 2013 dated 10.10.2013 filed by Konganadu College of Education Vs TNTEU and SRC-NCTE received by on 13.11.2013. The court order stated as follows:-

".....8. The impugned order is set aside and the matter is remitted to the first respondent for fresh consideration. The first respondent is directed to provide all materials relied on for the purpose of taking action against the petitioner and thereafter, decide the matter on merits and as per law. It is needless to point out that opportunity of personal hearing also should be given to the petitioner. Such exercise shall be completed within a period of one month from the date of receipt of a copy of this order. It is made clear that during the currency of the matter before the first respondent, no admission should be made by the petitioner.

The writ petition is allowed to the extent indicated above. No costs. Consequently, connected miscellaneous petitions are closed."

AND WHEREAS, the SRC in its 287th meeting held on 20 May 2015 considered the written representation and the court order and it has decided that process and put up.

AND WHEREAS, accordingly, the detailed agenda was placed before SRC in its 288th meeting held on 31st May 2015 considered the matter and it has decided that obtain all documents and put up for causing shifting inspection.

AND WHEREAS, accordingly, a letter was sent to institution on 04.06.2015 to submit all the documents. The institution has submitted its written representation on 06.07.2015.

AND WHEREAS, the SRC in its 291st meeting held on 20th & 21st August, 2015 considered the matter and it has decided that, (1). In compliance of the court order, restore recognition (2). Issue revised recognition order (3). Cause inspection, after payment of fee, to ensure full compliance of 2014 Regulations after 31st Oct, 2015.

NOW THEREFORE, recognition accorded to Kongu Naadu College of Education, Mamaangam, Ammapalayam Post, Salem District - 636302, Tamilnadu for B.Ed course is hereby restored/continued_till further orders.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.

Further, the institution has submitted affidavit for new recognition on 02.03.2015.

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution Kongu Naadu College of Education, Mamaangam, Ammapalayam Post, Salem District 636302, Tamilnadu has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.
- 3. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
 - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
 - III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- **4. NOW THEREFORE,** in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **Kongu Naadu College of Education, Mamaangam, Ammapalayam Post, Salem District 636302, Tamilnadu** for conducting **B.Ed** programme of **two** years duration with an annual intake of **100** for two basic units of 50 students each from the academic session **2015-16** subject to fulfilment of the conditions mentioned herein before 31.10.2015.
- **5.** Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

- **6.** The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - a) Sanctioned programmes along with annual intake in the institution:
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter:
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information. if it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
