Preamble,

WHEREAS, Shri V P R Trust, Theni District, Tamilnadu has submitted an application to the SRC of NCTE for grant of recognition to Shri.V.P.R. College of Education, Sy.No.2354, K.R.R. Nagar, Theni District-625 531, Tamilnadu for Secondary (B.Ed) course of one year duration with an annual intake of 100 (Hundred) students. The recognition was granted to the institution on 08.11.2006 with a condition to shift its own premises/building within three years from the date of recognition (in case the course is started in rented premises).

AND WHEREAS, the institution has submitted triplicate of applications for shifting of premises on 10.04.2015 along with processing fee of Rs.1,50,000/- and some documents.

AND WHEREAS, accordingly, the application was processed and placed before SRC in its 285<sup>th</sup> meeting held on 17<sup>th</sup> April 2015 considered the matter and decided to cause inspection and ask VT to obtain latest approved staff list and obtain FDRs for the enhanced amounts.

AND WHEREAS, accordingly, inspection of the institution was fixed between 23-25 April 2015. The inspection intimation was sent to the institution on 20.04.2015. The inspection of the institution was conducted on 26.04.2015 and the VT report received in the office of SRC on 28.04.2015.

AND WHEREAS, the SRC in its 286th meeting held on 30th April, 2015 considered the VT report and all other relevant documents, and it has decided to permit shifting of premises for B.Ed.

NOW THEREFORE, permission is hereby accorded by SRC to Shri.V.P.R College of Education, Sy.No. 2354, K.R.R Nagar, Theni District-625531, Tamilnadu to shift its premises to the new location/building at Shri. V.P.R College of Education, Sy.No. 942/1, Bodendirapuram Road, Kodangipatty Post, Bodinayakanur Taluk, Theni District-625547, Tamilnadu for B.Ed course.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

#### ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution Shri. V.P.R College of Education, Sy.No. 942/1, Bodendirapuram Road, Kodangipatty Post, Bodinayakanur Taluk, Theni District-625547, Tamilnadu has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities. 3.AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate 11. (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- The Regional Committees shall arrange for verification of documents, inspection of these III. premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- 4. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Shri. V.P.R College of Education, Sy.No. 942/1, Bodendirapuram Road, Kodangipatty Post, Bodinayakanur Taluk, Theni District-625547, Tamilnadu for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to fulfilment of the conditions mentioned herein before 31.10.2015
- 5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
  - a) Sanctioned programmes along with annual intake in the institution:
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c) Name of faculty members who left or joined during the last, quarter:
  - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - The affidavit with enclosure submitted along with application.
  - The institution shall be free to post additional relevant information. if it so desires.
  - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
