PREAMBLE:

The Arcot Lutheran Church, No.9, ALC Campus, Cuddalore Taluk, Cuddalore, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Arcot Lutheran Church College of Education, Jeevanagar, Main Raod, Nellikuppam, Cuddalore-607105, Tamilnadu for B.Ed Course on 31.10.2008.

After considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on 16.04.2009 to the applicant institution under provision to Section 14(3)(b) of the NCTE Act. 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this benalf.

Further applicant institution had submitted the written representation on 05.05.2009. The said representation was considered by the Regional Committee in its 175th Meeting held on 13-14 May, 2009 and decided to refuse recognition.

Accordingly, order of refusal was issued vide order No.13294 dated. 28.05.2009.

The applicant institution preferred appeal under Section 18 of NCTE Act, before NCTE. New Delhi. The Appellate Authority considering the appeal passed an order vide F No 89-446/2009 dated 11.09.2009 reversing the decision of SRC.

The NCTE Headquarters Vide Letter dated 04.07.2008 directed this office to issue the recognition orders to the institution wherever reversal of decision is there and place the decision before SRC subsequently. Accordingly, Letter of intent was issued to the institution on 12.10.2009. The institution in its letter dated 07.12.2009 has submitted reply with necessary annexures and staff profile. The reply was placed before SRC in its 187th Meeting held on 29-30 December, 2009 and SRC decided to issue formal recognition order.

Hence the order.

ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Arcot Lutheran Church, No.9, ALC Campus, Cuddalore Taluk, Cuddalore, Tamilnadu has submitted an application to the Southern Regional Committee of NCTE for grant of recognition for conducting B.Ed course with an annual intake of 100 on 31.10.2008.

- AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Arcot Lutheran Church College of Education, Jeevanagar, Main Raod, Nellikuppam, Cuddalore-607105, Tamilnadu for conducting B.Ed Course of one year duration with an annual intake of 100 students from the academic session 2009-2010 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2007 subject, to fulfillment of the following conditions:
- The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007
- The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

- The institution shall maintain & update its Web-site as per provisions of NCTE 6 Regulations and always display following as mandatory disclosure:-
 - Copy of the Application Form
 - Land and Building Particulars (ii)
 - Staff Profile (iii)
 - Recognition letter (IV)
 - Information for having fulfilled the norms & standard and other required (v)
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules. Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution Arcot Lutheran Church College of Education, Jeevanagar, Main Road, Nellikuppam, Cuddalore-607105, Tamilnadu has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.
- 3. AND WHEREAS, on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.
- 4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
 - I. The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.
 - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- III. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- IV. The Regional Committees shall arrange for verification of documents, inspection of these premises and c heck adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- 5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Arcot Lutheran Church College of Education, Jeevanagar, Main Road, Nellikuppam, Cuddalore-607105, Tamilnadu for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfilment of the conditions mentioned at II & III herein before 31.10.2015
- 6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- 7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

- 8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - a) Sanctioned programmes along with annual intake in the institution:
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter:
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information. if it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
