ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 K.K.V.P. Rasamma Educational Trust, Karur District, Tamilnadu has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Rasama College of Education, Vettamangalam Village & Post, Palhakalliamman Nagar, Karur District-639117, Tamilnadu for M.Ed course of one year duration with an annual intake of 25(Twenty five) Students.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.


3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Rasama College of Education, Vettamangalam Village & Post, Palhakalliamman Nagar, Karur District-639117, Tamilnadu for conducting M.Ed course of one year duration with an annual intake of 25(Twenty Five) students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:

- i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
- ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- iii) The institution will ensure that One Professor, One Reader and Three Lecturers faculty members duly approved by the affiliating University are in position for an intake of 25 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
5. The institution shall make admissions only after it obtains affiliation from the examining body.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
7. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
8. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.



Whereas recognition has been granted to Rasama College of Education, Vettamangalam Village & Post, Palhakallamman Nagar, Karur District - 639117, Tamilnadu for M.Ed. course with an intake of 25 students vide order no. F.SRO/NCTE/M.Ed/2007-2008/1513 dated 06/06/2008.

- AND WHEREAS, NCTE Hqrs. vide their letter no. F.No.49-4/2010/PT/NCTE(N&S) dated 30th July, 2010 has informed that the enhancement in the intake of one unit of M.Ed. course programme from 25 to 35 has been notified vide National Council for Teacher Education Amendment Regulation, 2010 in the Gazette of India on 26th July 2010. The amendment stipulates that the intake be increased from existing 25 to 35 students from the current session 2010-11, without creation of any additional infrastructure and instructional facilities. NCTE Hqrs has directed to intimate all the institutions of each region having approved M.Ed. Programme of 25 students by issuing a letter that they may enhance it upto 35 students, accordingly.
- NOW THEREFORE enhancement of intake of 10 seats from existing 25 to 35 is permitted to Rasama College of Education, Vettamangalam Village & Post, Palhakallamman Nagar, Karur District - 639117, Tamilnadu for M.Ed. course with effect from the session 2010-2011 till further orders without creation of any infrastructural and instructional facilities.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution, Rasama College of Education, Vettamangalam Village & Post, Palhakallamman Nagar, Karur District-639117, Tamilnadu has by affidavit consented to come under New Regulations and sought for one unit in M.Ed, which requires additional facilities

3. AND WHEREAS, on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 06.05.2008.

4. AND WHEREAS, it has been decided to permit the institution an intake of one unit of 50 students subject to the institution fulfilling following conditions namely,

- I. The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
- II. The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution does not fulfil required norms of infrastructure recognition will be withdrawn.
- III. Further, with regard to the second unit the institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- IV. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection
- V. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017

5. Now therefore, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Rasama College of Education, Vettamangalam Village & Post, Palhakallamman Nagar, Karur District-639117, Tamilnadu for conducting M.Ed programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-16 subject to fulfilment of the conditions mentioned at 4.(I) and 4.(II) herein before 31st July, 2015 and those mentioned at 4.(III), 4.(IV) before 31.10.2015.

6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

8. The Institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the Institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
