WITHDRAWAL ORDER**

WHEREAS, recognition was granted to the institution namely Zion College of Physical Education, CSI Compound 2/35, R.S. Road, Cuddapah-516001, Andhra Pradesh run by Zion Social Educational Agricultural Development Society, Cuddapah, Andhra Pradesh vide SRC (NCTE) order no. F.AP/B.P.Ed/SRO/NCTE/2002-2003/2181 dt. 16.07.2002 for conducting B.P.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 19.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 26.05.2015 for conducting B.P.Ed. course of two years duration with an annual intake of 100 (One basic unit) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 15.02.2019. The institution vide letter dated 14.03.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 376<sup>th</sup> meeting held on 11<sup>th</sup> - 12<sup>th</sup> June, 2019 considered the matter and decided as under;


The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to Zion College of Physical Education, CSI Compound 2/35, R.S. Road, Cuddapah-516001, Andhra Pradesh for conducting B.P.Ed. course w.e.f. the academic session 2019-20 under clause 17(1) of NCTE Act, 1993 on the following grounds: -

1. LUC not submitted
2. EC not submitted
3. Latest faculty list duly approved by the competent authority not submitted
4. FDRs not submitted.

**NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Zion College of Physical Education, CSI Compound 2/35, R.S. Road, Cuddapah-516001, Andhra Pradesh** run by **Zion Social Educational Agricultural Development Society, Cuddapah, Andhra Pradesh** for conducting B.P.Ed programme of two years duration with an annual intake of 100 students (1 unit) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
