Show Cause Notice

WHEREAS, Sri Sapthagiri Srinivas Educational and Cultural Society. Trust, Kolar, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Vishnu B.Ed College, Hanasanahalli Extension, Bangarpet Taluk-563114, Kolar District, Karnataka for Secondary(B.Ed) Course of one year duration from the academic session 2005-06 with an annual intake of 100 students and was granted recognition on 06.01.2006 with a condition to shift to its own premises within three years from the date of recognition (in case the course is run in rented premises).

AND WHEREAS, a court Notice dated 13.12.2013 in W.P.No.56437 of 2013 filed by Vishnu B.Ed College, Kolar District, Karnataka in the Hon'ble High Court of Karnataka at Bangalore was received by this office on 21.12.2013. The case was filed against the State Government of Karnataka and others wherein the SRC, NCTE is the 4th Respondent. The institution prayed to get an interim order staying for the operation of the resolution dated 30/11/2013 passed by the Registrar, Bangalore University.

AND WHEREAS, a letter was issued to the Advocate, Shri.P.S.Dinesh Kumar, on 19.03.2014 for defending the case.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulation, 2009, the National Council for Teacher Education notified the Regulation, 2014 on 01.12.2014. On 22.01.2015, the institution through an affidavit submitted consent for coming under new Regulations, 2014. The revised order was issued to the institution on 18.05.2015 with an intake of 100 students for two basic units of 50 students each.

AND WHEREAS, the institution submitted written representation on 30.10.2015.

AND WHEREAS, the SRC in its 315th meeting held during 17th& 18th June, 2016 considered take written representation of the institution and decided as under:-

- "1. Title deed is in order.
 - 2. EC is a hand- written document in Kannada. Obtain clear English-version copy.
 - 3. BP is not approved by competent authority.

- 4. Inspection fee has not been paid.
- 5. BCC, Original FDRs and latest Faculty list have not been given.
- 6. Ask VT to collect all relevant documents."

AND WHEREAS, a letter was issued to the institution on 12.07.2016.

AND WHEREAS, on 02.08.2016, a letter dated 29.07.2016 has been received from the Chairman, Vishnu B.Ed College, Bangalore, Kolar District, Karnataka requesting for intake of 50 students (one basic unit) of B.Ed. course.

AND WHEREAS, the SRC in its 322nd meeting held during 20th -21st October, 2016 considered the written representation of the institution and decided as under:-

- 1. Request for reduction of intake from 2 units to one unit is accepted.
- 2. Ask them to submit all relevant documents for processing the case for issue of a new FR under the 2014 Regulations for B.Ed (1unit).
- 3. If documents have already been received process and put up.

AND WHEREAS, a letter was issued to the institution on 16.11.2016.

AND WHEREAS, a letter dated 30.11.2016 received by Bangalore University regarding reduction of intake in respect of several B.Ed College under Bangalore University.

AND WHEREAS, a letter was issued to Bangalore University, These institution have yet to present these documents due to which their application for reduction of intake of students from 2 units to 1 unit B.Ed course is still pending.

AND WHEREAS, the institution submitted written representation on 26.04.2018 for enhancement of intake from 50 to 100.

AND WHEREAS, the institution vide letter dated 09.04.2019 has again requested as under: -

"With respect to the above cited subject, I am herewith requesting you to kindly enhancing the intake of 50 Students to 100 students. i.e. one unit to two units in B.Ed., course for the academic year of 2018-19 to VISHNU B.Ed., COLLEGE Bangarpet due to lots of demand from the students. Hence, we request your kind selves please permit Two units of 100 students.

AND WHEREAS, a copy of email dated 27.05.2019 was received from Advocate Shri Basavaraj V. Sabarad informing that the institution has filed a WP No. 21 184 of 2019.

AND WHEREAS, the matter was considered by the SRC in its 376th meeting held from 11th & 12th June 2019 and the Committee decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to issue Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the following grounds:-

- The institution is required to submit certified copy of land documents. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- 2. Land Use Certificate issued by the Competent Authority.
- 3. Non Encumbrance Certificate issued by the Competent Authority.
- 4. A copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- 5. Details of Teacher Education programme/other programme (if any) being run by the institution in the same campus

- 6. Building Completion Certificate as per prescribed Format.
- 7. Staff list duly approved by the affiliating body as per the prescribed Format.
- 8. Original FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years.

In view of above, the Committee decided that Show Cause Notice be issued to the institution as to why the recognition be not withdrawn on the above points. The Committee, therefore, provides last opportunity under Section 17 of the NCTE Act, 1993 to the institution to submit its reply within 21 days from the date of issue of notice, before the Committee takes the final decision. In case, the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act, Rules and Regulations.
