Show Cause Notice

WHEREAS, the recognition was granted to the institution, namely Bapu College of Education, Triveni Road, Yeshwanthpur, Bangalore-56022, Karnataka for conducting B.Ed. course of one year duration with an intake of 100 students vide order No. F.SRO/NCTE/B.Ed./2005-2006/4802 dated 21.12.2005.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in suppression of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education notified the Regulation, 2014 on 01.12.2014. The institution by a notarized affidavit dated 13.01.2015 consented to come under new Regulations and sought for two basic units (50 students each unit) of two years B.Ed. course which required additional facilities. In light of the above and in accordance with the NCTE Regulations, 2014, the Southern Regional Committee (NCTE) issued the revised recognition order dated 16.05.2015 to Bapu College of Education, Triveni Road, Yeshwanthpur, Bangalore-56022, Karnataka for conducting B.Ed. course of two years duration with an annual intake of 100 students [two basic unit(s) of 50 students each] from the academic session 2015-2016 subject to fulfilment of the above conditions.

AND WHEREAS, the institution vide letter dated 14.09.2015 requested for reduction from two basic units (100 students) to one basic unit (50 students). Accordingly, a corrigendum was issued on 30.10.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 50 students of one basic unit from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. As per decision taken by SRC in its 369th meeting held on dated. 28.01.2019, Show Cause Notice was issued to the institution on 12.02.2019.

AND WHEREAS, the institution vide letter dated. 18.03.2019 submitted its reply.

AND WHEREAS, the matter was considered by the SRC in its 376th meeting held from 11th & 12th June 2019 and the Committee decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to issue **Show Cause Notice u/s 17 of NCTE Act, 1993** before withdrawal of the recognition on the following grounds:-

1. Latest Staff list duly approved by the affiliating body as per the prescribed Format
2. Original FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years.
3. A copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
4. Building Completion Certificate as per prescribed Format issued by the Competent Authority.

In view of above, the Committee decided that Show Cause Notice be issued to the institution as to why the recognition be not withdrawn on the above points. The Committee, therefore, provides last opportunity under Section 17 of the NCTE Act, 1993 to the institution to submit its reply within 21 days from the date of issue of notice, before the Committee takes the final decision. In case, the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act, Rules and Regulations.
