WITHDRAWAL ORDER**

WHEREAS, Kattipally Ravinder Reddy Education Society, Nizamabad, Talangana submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Katipally Ravinder Reddy College of Education, 6-2-157/28, Subhash Nagar, Nizamabad-503002, Telangana for B.Edcourse of one year duration from the academic session 2004-05 with an annual intake of 100 students. The recognition was granted to the institution on 23.03.2005 with a condition that the institution shall shift to its own premises /building within three years for the date of recognition (in case the course is started in rented premises).

AND WHEREAS, the institution submitted its willingness affidavit on 02.02.2015 as per regulations 2014. Accordingly, revised recognition order was issued to the institution on 11.05.2015 for 2 units with a condition that the institution has not shifted to its own premises as stipulated in its formal recognition order dated 23.03.2005. The institution has not submitted reply till date.

AND WHEREAS, NCTE Hqrs has forwarded a written representation submitted by the institution regarding requesting for time was considered by SRC in its 292nd meeting held on 29th & 30th September, 2015 and the Committee decided as under:

1. Oct.15 is the last date commonly for all institutions to file documents. We cannot go beyond that exception for any particular institution.
2. Inform them accordingly and put up again in early Nov 15.

AND WHEREAS, as per decision of SRC, a letter was sent to the institution on 12.11.2015. The SRC in its 294th meeting held on 14th – 16th November, 2015 considered the list of colleges not submitted documents for shifting in compliance to the condition laid down in revised recognition order for 2015-2016 and it has decided to issue show cause notice for the following deficiency:

- The institution has not submitted documents for shifting as mentioned in the revised recognition order as per the regulation 2014.

AND WHEREAS, show cause notice was not sent to the institution. The SRC in its 328th meeting held on 31st January, 2017 considered the matter and decided as under:

1. This is a shifting case.
2. We had issued SCN for documents for shifting.
3. There is nothing on file to show whether the SCN was issued/served.
4. Issue SCN again.

AND WHEREAS, as per decision of SRC, show cause notice was issued to the institution on 09.02.2017. The institution submitted its written representation on 13.03.2017. The SRC in its

342nd meeting held on 05th& 06th July, 2017 considered the matter of reduction from 2 units to 1 unit is considered the decided to accept the request. Accordingly, as per decision of SRC, one unit order is sent on 21.07.2017. The SRC in its 343rd meeting held on 01st& 02nd August, 2017 considered the matter and decided as under;

1. They wanted time till June 17. It is already August 2017.
2. Put up in the next meeting on 17 August, 2017.

AND WHEREAS, as per the decision of SRC, again the matter was placed before SRC in its 344th meeting held on 17th and 18th August, 2017 and the Committee decided as under;

1. Their request for further time to submit documents is accepted as the last
2. opportunity available.
3. Give time till 30.09.2017.

AND WHEREAS, as per the decision of SRC a letter was sent to the institution on 24.08.2017. The institution not submitted any documents. Meanwhile, Directorate of Academic Audit, Telangana University, Nizamabad has submitted an annual inspection report of Katipally Ravinder Reddy College of Education, Nizamabad with regard to extension of provisional affiliation not recommended by inspection committee for 2018-19 on 23.07.2018. The details of the report is as under;

1. "Katipally Ravinder Reddy College of Education, Nizamabad was established in 2005, but still it is running in a leased building which is against NCTE norms. In 2017-18, college has given an undertaking on hundred rupees bond paper stating, "I will shift the college into our own building for the next academic year 2018-19, otherwise affiliation of this college to Telangana University will be automatically cancelled".
2. In 2016-17 because of the above reasons affiliation was not given and hence there were no admission in 2016-17.
3. College has shifted from Subashnagar, Nizamabad to Barkatpura, Nizamabad without permission from NCTE & TU.
4. Original latest Encumbrance Certificate of land particular in not shown.
5. Required number of Staff and Principal not been appointed as per NCTE and TU norms.
6. Library is not in working condition.
7. Journals are not subscribed.

AND WHEREAS, a Court order in I.A.No: 1 of 2018 in W.P.No. 26482 of 2018 filed by the institution in the hon'ble High Court of Hyderabad and the order stated as under:-

- "The case of the petitioner college is that college name was not included in the final phase of counseling for admission into B.Ed. course for the academic year 2018-2019, thought their name was found in the list of affiliated colleges for the academic year 2018-19.
- Learned Standing Counsel appearing for Telangana University submits that the petitioner college do not own building for running the institution; and the for the academic year 2017-18 also the petitioner college have given an undertaking that they will move into their own building for the next academic year ie., 2018-19. But, again this academic year also they have not shifted into their own building, as such, their names are not included and the affiliation was granted only in respect

of second year; and that they cannot violate their own undertaking given for the academic year 2017-18.

- Learned counsel for the petitioner submits that having granted affiliation they cannot refuse to include the petitioner college for final phase counseling.
- A perusal of the proceedings filed in WP.No. 26482 of 2018 goes to show that petitioner's college was granted affiliation. It is not indicated in the said proceedings that the affiliation is only in respect of second year. It is simply stated that "particulars of University and its affiliated colleges for the academic years 2018-19".
- However, learned counsel for the petitioner submits that by the next academic year they will move into their own building, failing which it is open for the respondents to cancel their affiliation.
- In view of the aforesaid facts and circumstances, since already affiliation proceedings are filed before this Court showing the names of petitioner college at serial No. and college code as 5284, there shall be interim direction as prayed for. However, petitioner's counsel states that they will not under any circumstances seek similar relief for the next academic year. The same is recorded."

AND WHEREAS, the SRC in its 363rd meeting held on 17th to 19th September, 2018 considered the matter and decided as under;

1. The Court has virtually granted permission to run the programme during 2018-19 even for the first year.
2. We have to proceed on that basis.
3. Right from the start they have been fooling us and the University. They deserve to be dealt with strictly.
4. This seems to pursue in particular are: (i) They have to submit all documents especially the latest EC.
(ii) They shall give the latest EC.
(iii) Their in-take strength has already been reduced from 2 units to 1 unit. They shall submit the latest approved Faculty List of 1 + 9. Recruitments made after 09.06.17 shall conform to the amendments made on that date.
(iv) They have shifted without permission. This is not acceptable. They shall shift to own premises during 2018-19 itself. Otherwise, recognition will have to be withdrawn and the 2nd year students may have to be adjusted in some other college. The admissions in 2018-19 will be subject to this understanding.
(v) Class-rooms, labs & MP Hall shall conform to the dimensions prescribed.
- 5.1 Collect fees and prepare to cause inspection.
- 5.2 We must examine all the documents and advise the VT clearly about the deficiencies festering.
6. Keep the University informed.
7. Keep our lawyer informed so that he can duly apprise the court of the correct facts if & when the need arises.
8. Issue Show Cause Notice accordingly. Collect all documents in one month. Process & put up in November 2018.

AND WHEREAS, as per the decision of SRC, show cause notice was issued to the institution on 10.10.2018. A letter was sent to Shri K. Ramakanth Reddy, Standing Counsel, High Court of

Andhra Pradesh on 10.10.2018. An e-mail dated 22.10.2018 was received from K.Ramakanth Reddy, Standing Counsel, High Court of Andhra Pradesh stated as under;

".... I am in receipt of your letter no. F.SRO/NCTE/AOSO2678/B.Ed/2017-18/98295 dated 10.10.2018, sent by post.

I have gone through the decision of SRC in respect of Katipally Ravinder Reddy College of Education, Subhash Nagar, Nizambad, Telangana. I am of the considered opinion that an appeal has to be filed in this case as the points shown by SRC have been suppressed by the petitioner.

Therefore, it is a must we should file an appeal."

AND WHEREAS, the SRC in its 365th meeting held on 31st October to 1st November, 2018 considered the matter and decided as under;

1. This is a RPRO case of B.Ed. (1 Unit) course.
- 1.1 We had examined the case in detail and listed the issues for attention in our 363rd meeting.
- 2.2 SRO should carefully pursue them.
3. Our Lawyer has advised appeal in this case. No particular advantage will flow from the appeal. We had not file an appeal.
- 4.1 Collect fees and can be inspection.
- 4.2 W.r.t. our summary minutes of the 363rd meeting, list out the points for careful attention by the V.P.
5. Put up in the 367th meeting.

AND WHEREAS, a letter was sent to the institution on 27.11.2018. The institution did not reply till date. In meantime, a copy of email dated 14.12.2018 received from Advocate K. Ramakanth Reddy with a draft Counter Affidavit to be filed before the Hon'ble High Court of Hyderabad in the W.P. No. 26482 of 2018 filed by the institution. The matter pertains to affiliation of college and their name was not included in final phase of counseling for admission into B.ED course for the academic year 2018-19. As per Telangana University petitioner college do not won buildings for order has been granted by the Hon'ble Court. Accordingly, matter has been considered in SRC 365th October to 1st November 2018 and decided to conduct inspection. The letter dated 27.11.2018 already sent to the petitioner TEI for inspection.

AND WHEREAS, the SRC in its 376th meeting held on 11th – 12th June, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-


The Committee perused the documents and decided to withdraw the recognition. The reasons are as follow: -

1. The College was permitted during 2004-05 with a condition to shift to new building constructed as per NCTE norms. The management has not complied with.
2. Though repeatedly asked to submit all the relevant documents including Building Plan. The management is taking shelter under some pretext or the other.
3. Even communication was sent to pay the fee for causing inspection. The management not responded.

In view of the above and non-responsiveness, the committee decided to withdraw the recognition.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Katipally Ravinder Reddy College of Education, 6-2-157/28, Subhash Nagar, Nizamabad-503002, Telangana** run by **Kattipally Ravinder Reddy Education Society, Nizamabad, Talangana** for conducting B.Ed programme of two years duration with an annual intake of 50 students (1 unit) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
