Whereas, the recognition was granted to the institution namely Vivekananda College of Physical Education for Women, Unjanai Village, Tiruchengodu Taluk, Namakkal District -637205, Tamilnadu vide SRC (NCTE) order no. F.TN/B.P.Ed./SRO/NCTE/2005-2006/3495 dt.18.10.2005 for conducting B.P.Ed. course of one year' duration with an annual intake of 50 students from the academic session 2005-2006.

And whereas, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

And whereas, after promulgation of NCTE Regulations, 2014, the duration of the B.P.Ed. course was increased from one year to two years and the existing institutions offering B.P.Ed. course, of one-year duration, were required to give their acceptance, in the form of an affidavit, for adherence of the NCTE Regulations, 2014.

And whereas, the institution had not submitted an affidavit as its acceptance for adherence to the provisions of the NCTE Regulations, 2014 and therefore, a revised provisional recognition order (RPRO), as per NCTE Regulations, 2014, was not issued to the institution

And whereas, the SRC in its 294th meeting held on 14th to 16th November, 2015 considered the matter of the institution for ascertaining the compliance by the institution and decided to issue a show cause notice to the institution for withdrawal of recognition.

And whereas, a show cause notice dt. 20.05.2016 was issued to the institution.

And whereas, the matter was placed before the SRC in its 364^{th} meeting held on $28^{th}-29^{th}$ September, 2018. The Committee considered the matter and decided as under:

- This is a case of B.P.Ed recognized under the old Regulations.
- This examination is for issue of FR under the 2014 Regulations.
- 3.1 We had issued a Show Cause Notice on 17.11.2016.
- 3.2 They have not cared to reply to our Show Cause Notice.
- 4.1 Issue Show Cause Notice again. Give time till 31.10.2018 for reply.
- 4.2 Failure to reply will lead to withdrawal of recognition.

And whereas, as per the decision of SRC, show cause notice was issued to the institution on 29.10.2018 (P-544/Coors.).

And whereas, the institution submitted a reply vide letter dt. 12.11.2018 along with an Affidavit dt. 30.05.2016.

And whereas, it is pertinent to mention here that the RPRO has not been issued to the institution till date.

And whereas, the SRC in its 375th meeting held on 13th & 14th May, 2019 considered the matter and decided as under: -

"The original files of the institution along with other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- 1. The institution was issued a show cause notice dt. 17.11.2016 on the ground that "Sy. Nos. in BP do not match with the Nos. in other documents. Now the institution submitted a copy of building plan with its reply dt. 15.11.2018. The Committee observed that the institution submitted building plan correcting the survey numbers but the stamp and signature of approving authority with the date fo 02.06.2002 is the same on the building plan submitted with the reply submitted by the institution vide letter dt. 02.06.2016, hence, the building plan seems to be manipulated.
- 2. The institution has not submitted the list of faculty duly approved by the affiliating body.
- 3. The institution itself vide letter/reply dt. 12.11.2018 accepted that the classes were not conducted for the B.P.Ed course due to lack of admission from the academic year 2010-2011.
- 4. The institution did not submit satisfactory reply on the issue of non-submission of affidavit regarding adherence of NCTE Regulations, 2014.
- 5. The institution has not submitted FDRs towards Endowment and Reserve Fund in original, in joint account as required under NCTE, Regulations, 2014.

The Committee decided to withdraw the recognition granted to Vivekananda College of Physical Education for Women, Unjanai Village, Tiruchengodu Taluk, Namakkal District, Tamilnadu-600017 for conducting B.P.Ed course.

Now, therefore, in view of the above, the recognition granted to the institution vide order no. F.TN/B.P.Ed./SRO/NCTE/2005-2006/3495 dt.18.10.2005 for conducting B.P.Ed. course become invalid as per directions & guidelines issued by the NCTE Hqrs vide letter no. 51-4/2014/NCTE/N&S/A101332 dated 27.12.2014 and decision of SRC thereof, file of the institution is closed.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
