WITHDRAWAL ORDER UNDER SECTION 17 OF NCTE ACT, 1993

Whereas, recognition was granted to the institution namely Gangaa College of Education, Mettukadu, Moolapadai, Koranampatti Post, Idappadi Taluk, Salem District - 637102, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/2006-2007/8992 dt.08.11.2006 for conducting B.Ed. course of one year' duration with an annual intake of 100 students.

And whereas, the SRC vide order no.F.No.APSO4888/B.Ed./TN/2011-12/32676 dt.28.11.2011 granted permission to shift the institution to its own building at Ganga College of Education, Moolpadai, Koranampatti Post, Konganapuram (via), Idappadi Taluk, Salem District, Pin - 637102, Tamilnadu.

And whereas, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 27.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

And whereas, provisional revised recognition order was issued to the institution on 23.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

And whereas, the institution submitted a compliance with relevant documents vide letter dt. 30.10.2015.

And whereas, the matter was placed before in 314th meeting of SRC held on 27th & 28th May, 2016 wherein a general decision was taken to cause inspection of such cases but inspection was not conducted.

And whereas, the matter was placed before in 374th meeting of SRC held on 09th - 10th April, 2019 and the decision of the Committee is reproduced below:

"The Committee decided to provide an opportunity before withdrawal of recognition, hence, a Show Cause Notice u/s 17 of NCTE Act for submission of a written representation with relevant supporting documents be issued on the following grounds:

- 1. FDRs towards Endowment and Reserve Fund of Rs.12 lakhs have not been submitted as required under NCTE Regulations, 2014.
- 2. Land Use Certificate has not been submitted.
- 3. The faculty, as required under NCTE Regulations. 2014, is not approved by the affiliating
- 4. BCC submitted is not in proper formal.
- 5. According to NEC, the nature of land is "Agricultural".
- 6. Certified copy of land documents issued by the competent authority along with notarized English translation have not been submitted."

And whereas, as per the decision of SRC, a show cause notice was issued to the institution on 15.04.2019.

And whereas, the institution submitted a reply vide letter dt.07.05.2019.

And whereas, the matter was considered by the SRC in its 376th meeting held on 11th - 12th June, 2019. The decision of SRC is reproduced below:

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

"The Committee decided to withdraw the recognition granted to Gangaa College of Education, Mettukadu, Moolapadai, Koranampatti Post, Idappadi Taluk, Salem District - 637102, Tamilnadu for conducting B.Ed. course on the following grounds:

- 1. Faculty list submitted is not approved by the affiliating university.
- 2. Insufficient FDRs, also not in joint account.
- 3. LUC is not submitted
- 4. Built Up Area is not adequate
- 5. BCC is not in prescribed format 6. Land is Agricultural Land, also in the name of individual."

Now therefore, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Gangaa College of Education, Mettukadu, Moolapadai, Koranampatti Post, Idappadi Taluk, Salem District – 637102, Tamilnadu was granted recognition vide SRC, NCTE's vide order no. F.SRO/NCTE/2006-2007/8992 dt.08.11.2006 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, within 60 days from the date of issue of this Order. The guidelines for filling appeal may be seen on NCTE's website.
