WHEREAS, recognition was granted to the institution namely Mitra College of Education for Women, Near Mitra Maternity Nursing Home, Besides K.R. Stadium, Srikakulam - 532001, Andhra Pradesh run by Mitra Educational and Welfare Society, Srikakulam District-532001, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/2007-2008/14080 dt. 02.11.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt Nil for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 28.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC issued a Corrigendum vide order No. F.SRO/NCTE/APSO7484/B.Ed/AP/2015/75184 dated 07.10.2015 permitting the institution to have one basis unit of 50 students subject to the institution fulfilling following conditions namely: -

(i) The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.

AND WHEREAS, the SRC vide order No. F.SRO/APSO7484/B.Ed/AP/2016-17/87551 dated 01.08.2016 permitted the request for change to Co-education (B.Ed. one unit).

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 06.03.2019. The institution vide letter dated 03.04.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 376th meeting held on 11th – 12th June, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to <u>withdraw the recognition</u> granted to Mitra College of Education for Women, Near Mitra Metarnity Nursing Home, Besides K.R.Stadium, Srikakulam -532001, Andhra Pradesh for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the following grounds: -

- 1. Latest faculty list duly approved by the competent authority not submitted
- 2. Building Plan is not duly approved by the competent authority.
- 3. BCC is not issued by the competent authority. It is an unauthorized and illegal construction.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Mitra College of Education for Women, Near Mitra Maternity Nursing Home, Besides K.R. Stadium, Srikakulam - 532001, Andhra Pradesh run by Mitra Educational and Welfare Society, Srikakulam District-532001, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 50 students (1 unit) which were finally allowed to the Institution vide Corrigendum order No. F.SRO/NCTE/APSO7484/B.Ed/AP/2015/75184 dated 07.10.2015 on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
