## FINAL SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted to the institution namely Educare College of Education, Jangaon Revenue Division, Sree Ram Nagar, Opp. AP Dairy Farm, Jangaon Warangal District, Andhra Pradesh run by Vignana Bharati Educational Society, H.No. 6-2-44/7/1, Kankar Road, Mahabubnagar – 506101, Warangal District, Telangana vide SRC (NCTE) order no. F.AP/NEW/B.Ed/146/SRO/NCTE/2002-2003/6659 dt.04.04.2003 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

- **2**. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 24.01.2015 for its willingness for adherence of provisions of new Regulations.
- 3. AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- **4. AND WHEREAS,** on the basis of request, the SRC in its 342<sup>nd</sup> meeting decided for reduction of intake from 2 units to 1 unit. Accordingly a order dated 21.7.2017 was issued.
- **5. AND WHEREAS**, The FDRs in original were returned to the institution vide letter dt. 07.07.2015. The SRC in its 369<sup>th</sup>meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 28.02.2019. The institution did not submitted reply to the show cause notice till date.
- **6. AND WHEREAS**, the SRC in its 377<sup>th</sup> meeting held on 03<sup>rd</sup> 04<sup>th</sup> July, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution has not submitted a copy of approved building plan. The
institution is required to submit a attested/notarised copy of the approved
Building Plan (if institution is running more than one Teacher Education
programme, it shall be required to submit an exclusive earmarked building plan
for each of the recognised Teacher Education programme)

2. The institution has not submitted a copy of Building Completion Certificate. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.

3. The institution has not submitted Staff list as per the prescribed Format duly approved by Registrar of the affiliating body. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the
