WHEREAS, recognition was granted to the institution namely Sri Karibandi Subbarao Memorial College of Education, Kovvur Revenue Division Tadipudi, West Godavari District-534341, Andhra Pradesh run by Grameena Educational & Social Society, D. No. 1-1, Tadipudi Tallapudi, West Godavari-534341, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/206/SRO/NCTE/2002-2003/6151 dt. 03.03.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 23.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 11.03.2019. The institution vide letter dated nil received dated 25.03.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 377th meeting held on 03rd – 04th July, 2019 considered the matter and decided as under;

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

(i) The institution failed to submit requisite documents as per SCN dated 11.3.2019.

The Committee decided to withdraw the recognition granted to Sri Karibandi Subbarao Memorial College of Education, Kovvur Revenue Division, Tadipudi, West Godavari District – 534341, Andhra Pradesh for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sri Karibandi Subbarao Memorial College of Education, Kovvur Revenue Division Tadipudi, West Godavari
