# F.SRO/NCTE/APSO0421-B.Ed.-AI/APSO4145-M.Ed./KL/2019-20/107389-Date: -2 4 JUL 2019 Final Show Cause Notice u/s 17 of the NCTE, 1993

Whereas, the institution namely Fathima Memorial Training College, Pallimukku, Vadakkevila Post, Kollam-691010, Kerala was granted recognition for conducting B.Ed. course of one-year duration with an annual intake of 100 students vide SRC, NCTE order dt. 29.05.2009.

And Whereas, the institution was also granted recognition to conduct M.Ed. course of one year's duration with an annual intake of 25 vide SRC, NCTE order dt. 15.10.2009.

And Whereas, the NCTE, New Delhi has informed all such existing teacher training institutions conducting B.Ed., B.P.Ed. and M.Ed. courses to submit an affidavit as an acceptance of provisions of NCTE Regulations, 2014 for getting a revised recognition order as per NCTE Regulations, 2014.

And Whereas, the institution submitted affidavits for the purpose of issuance of revised recognition order under NCTE Regulations, 2014.

And Whereas, the provisional revised recognition order dt. 13.05.2015 was issued to the institution for conducting B.Ed. course of two years duration with an annual intake of 100 students (2 units) w.e.f. the academic session 2015-2016 subject to submission of conditions mentioned therein. Further, the provisional revised recognition order dt. 31.03.2015 was issued to the institution for conducting M.Ed. course of two years duration with an annual intake of 50 students (1 unit) w.e.f. the academic session 2015-2016 subject to submission of conditions mentioned therein: -

- i. The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30th June, 2015 failing which the recognition will be withdrawn.
- ii. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, and 2014 and inform Regional Committees with required documents by October 31, 2015.
- iii. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting Team at the time of inspection.
- iv. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

And Whereas, the institution submitted certain documents in compliance of conditions of RPROs dt. 26.02.2016.

And Whereas, the Hon'ble High Court of Kerala, Ernakulam in W.P.C. No. 3022/2019 passed an order dt. 09.04.2019 and the order is reproduced below: -

"The learned Standing Council for the 2<sup>nd</sup> respondent submits that the petitioner has not produced all the details requested. At the same time, the learned counsel for the petitioner submits that no communication is rec eived from the 2<sup>nd</sup> respondent requesting for any details and they are ready to furnish any details called for.

Therefore, the 2<sup>nd</sup> respondent to communicate the petitioner with respect to the details which are required to be furnished within a period of two weeks."

And Whereas, the matter was placed before the SRC in its 375<sup>th</sup> meeting held on 13<sup>th</sup> & 14<sup>th</sup> May, 2019 in light of directions passed by the Hon'ble Court in order dt. 11.04.2019 in W.P. No. 3022/2019 and the SRC decided the following: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

In obedience to the Hon'ble High Court of Kerala, the Committee decided to direct the Management of Fathima Memorial Training College, Pallimukku, Kollam District – 691010, Kerala to submit the following information/documents: -

- a) Details of different teacher education programme along with sanctioned strength.
- b) Whether the affiliating University/Govt. of Kerala allotting the students to the institution, if there is a gap since when."

The institution is required to submit the following documents in original.

- 1) Certified copy of land documents. (If the same are in Regional Language the institution is also required to submit notarized copy of English version of land documents).
- 2) Land Use Certificate issued by the Competent Authority.
- 3) Latest Non Encumbrance Certificate issued by the Competent Authority.
- 4) Approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognized Teacher Education programme).
- 5) Building Completion Certificate as per prescribed Format.
- 6) Staff list duly approved by the affiliating body as per the prescribed Format.
- 7) Original FDR of Rs.7 lakhs and 5 lakhs, totaling Rs.12 lakhs towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years.

The Management be informed to present personally before the Committee with all the above documents."

And Whereas, the matter was placed before SRC in its 376th meeting held on 11th & 12th June, 2019 wherein the following decision was taken: -

"The Committee perused the request made by the office of the Regional Director, SRC, NCTE to reconsider the decision taken by the SRC in its 375th meeting for the agenda items 1 to 10. The Committee after thorough discussion resolve to confirm the decision taken in the 375th meeting and issue orders accordingly to all the 10 institutions and present the Action Taken in the next meeting.

And Whereas, the Regional Director being the Convener of the SRC and also as per clause 7.12 of the NCTE Regulations, 2014 which stipulates that "The Regional Director, who is the convener of the Regional Committee, while putting up the proposals to the Regional Committee shall ensure that the correct position in the Act, rules or regulations including norms and standards for various teacher education programmes are brought to the notice of the Regional Committee so as to enable the Committee to take appropriate decisions."

And Whereas, the matter was again placed before SRC in its 377<sup>th</sup> meeting held on 03<sup>rd</sup> & 04<sup>th</sup> July 2019 wherein the following decision was taken: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

- The institution has not submitted a certified copy of land documents. The institution is required
  to submit certified copy of land documents issued by concerned Tehsildar/Revenue Officer. (If
  the same are in Regional Language the institution is also required to submit notarized copy of
  English version of land documents).
- 2. The institution has not submitted a copy of Land Use Certificate. The institution is required to submit an attested/notarized copy of Land Use Certificate issued by the Competent Authority.
- 3. The institution has not submitted a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarized copy of Non Encumbrance Certificate issued by the Competent Authority.
- 4. The institution has not submitted a copy of approved building plan. The institution is required to submit an attested/notarized copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognized Teacher Education programme).
- 5. A attested/notarized copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location along with land area and built up area.
- 6. The institution has not submitted a copy of Building Completion Certificate. The Institution is required to submit an attested/notarized copy of Building Completion Certificate issued by the competent authority.
- 7. The institution has not submitted Staff list as per the prescribed Format duly approved by Registrar of the affiliating body. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case

the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognized teacher education programme being run by the Institution).

8. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakhs and 5 lakhs, totaling Rs.12 lakhs towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

Now therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

You are also directed that if any document is in regional language, the Notarized English translation be also submitted.

In case, the office does not receive any representation within the stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act and Regulations.
