Final Show cause notice u/s 17 of the NCTE, 1993

WHEREAS, recognition was granted to the institution namely Sivagamiammal College of Education, Kattinayanapalli Village, Krishnagiri District-635001, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/18427/18427 dt.28.02.2008 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, a provisional revised recognition order dt. 01.05.2015 was issued to the institution for conducting B.Ed. course of two years' duration with an annual intake of 100 (two basic units) from the academic session 2015-16 subject to the following conditions :-

- (i) The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30th June, 2015 failing which the recognition will be withdrawn.
- (ii) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (iii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- (iv) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

AND WHEREAS, the matter was placed before the SRC in 314th meeting of SRC held on 27th & 28th May, 2016 wherein a general decision was taken to cause inspection of such cases. However, inspection of the institution was not conducted.

AND WHEREAS, the matter was placed before the SRC in its 375th meeting held on 13rd - 14th May, 2019. The Committee considered the matter and decided to issue Show Cause Notice on certain grounds.

AND WHEREAS, the institution has submitted reply in response to the Show Cause Notice issued on 28.05.2019.

AND WHEREAS, the reply letter dt. 18.06.2019 of the institution along with regulatory file was placed before the SRC in its 377th meeting held on 03rd - 04th July, 2019 and the Committee decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- (i) Certified copy of the land documents not submitted.
- (ii) Details of teacher education programme / other programme (if any) being run by the institution in the same premises.
- (iii) Building Completion Certificate duly approved by the Competent Authority.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice."

NOW THEREFORE, in compliance of the decision of the SRC this final show cause notice is issued u/s 17 (1) of NCTE Act, 1993 with the direction to submit your written representation within a period of 21 days from the date of issue of this notice, complying the decision of the SRC, failing which action u/s 17(1) will be taken as per NCTE Act & Regulations 2014.

You are also directed that if any document is in regional language, the Notarized English translation be also submitted.

In case, the office does not receive any representation within the stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act and Regulations.
