AND WHEREAS, the institution, PT DEVPRABHAKAR SHASTRI B.ED. COLLEGE, KHASARA NO. - 878 TO 883, 886/1 TO 886/3, 887, PLOT NO. - 52, N.H. - 75, VILLAGE - GATHEORA, P.O. + TEHSIL + DIST. - CHHATARPUR - 471001, MADHYA PRADESH (WRCAPP2395/223) has by affidavit consented to come under New Regulations.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and video graphy, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme, such as instructional facilities, infrastructural-facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to PT DEVPRABHAKAR SHASTRI B.ED. COLLEGE, KHASARA NO. - 878 TO 883, 886/1 TO 886/3, 887, PLOT NO. - 52, N.H. - 75, VILLAGE - GATHEORA, P.O. + TEHSIL + DIST. - CHHATARPUR - 471001, MADHYA PRADESH for conducting B.ED. programme of 2 (Two) years duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2016-17.

AND WHEREAS, it has been decided to permit the institution to have **one basic unit of 50 students** subject to the institution fulfilling following condition namely:

(ii) The institution shall ensure that it becomes a composite institution gradually, Preferably by 2016-17.

The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with statement of annual accounts duly audited by a Chartered Accountant.

- d) Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
