Smt. Mala Shrivastava, Chairperson, WRC, Shri Chandrashekhar Vazalwar, Shri Anil Bedge, Prof. Freny Tarapore, Members, expressed their inability to attend the meeting. The Representatives of States/UTs of Chhattisgarh, Daman & Diu and Dadra & Nagar Haveli could not attend the meeting.

**238.2 Action Taken Report on the minutes of the 237<sup>th</sup> Meeting of WRC.**


Regional Director informed that required action is being taken on the minutes of the 237<sup>th</sup> meeting. Action taken report will be submitted in the next meeting.

**238.3 Policy Decisions/letters received from NCTE Hqrs./State Govt.**

The Regional director presented before the WRC Letter No. B.Ed.- 4615/C.R.203/Mashi-2 dated 29.12.2015 from the Govt. of Maharashtra. According to the letter, the State Govt. had intimated to NCTE vide its letter dated 20.03.2015 for not granting recognition to B.Ed./M.Ed. courses in the State for the year 2016-17 with exception to minority institutions. This letter was with reference to the public notice issued by the NCTE on 27.02.2015.

The Committee decided that Regional Director will write the letter to the NCTE Hqrs. to find out if any action has been taken on the letter dated 20.03.2015 addressed to the NCTE.

The State Govt., in its letter dated 29.12.2015, has decided to scrutinize the proposals of composite institutions and send the recommendation within 45 days. The Committee considered the matter and decided that the cases should be processed if mandatory period of 90 days for receiving the State Govt. recommendation is over.

Ft.</p> <p>The institute was directed to explain as to why the institution has not setup separate Art &amp; Craft room, Science &amp; Maths Lab, ET Lab. The institute was also directed to explain the reason of less size of the multipurpose hall. The institute in its reply has submitted that the institute has facility as required under the norms. It has submitted the copy of the building plan which is the plan for another location where the institute intends to shift. Thus, at the time of inspection,</p>

The background of the case is as follows:-</p> <p>The society applied for B.Ed. course in the year 2003. At that time NCTE Regulations 2002 was in force. According to the Regulations, a Society was eligible to start Teacher Education Course in a rental premise if it has land on its own name.</p> <p>At the time of its application, the Society had not the land in its name. The Society purchased the land measuring 0.418 Acre in the year 2004. The building was on rental basis and it was on lease from Ram Sevak Singh.</p> <p>As per Regulations 2002, the institute was allowed to run in rental building if the Society has land in its own name. As per the Regulations the society will build its own building within 3 years and shift institute from the rental building.</p> <p>On perusal of the records submitted by the institute alongwith its reply dated 21.05.2015 it has been found that the Society has acquired land in the same village with survey no. 353, 377, 351, 355 on 30 years private lease. The registered documents includes the building on survey no. 353, that was taken on rental basis in the year 2003.</p>

The Society has land in its own name that was purchased in the year 2004 and it did not build its own building in the land and continued to run the institution in rental premises. Whereas, as per Regulations 2002, the Society was to construct the building and shift to its premises between 3 years of the grant of Recognition. As is clear from the above facts, the Society is running the institute in violation of the NCTE Regulations.</p> <p>The institute was also asked to introduce the benefit of CPF for the staff. In reply, the institute has submitted that the CPF amount is being deducted from the salary of the staff but it has not submitted any proof in this regard.</p> <p><b>Hence, Show Cause Notice u/s 17 be issued on the above grounds.</b></p>
