AGENDA ITEM 241 – WITH THE PERMISSION OF CHAIRPERSON, WRC (NCTE) BHOPAL

Consideration of present status of applications received for grant of Recognition for the session 2016-2017

NCTE, vide Public Notice dated 27.02.2015 invited applications from the applicant teacher training institutions for the academic session 2016-17. The last date for submission of applications online was 31st May, 2015 which was extended upto 30th June, 2015.

M. N. S. Kano

In response to the Public Notice, 1069 institutions submitted the applications online, out of which hardcopy of applications were received in 909 cases. Out of this, approx. 170 applications have been rejected. Thus, approx. 739 applications are under process.

Out of 739 applications under process there are approx. 350 no. of applications, in which SCN is to be issued on grounds like Private lease deed, Land is not diverted for educational purpose, Instt. is not a composite instt., Land area/builtup area is less as required under Regulations, 2014, NOC of affiliating body is not submitted, etc.

In view of paucity of time for disposal of pending applications by 03rd March 2016 and to speed up the process, the matter is brought to the notice of WRC in its 241st meeting being held on 04th - 06th Feb 2016.

The Committee may decide giving directions to the RD, WRO (NCTE) to issue SCN in cases which have shortcomings as per Norms & Stds. and Regulations, 2014.

Therefore, the matter is placed before WRC for consideration and directions in the matter.

DECISION OF WRC :-

The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC.




