**Matters related to applications received from banned districts and/or without NOC :-**

The SLP No. 5102/2016 (Ambition College of Education Society), SLP No. 7461/2016 (Shaheed Ashfaq-Ullah Society, Gwalior) and SLP No. 9010/2016 (Tripathi Gurudev Vidyanand Saraswati Shiksha Utthan Samiti) were heard by the Hon'ble Supreme Court on 26<sup>th</sup> April, 2016. The Apex Court disposed the SLP No. 9010/2016 and tagged the SLP No. 5102/2016 (Ambition College of Education Society) and SLP No. 7461/2016 (Shaheed Ashfaq-Ullah Society, Gwalior) with SLP No. 5282-5289/2015 (LBS B.Ed. College) to be heard later on to decide the question of law.

The Committee decided that the cases cannot be considered at this stage in cases wherein the institutions have submitted reply to letter of intent and are from the banned districts in M.P. for D.El.Ed. course and/or are without NOC of the affiliating body. The cases can be considered only for the next academic session 2017-2018 after the judgement of the Apex Court. The recognition cannot be given in other application as well, if applied together to fulfil clause 2(b) of the NCTE Regulations, 2014 regarding the composite nature of the institution. Such institutions may be informed accordingly.



**Matters related to governance :-**

a) In order to expedite processing of applications received from the applicant TTIs for the academic session 2016-2017, the WRC in its 241<sup>st</sup> meeting had authorized the RD, WRC to issue SCN/Constitute VT, as the case may be.



Henceforth all cases may be placed before the WRC for consideration and decision and no SCN/VT shall be constituted by the RD, WRC.


