**258.1 Confirmation of the minutes of 257<sup>th</sup> Meeting of WRC**


The minutes of 257<sup>th</sup> meeting were confirmed by the Committee.

Hence, this answer is not satisfactory.</p> <p>iv) <b>Other Benefits for Staff – like CPF:</b> It has been informed that no such benefits are being given. The applicant has not informed as to why the benefits due to the staff under Section 10(2) and (3) are not being provided to the academic and non-academic staff. This explanation is not satisfactory.</p> <p>v) <b>Obtaining of NAAC:</b> It has been informed that process for obtaining has been initiated. It is noteworthy that as regards obtaining NAAC, the reply of the applicant given in August, 2016 is the same as the reply given in September, 2015. However, it is seen from the record that the fee for obtaining NAAC Accreditation has been deposited. Since, the institution has not complied with the important conditions for building, <del>Pay Scale</del>, and other benefits, in spite of Show Cause Notice, <b>Recognition is withdrawn.</b></p>
