

Part of the building is incomplete without roof.</p> <p>The second CD submitted by the latest VT conducted on 5th & 6th of Feb, 2017 shows a totally different single storey building. In this second building also the rooms are small and not as per the NCTE norms. The multipurpose hall is only 987 sq. ft. The VT has mentioned that the RCC roof is dangerously damaged, hence insecure for the students and the staff. The partition between the rooms is made up of plywood. The management refused to show the original documents. The VT has mentioned that the Labs and the ICT Lab do not have sufficient materials. There are only 2214 books in the Library.</p> <p>The VT has quoted "...the management has two locations one at Irijangaon (Gut No. 72) where a semi English medium school is working and the second is in the first floor of a rental building from Basmat Municipality. Inadequate and damaged instructional facilities are found by the VT members. Management was not ready to provide the original documents for the verification. Only Xerox copies were given for verification. They also did not handover the copies of the documents to attach with the report... When the VT members objected, management members guided us to an old building at Basmat far away from the previous location. The management claimed that D.El.Ed. programme is running there. But no such evidences are found..."</p>

				<p>Further, a perusal of the file shows a Building Plan for a four storied building and there is also a Building Completion Certificate for a four storeyed building measuring 3268.55 sq. ft. the Building Plan does not tally at all with the two buildings which were shown to the VT.</p> <p>It seems obvious that the management tried to mislead the VT, first by showing 2 buildings and secondly, by not providing documents.</p> <p>Hence, Show Cause Notice be issued as to why the recognition should not be refused on the above grounds.</p> <p>Reply should be submitted within 30 days.</p>
