In the 249th meeting held on 21-23 April, 2016, the WRC had decided to grant Recognition for 1 unit of the B.Ed. course as the total built up area was only 33411 sq. ft.</p> <p>The institution vide letter dt. 18/05/2016 requested for 2 units, saying for the first time, that they are having 2 phases - one for 33411 sq. ft. and the other 12102 sq. ft. However, the Management had not taken the VT to the phase-2 of the building. Even the CD submitted does not anywhere show the phase-2 of the building. Therefore, 'Phase-2' is only a statement by the Management which has not been verified by the VT and not substantiated by the CD.</p> <p>Therefore, it is necessary to reconstitute a VT to verify the claims regarding Phase-2. This lack of verification of infrastructure makes the committee hesitant to issue 2 units. The Committee has no evidence to show that the building at phase-2 is compliant to NCTE Regulations, Appendix-4 as far as instructional and infrastructural facilities are concerned.</p> <p>The institution is informed to send all the evidences it has regarding Phase-2 (documents, videos etc.). This has reference to the institution's letter dt. 11/04/2017. So, that a decision can be arrived at.</p> <p>Hence, Clarification be obtained on the above grounds. Further any additional infrastructure needs physical verification for which the institution needs to submit a fee of Rs.1.50 lakhs. It was the responsibility of the institution to show all the required infrastructure to the visiting team for verification.</p>


