

**MINUTES OF THE 281<sup>st</sup> MEETING**

**OF**

The 281<sup>st</sup> meeting of WRC was held on September 19<sup>th</sup> – 20<sup>th</sup>, 2017.

Since Prof. Chandrashekhar Vazalwar, Chairperson, WRC, NCTE has expressed his inability to attend this meeting, the members of the committee unanimously decided to conduct the meeting under Chairmanship of Dr. Louis Vernal.

Shri L.S. Baghel, Prof. Freny Tarapore and the State Representatives of Gujarat expressed their inability to attend the meeting. The Representatives of Chhattisgarh, Daman & Diu and Dadra & Nagar Haveli did not give any information about their presence.

At the outset, Shri Awadhesh Nayak, Regional Director and Convener, welcomed the Chairperson and all the members of WRC, NCTE to the 281<sup>st</sup> meeting of the WRC.

The Regional Director, being Convener of the WRC, presented each agenda item for consideration of the WRC.

**Agenda 281.1: Confirmation of the minutes of 280<sup>th</sup> Meeting of WRC.**

The Action Taken Reports were noted.

**Agenda 280.3: Policy decisions/letters received from NCTE Hqrs.**

**1. The NCTE Hqrs. vide letter no. NCTE-Ins/3/2017-Insp Section-HQ-Part(1) dt. 20.09.2017 has issued clarification. WRC noted the content of the letter.**



**Sub: Initiation of the process of de-recognition of institutions for non compliance of filing the Mandatory Affidavit – reg.**

In order to systemetise the compilation of complete information of all TEPs in the country, the NCTE HQrs New Delhi had asked all institutions to submit the Mandatory Affidavit on the prescribed format. The first such Public Notice was issued on 05.10.2016. Further opportunity was given on 16.06.2017, and the last date for submission was 12.09.2017.

NCTE Delhi also issued Show Cause Notice through PUBLIC NOTICE to submit the Mandatory Affidavit within the specified date. Then, it compiled the list of institutions and identified TEIs which had not complied with the submission of Mandatory Affidavit. The lists were sent to the WRO to reconcile the discrepancies with regard to the address as well as duplication of entries for placing the list to WRC for initiating the process of de-recognition of such institutions. These lists were tabled during the meeting.

The WRC perused the lists as provided by the HQrs as well as the details provided by the WRO.

Thereafter, the WRC decided to issue Show Cause Notice u/s 17 of the NCTE Act for non-compliance of the directions of the NCTE, and why the institution should not be de-recognized. The reply should be sent on or before 23<sup>rd</sup> October 2017 after which further necessary action will be taken as per the Regulations.




