				complete the process. No proof submitted. Show Cause Notice be issued on the points where the reply is not satisfactory.

Any Other Item

The WRC reviewed the status of applications received for the session 2016-2017 and pendency.

The WRC requested the RD to request the State Govt. of M.P. and other states to provide their recommendations on the applications for the session 2017-2018, expeditiously.

The RD informed the WRC that he had taken up the matter with the State Governments of Gujarat, Maharashtra, Daman & Diu for ensuring the presence of their representatives for attending the meetings of WRC.
