PUBLIC NOTICE

The National Council for Teacher Education has been established under an Act of Parliament on 1st July 1995 with a view to achieve planned and coordinated development of teacher education and matters connected therewith, throughout the country. NCTE has 4 Regional Committees - Eastern, Western, Northern and Southern which are constituted by the Council of NCTE. Under the provisions of National Council for Teacher Education (number of persons to be nominated to the Regional Committee, their term of office and allowance payable) Regulations, 1995 dated 22.01.1996 and amended NCTE Regulations, 2011 dated 07.02.2011, 6 persons having special knowledge and experience in matters relating to teacher education shall be nominated as members of the Regional Committees for a period of 2 years from the date of their nomination or till fresh appointment are made, whichever is later. The qualifications and experience given in clause 2 (2) of NCTE Regulation 2011 dated 07.02.2011, is as follows:-

- a. Former Vice-Chancellors, Pro-Vice Chancellors, Deans of the Faculties of Education of Universities of Central/State Govt.
- b. Professors and Head of the Departments of Education in the Universities under the Central Government or the State Government.
- c. Principals of Government Post Graduate Colleges.
- d. Senior Teacher Educators, preferably of Government institutions with a minimum of 15 years experience of teaching and research in education.
- e. Former Commissioners of Education/Former Directors of State Council of Educational Research and Training (SCERT).
- f. Persons who have held a position not below the rank of Joint Secretary to the Government of India or Secretary in a State Government, dealing with education and related matters.
- g. Former Head of national level institutions in the field of education/teacher education.
- 2. NCTE invites applications from persons, falling in the categories listed at Nos. (a) to (g) above, in the prescribed proforma, willing to be a member of the Regional Committee. The requisite resume duly filled in, and documents in support of qualification and experience may be submitted through online mode only at www.i/ncte.gov.in/index.html for consideration by the Selection Committee, within 30 days of the issue of this Public Notice on NCTE website.
- 3. Persons employed in any Government/Semi-Govt/Autonomous Body/Statutory Body/PSU should forward their application for nomination through proper channel only. The same should be received in NCTE on/before the last date specified above.
