ORDER

WHEREAS the appeal of Thakur Jay Narayan Singh Memorial Degree College, Khaga Fatehpur, Uttar Pradesh dated 30/10/2015 is against the Order No. NRC/NCTE/NRCAPP-4139/240th Meeting/2015/121337 dated 18/08/2015 of the Northern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "the institution has not submitted reply of SCN."

AND WHEREAS Sh. Sanjay Kumar Upadhyay, Trustee and Sh. Kulbas Narai Srivastava, Principal, Thakur Jay Narayan Singh Memorial Degree College, Khaga Fatehpur, Uttar Pradesh presented the case of the appellant institution on 12/01/2016. In the appeal and during personal presentation it was submitted that "the reply of notice was not given by the institution because said "Show Cause Notice" (04/06/2015) sent to the institution by the NRC-NCTE was not received. The FDR annexed in 7(13) letter given to institution was namely wrong because there was printed another named institution which was due to carelessness of NRC-NCTE. The original FDR of institution is not yet received by institution. That is the list of faculty members was not submitted."

AND WHEREAS Appeal Committee noted that Letter of Intent (L.O.I.) was issued to the appellant institution on 26.02.2015 and the appellant institution thereafter addressed a letter dated 30.05.2015 to N.R.C. requesting for grant of formal recognition under clause 7(16) of the NCTE Regulations, 2014. N.R.C., Jaipur considering that the appellant institution has not furnished the list of faculty approved by competent affiliating University as was required under the terms and conditions laid down in the L.O.I., issued a show cause notice (S.C.N) on 04.06.2015. The appellant during the course of hearing on 12.01.2015 stated that S.C.N. was not received by the appellant institution. On being asked as to why the appellant institution could not fulfil the terms & conditions laid down in the L.O.I. regarding appointment of faculty, no satisfactory reply was given by the appellant. Appeal Committee, therefore, decided to confirm the refusal order dated 18.08.2015.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded to confirm the refusal order dated 18/08/2015 issued by N.R.C. N.R.C. should however, locate the F.D.R. pertaining to appellant institution and return it after getting back the other F.D.R. which has mistakenly been sent alongwith refusal order.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed agains

ORDER

WHEREAS the appeal of Tamil Nadu Physical Education and Sports University, Chennai, Tamil Nadu dated 30/10/2015 is against the Order No. SRO/NCTE/SRCAPP2246/B.P.Ed/TN/2016-17/75575 dated 09/10/2015 of the Southern Regional Committee, refusing recognition for conducting B.P.Ed. course on the grounds that "the University has not submitted hard copy of application within 15 days of online submission."

AND WHEREAS Dr. P. Samraj, Registrar, Tamil Nadu Physical Education and Sports University, Chennai, Tamil Nadu presented the case of the appellant institution on 12/01/2016. In the appeal and during personal presentation it was submitted that "the Tamil Nadu Physical Education and Sports University submitted online application for the recognition of B.P.Ed. (Two Years) course for the 2016-17 session on 30/04/2015. Since the instructions of online filling of applications were not very clear for submission of hard copy, the inadvertent mistake in submission of hard copy within 15 days occurred. The time of 15 days was inadvertently miscalculated resulting late submission of hard copy. But that is before the closure date of online submission."

AND WHEREAS Appeal Committee noted that appellant institution submitted online application for B.P.Ed. course on 30.04.2015 and hard copy was received in the office of S.R.C. on 18/05/2015. Appeal Committee further noted that NCTE (HQs) had issued necessary guidelines to all Regional Committee offices that 15th July, 2015 will be the last date for submission of hard copy of application with N.O.C. irrespective of the date of online application.

AND WHEREAS Committee therefore, decided to remand back the case to S.R.C. for consideration and processing of the application of the appellant institution which was received in the office of S.R.C. on 18.05.2015.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Committee concluded to remand back the case to S.R.C. for further processing of the application.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to SRC for consideration and processing of the application of the appellant institution which was received in the office of S.R.C. on 18.05.2015.

NOW THEREFORE, the Council hereby remands back the case of Tamil Nadu Physical Education and Sports University, Chennai, Tamil Nadu to the SRC NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Mulayam Singh Mahavidyalaya, Kanpur, Kanpur Nagar, Uttar Pradesh dated 31/10/2015 is against the Order No. NRC/NCTE/NRCAPP-9029/242nd Meeting/2015/123245 dated 10/09/2015 of the Northern Regional Committee, refusing recognition for conducting D.El.Ed. course on the ground that "the institution has not submitted reply of Show Cause Notice issued on 13.07.2015."

AND WHEREAS Shri Vishant Rawat, representative of Mulayam Singh Mahavidyalaya, Kanpur, Kanpur Nagar, Uttar Pradesh presented the case of the appellant institution on 12/01/2016. In the appeal and during personal presentation it was submitted that "the institution requested to the visiting Team that building is not complete according to norms and the delay in completion of the building is due to Labour Problem. The reply of Show Cause Notice was sent on 13/08/2015. The receipt of speed post is attached herewith. Actually we have received the Show Cause Notice on 28/07/2015 due to confusion we thought that we stipulated 30 days' time is from the date 28/07/2015 but it was from the date of issue so kindly consider my appeal sympathetically and continue the recognition process of my application for D.El.Ed. Course. The reply of show cause notice and affidavit is attached."

AND WHEREAS Appeal Committee noted that appellant institution applied for grant of recognition of D.El.Ed. course on 31.12.2012. After processing of application, N.R.C., Jaipur decided to conduct an inspection of the institution for which intimation was given to the appellant institution on 10.05.2015. The Visiting Team Members informed N.R.C. on 19.06.2015 that the appellant institution has refused for inspection because building is incomplete. Show Cause Notice (S.C.N.) dated 13/07/2015 was issued to the appellant institution to submit written representation for refusing to get the institution inspected. The appellant did not submit any reply to the S.C.N. Appeal Committee considering that application for recognition was made in December, 2012 and the appellant institution was not ready with the built up area till June, 2015 and also did not submit reply to S.C.N. dated 13/07/2015, decided to confirm the refusal order dated 10.09.2015.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Committee concluded to confirm the refusal order dated 10.09.2015 issued by N.R.C.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Dr. Pushpendra Singh Smarak Mahavidyalay, Amethi, Pradesh dated Sultanpur, Uttar 30/10/2015 against is the Order NRC/NCTE/NRCAPP-7030/243rd Meeting/2015/125084 dated 09/10/2015 of the Northern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "the reply dated 10/09/2015 was submitted by the institution in response to the Show Cause Notice issued inter-illia giving 30 days time for submission of reply. The institution neither submitted reply with in the 60 days period given under LOI nor could it comply the required documents in the SCN. Thus, the institution got a period of 90 days to submit the required reply but it could not do so."

AND WHEREAS Sh. Santosh Kumar Singh, Member, Dr. Pushpendra Singh Smarak Mahavidyalay, Amethi, Sultanpur, Uttar Pradesh presented the case of the appellant institution on 12/01/2016. In the appeal and during personal presentation it was submitted that the institution received the letter of intent dated 13th May, 2015 in the last week of May, 2015. The institution applied for sending the panel for selection of faculty to the Registrar Dr. Ram Manohar Lohia Avadh University Faizabad (herein after referred as University for short) just after receiving the information through internet on 09th March. 2015. The University constituted panel and the names of experts were sent to the Institution vide letter dated 04.07.2015 after about 4 months. The reply of the letter of intent was to be submitted till 12th of July, 2015. The experts who were nominated for selecting the HOD Dr. I.R.S. Sindhu, Prof. Sudhir Kumar and Prof. Subodh Kumar refused to visit the institution. The expert of Visual art Prof. B Agarwal and P. Rajiv Navan also refused to visit the Institution. The Institution again wrote letter to the University on 25.08.2015 to nominate other experts in their places. The university allotted new panel on 06.10.2015. Two experts Dr. Samar Bahadur Singh and Dr. Subodh Chandra Agarwal amongst whom Dr. Samar Bahadur Singh had died prior to one year and Prof. Subodh Chandra Agrawal refused to visit the Institution. The institution again wrote letter to the university on 08.10.2015 intimating the fact of death and refusal of respective persons. The University again nominated new panel and the names of Prof. R.P. Shukla and Dr. S.B. Singh were included in the list of experts. The panel visited on the scheduled dated 25.10.2015 and selection was made by the experts on the said date. The institution immediately sent the documents for approval to the University on 27.10.2015. The Institution made frantic endeavour to obtain the approval early as much as possible, but due to the lethargic, callous and apathetic attitude of the University the approval is still awaited and it could not be secured by the institution for none of its faults. The show cause notice was issued to the Institution in the terms of 241st Meeting of N.R.C. and it

was received by the Institute on 20.08.2015. The Institution submitted its reply on 05.09.2015 by speed post. No objection certificate was not required at the relevant time when the Institution applied for recognition. The application of the institution was rejected in the 243rd meeting of the NRC, which was held on 28-30, September, 2015. The NRC was under the legal obligation to consider the difficulty which was faced by the institution. It is specific feature of the entire episode that there is fixed time for sending the reply to the letter of intent on the one hand and there is no fixed time for sending the experts for making selection of the faculty and granting approval. The Institution categorically submits that the College will be composite as the 3 years Graduation course is already running from the session 2011-12. The Institution fulfils the requirement of being composite institution. The institution applied for establishing B.Ed. College in the year 2012 for running 1 year B.Ed. course and there is no application of the Regulation framed in the year 2014. It is worth indicating that the institution has already received the recognition of 3 years Graduation Course in Art subjects. As for as 'No Objection Certificate' is concerned it is most respectfully submitted that the provisions of NCTE Regulation whereby NOC was required was declared illegal and void by the High Court and when the Institution applied for recognition of 1 year B.Ed. course there was no requirement of submitting the NOC. Now at later stage the NRC cannot force to the institution to submit the NOC. The names of experts are recommended without receiving their consent and without considering as to whether they are suffering from ailment or not. Consequently the experts generally show their unwillingness to visit the college.

AND WHEREAS Appeal Committee noted that a Letter of Intent (L.O.I.) was issued to the appellant institution on 19/05/2015. The conditions laid down in the L.O.I. inter-alia laid down that the appellant institution has to get the approval of affiliating body to the appointment of faculty within a period of 60 days. The appellant institution furnished evidence that it had continuously been writing and pursing with the affiliating body for nomination of experts to finalise the selection of faculty. Copies of Letters dated 4/07/2015 and 25/08/2015 addressed to Vice Chancellor, Dr. Ram Manohar Lohia Awadh University, Faizabad were furnished to N.R.C. on 05/09/2013. The appellant institution vide its letter dated 05/09/2015 had also kept the N.R.C. informed of the difficulties being faced in getting subject experts and requested for sympathetic consideration. As regards other points raised in the S.C.N. relating to composite nature of the institution and N.O.C. from affiliating body, the appellant has stated that since its application dates back to year 2012, the points raised cannot be insisted to be pre-requisites. The appellant further stated that affiliating University has finally approved the faculty on 29.10.2015 which the appellant should be allowed to submit to N.R.C.

AND WHEREAS Appeal Committee took note that the appellant institution has been making consistent efforts to seek university approval and has also kept the N.R.C. informed of the developments in this regard. Committee, therefore, decided to remand back the case to N.R.C. for consideration of the list of faculty which the appellant should submit to N.R.C. within 15 days of the issue of appeal orders. Appellant should also furnish a compact reply to all the points required to be complied with as per conditions laid in the L.O.I. dated 19/05/2015.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded to remand back the case to N.R.C. for consideration of the list of faculty approved by the affiliating University. The appellant should furnish a compact reply to L.O.I. within 15 days of the issue of appeal orders.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC for consideration of the list of faculty which the appellant should furnish to NRC within 15 days of the issue of appeal orders. Appellant should furnish a compact reply to all the points required to be complied with as per conditions laid in the L.O.I. dated 19/05/2015.

NOW THEREFORE, the Council hereby remands back the case of Dr. Pushpendra Singh Smarak Mahavidyalay, Amethi, Sultanpur, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Biswanath Institute of B.Ed. College, Mojilispur, South 24 Parganas, West Bengal dated 05/11/2015 is against the Order No. ERC/7-193.1/ERCAPP1505/2013/35504 dated 08/09/2015 of the Eastern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "after constitution of VT, the institution has requested to extend the time limit of inspection by 60 days. The ERC decided to give 30 days' time to the institution in 186th ERC meeting. No reply has been received from the institution till date. In view of the above the Committee decided as under: The Recognition of the institution for B.Ed. Course is refused."

AND WHEREAS Sh. Biswanath Ghorami, President and Sh. Deepak Ghosh Dastidar, Manager, Biswanath Institute of B.Ed. College, Mojilispur, South 24 Parganas, West Bengal presented the case of the appellant institution on 12/01/2016. In the appeal and during personal presentation it was submitted that "the decision for inspection of our institute was taken in 156th ERC Meeting held on 7th and 8th June, 2013. You are well aware that due to heavy rain particularly in South 24 Parganas District, West Bengal, there was no scope of work for the month of August and we informed NCTE, Bhubaneswar vide letter No. MS/BIBC/01/12-13/04 dated 28/09/2013. President of the Society also personally met the authority. In 186th meeting of ERC, NCTE, Bhubaneswar decided to give 30 days' time to conduct the inspection. We sent a request letter to ERC NCTE, Bhubaneswar vide letter No. MS.BIBC/01/15-16 dated 27/08/2015 for ready to inspection of our institute after 30 days. But no information received from ERC, NCTE, Bhubaneswar. Accordingly we have completed all of our works as per norms & Standards of NCTE Regulation 2014 and waiting for VT to inspection our institution. Unfortunately in 193th Meeting ERC refused our file without any reason."

AND WHEREAS Appeal Committee noted that E.R.C. Bhubaneswar decided to conduct inspection of the Institution and a letter to this effect was issued on 03.07.2013. On the request of appellant institution date for inspection was extended and another letter of inspection was issued on 04.11.2013. One of the V.T. members informed E.R.C. on 13.01.2014 that appellant institution is not ready to give any date of inspection before two months. A Show Cause Notice (S.C.N.) was therefore, issued on 11.02.2014. On the request of institution another notice for inspection of the institution was issued on 30.01.2015. The Visiting Team member again informed E.R.C. that Sh. Biswanath Ghorani, President of the society, when contacted on phone, told that 'we are not ready for inspection' and disconnected the phone. E.R.C. thereafter issued another letter dated 05/03/2015 seeking clarification from the appellant institution. Appellant institution in reply to the above letter again sought 60 days time to get ready for inspection. E.R.C.

allowed 30 days time and accordingly informed the appellant institution on 29.04.2015. Since the institution did not confirm to have readied itself for inspection and number of opportunities were already given to the institution since July, 2013, E.R.C. finally decided to refuse recognition on 08/09/2015 on the ground that no reply was received from the institution. Appeal Committee decided that though the E.R.C. did not seek any reply from the appellant institution vide its letter dated 29.04.2015, it was incumbent on part of the institution to have come forward and informed the E.R.C. of its readiness for inspection. Though inspection is not subject to the consent of institution yet enough opportunities were given to the applicant institution to get ready for inspection. Appeal Committee, therefore, decided to confirm the refusal order dated 08/09/2015 which was issued after giving enough opportunities to the appellant institution for getting itself inspected.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Committee concluded to confirm the refusal order dated 08/09/2015 issued by E.R.C.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the ERC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the ERC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Ramnath PTC College, Shivnagar, Brahmin Society, Amreli District - Gujarat dated 05/11/2015 is against the Order No. WRC/APWO 2456/322283/PTC/231/Guj/2015/152736PTC/231/Guj/2015/152736 dated 11.09.2015 of the Western Regional Committee, refusing recognition for conducting D.E.C.Ed. course on the grounds that "show cause notice dated 09/04/2015 issued on the grounds of (a) land not being in the name of the society (b) land being less than as required under Appendix-2 of NCTE Regulations, 2014 (c) built up area being less as required under Appendix-2 of NCTE Regulations, 2014 (d) CLU not being in the proper format € FDRs for Rs. 5.00 lakhs and Rs. 7.00 lakhs not submitted. The applicant Society has not complied with the requirements mentioned in the Show Cause Notice. Hence, Recognition is refused u/s 14(3)(b) of NCTE Act, 1993. FDR be returned."

AND WHEREAS Sh. Vipul B. Dave, President and Sh. Devank S. Dave, Secretary, Ramnath PTC College, Shivnagar, Brahmin Society, Amreli District - Gujarat presented the case of the appellant institution on 12/01/2016. In the appeal and during personal presentation it was submitted that "as per the approval time Norms, 30 years lease land is acceptable. Land area is already available as per appendix 2 of NCTE Regulation 2014. We have already built the building and our building built up area is 2348 sq.mt. As per state Government Rules, CLU was sent to the NCTE office. We have already made FDR Rs. 12 lakhs it is a 5 lakhs 3 lakhs and 4 lakhs and all original copy of FDR is with NCTE Office."

AND WHEREAS Appeal Committee noted that recognition for conducting P.T.C. course was granted to the institution in Oct., 2006. The V.T. report dated 31.08.2006 (under Section 14 of the NCTE Act) indicates that institution started conducting the P.T.C. course from a rented premises. Committee also noted that recognition granted to the institution in Oct., 2006 was earlier withdrawn in July, 2012 by the W.R.C. on the grounds that institution had failed to shift to its own premises within three years period. The appellant preferred an appeal against the above order and the appellate authority remanded back the case to W.R.C. vide its order dated 15/01/2013 on the ground that before withdrawing recognition the appellant was not given opportunity to submit written representation i.e. S.C.N.

AND WHEREAS the appellant institution, thereafter submitted fee of Rs. 50,000/- for shifting of premises. The supporting documents furnished by the appellant pertain to building plan and Building Completion Certificate. The building plan does not contain stamp and signature of any civic authority and the proposed built up area on ground +

first + second + S.C. is approximately 9630 sq. feet. The Building Completion Certificate dated 3.08.2011 issued by Gram Panchayat, Amreli is for a total built up area of 7706 sq. feet. As seen from both the above documents, the built up area possessed by the appellant institution is far less than the builtup area of 1500 sq. mtrs. as prescribed under the NCTE Regulations, 2007, 2009 & 2014. The appellant also submitted copy of a Lease agreement dated 09.12.2005 which pertains to property on land measuring 7536 sq. feet with a built up area of 3853 sq. feet. Appeal Committee observed that land and built up area under possession of the appellant institution is far less than what is required under the NCTE norms Clause 8(11) of the NCTE Regulations, 2014 provide that "Wherever. there are changes in the norms and standards for a programme in teacher education, the institution shall comply with the requirement laid down in the revised norms and standards immediately. However, the revised land area related norms shall not be applicable to the existing institutions but the required built up area shall have to be increased to confirm to the revised norms." The appellant institution in the above case has not been able to furnish any evidence that it now possess the required built up area. Appeal Committee, therefore, decided to confirm the 'Refusal order' dated 11.09.2015 which actually should have been a 'withdrawal order' as the appellant institution was earlier granted recognition in the year 2006. Refusal order to be amended accordingly.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the order dated 11.09.2015 issued by W.R.C. The impunged refusal order dated 11.09.2015 should be modified to read as withdrawal order.

AND WHEREAS After perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the WRC was justified in withdrawing recognition and therefore, the appeal deserved to be rejected and the order of the WRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to SRC for further processing of the application of appellant institution as per extant regulations.

WHEREAS the appeal of Shri Ram Sahay Singh Kanya Mahavidyalaya, Mahripur, Basti, Uttar Pradesh dated 16/11/2015 is against the Order No. NRC/NCTE/NRCAPP-6629/243rd Meeting/2015/125658 dated 14/10/2015 of the Northern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "the response given by the institution dated 05/09/2015 to SCN dated 14/08/2015 regarding non approval/NOC of the programme by the Affiliating University and non-recruitment of teachers and Head of the institution is not satisfactory."

AND WHEREAS Sh. Ashutosh Kumar Tripathi, Clerk, Shri Ram Sahay Singh Kanya Mahavidyalaya, Mahripur, Basti, Uttar Pradesh presented the case of the appellant institution on 12/01/2016. In the appeal and during personal presentation it was submitted that "Teacher approval is under process because there is change in the affiliating University. The present university is Siddharth Nagar, University, Kapil Vastu. When the institution applied for B.Ed. course in 2012, there was no rules of NCTE to submit (NOC) and composite institution letter. But N.R.C. in its letter dated 14/08/2015 demanded the NOC letter and composite institution letter. The institution has applied for NOC in Siddharth Nagar University, Kapil Vastu. The letter is attached/enclosed in the document whereas the previous university has changed (DDU Gorakhpur University). The new University is Siddharth University, Kapil Vastu. That's why the delayed of NOC letter. The teacher approval process is under process. The Siddharth Nagar University has selected/appointed the subject expert committee. The letter is also enclosed in the document. The institution has given teacher approval advertisement in the Hindustan and Sahara Newspaper. The Xerox copy is also enclosed. The institution has replied all the letter of NCTE in the given time period."

AND WHEREAS Appeal Committee noted that Letter of Intent (L.O.I.) was issued to the appellant institution on 22.05.2015 seeking compliance on certain points including selection of faculty with the approval of affiliating University. Appeal Committee further noted that a Copy of L.O.I. was endorsed to the Registrar, Deen Dayal Upadhyay (DDU) University with a request to provide all assistance to the institution for selection of faculty. Subsequently a Show Cause Notice (S.C.N.) dated 14/08/2015 was issued seeking written representation from appellant institution for non-submission of reply to L.O.I. and clarification on some other points such as (a) proof of being a composite institution (b) affidavit undertaking to become a composite institution (c) N.O.C. from affiliating body. The appellant institution submitted a reply to S.C.N. which was received in the office of N.R.C. on 7/09/2015. The appellant beside furnishing reply on the composite nature of institution informed N.R.C. that there has been a change in the affiliating University and

instead of DDU University, the institution is now covered under the jurisdiction of a newly created University known as Sidharth University, Kapilvastu. The appellant also informed the N.R.C. that the institution has applied to the new University for issue of N.O.C., which was earlier not required under the NCTE Regulation of 2009. Appeal Committee noted that the appellant institution has made efforts to select faculty and the most obvious reason for delay was change in the affiliating University. Appellant has also kept the N.R.C. informed by responding to the S.C.N. Appellant made a submission before Appeal Committee that given a chance it would be possible for the institution to submit list of faculty within a month. Committee decided to remand back the case to N.R.C. for accepting the compliance report from appellant institution if it is submitted within a month from the date of issue of appeal orders.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to N.R.C. The appellant is required to submit compliance report to L.O.I. within 30 days time from the date of issue of appeal orders.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC for accepting the compliance report from appellant institution if it is submitted within a month from the date of issue of appeal orders.

NOW THEREFORE, the Council hereby remands back the case of Shri Ram Sahay Singh Kanya Mahavidyalaya, Mahripur, Basti, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Ram Dev Degree College, Mahimapur Deeh, Jaunpur District, Uttar Pradesh dated 17/11/2015 is against the Order No. NRC/NCTE/NRCAPP-7906/243rd Meeting/2015/125475 dated 13/10/2015 of the Northern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "the institution has not submitted compliance/documents as required in letter of intent issued under clause 7(13) of NCTE Regulation 2014 and show cause notice issued in this regard."

AND WHEREAS Sh. Jitendra Yadav, Manager of Ram Dev Degree College, Mahimapur Deeh, Jaunpur District, Uttar Pradesh presented the case of the appellant institution on 12/01/2016. In the appeal and during personal presentation it was submitted that "the institution received the letter of intent in the last week of January, 2015. The institution applied for sending the panel for selection of faculty to the Registrar, Veer Bahadur Singh Purvanchal University, Jaunpur, U.P. on 26/01/2015. The university constituted panel and the names of experts were sent to the institution vide letter dated 04/02/2015. The University was not careful and nominated one member in the panel who had already died. The institution informed the University with request to send another expert in place of dead expert. The panel sent by the University made selection and institution submitted entire papers for approval which was granted on 23/04/2015 for 7 teachers. Approval of Head of Department was granted on 01/05/2015. It is specifically submitted that the compliance of letter of intent was made vide letter dated 06/05/2015 vide dairy number 102019. But no information was sent by the NRC till 12.07.2015 on which date the Manager of the institution personally met the Regional Director and narrated his problem. The Regional Director informed him that his file was not traceable and he directed the Manager to submit photocopy from his office copy. The Manager of the institution submitted photocopy of his office copy in the NRC on 13/07/2015. The NRC considered the case of the institution in its 240th meeting held between 20 July to 22 July 2015 and it was noted that the institution has not submitted the faculty in respect of Physical Education and Fine Art. It is worth indicating that the institution has submitted the application for granting recognition in the year 2012 and at the time there was no requirement of approved faculty of Physical Education and Fine Art. Accordingly the University has not sent expert for the selection of the said faculty. After promulgation and application of Regulation 2014 it was made necessary to appoint said faculty on regular basis. The institution received the show cause notice in the 1st week of September 2015. The institution again requested the University to send the panel for selection of faculty of Physical Education and Fine Art just after receiving the show cause notice sent by NRC. The University sent panel and selection was made and papers were submitted by the institution without lapse of single day and approval was granted on 06/11/2015. The institution requested the University for sending panel for making selection on the two

posts mentioned in the show cause notice just after receiving the show cause notice but the University took time in sending panel and in making selection and in granting approval which was beyond the control of the institution. The application of the institution was rejected on 13/10/2015 when the selection process for selecting the faculty as mentioned in the show cause notice was going on."

AND WHEREAS Appeal Committee noted that a Letter of Intent (L.O.I.) was issued to the appellant institution seeking compliance on certain points including selection of faculty with the approval of affiliating University. Appeal Committee further noted that a Show Cause Notice (S.C.N) dated 04.06.2015 was issued to the appellant institution on ground of non-submission of reply to L.O.I. The appellant in its appeal memoranda stated that on making personal enquiry from N.R.C. on 13/07/2015 it was revealed that the relevant file is misplaced and he was required to submit a copy of compliance letter dated 06.05.2015 which he had already submitted to N.R.C. vide diary no. 102019 dated 06/05/2015. On getting a copy of the compliance report N.R.C. again issued a S.C.N. dated 03/08/2015 on grounds that institution has not submitted faculty in respect of physical education and fine arts as required under NCTE Regulations, 2014.

AND WHEREAS Appellant during appeal presentation on 12.01.2016 informed that as full time appointment of faculty of physical education and fine arts was not mandatory as per 2009 regulations, there was some confusion and difficulty in getting nomination of experts by the affiliating University. Subsequently the appellant institution was able to get faculty of physical education and fine arts selected on 06/11/2015.

AND WHEREAS Appeal Committee noted that appellant institution was able to report compliance to L.O.I. before issue of S.C.N. though the list of faculty was short of physical education and fine arts faculty. Appellant institution has been able to get this deficiency also removed within a reasonable time. Appeal Committee, therefore, decided to remand back the case to N.R.C. for reconsideration. Appellant is required to submit faculty approved by affiliating University to N.R.C. within 15 days of the issue of appeal orders.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to N.R.C. for reconsideration. The appellant institution is required to submit the list of faculty of physical education and fine arts to N.R.C. within 15 days from the date issue of appeal orders.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC for

reconsideration. The appellant institution is required to submit the list of faculty of physical education and fine arts to N.R.C. within 15 days from the date issue of appeal orders.

NOW THEREFORE, the Council hereby remands back the case of Ram Dev Degree College, Mahimapur Deeh, Jaunpur District, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Calicut University Teacher Training Education Centre, Malappuram, Kerala dated 18/11/2015 is against the Order No. SRO/NCTE/APSO2945/B.Ed/KL/2015 dated 23/09/2015 of the Southern Regional Committee, withdrawing recognition for conducting B.Ed. course on the grounds that "both BCC and Staff List are deficient."

AND WHEREAS Prof. (Dr) P. Kelu, Director of Teacher Education Centres, Calicut University Teacher Training Education Centre, Malappuram, Kerala presented the case of the appellant institution on 13/01/2016. In the appeal and during personal presentation it was submitted that "University of Calicut has planned to construct a three storied building for the University Teacher Education Centre-Manjeri in its 1.25 acres of land with 1917.30 sq. mts. Plinth area and this plan was approved by the concerned authority. Secretary Manjeri Municipality. The University has constructed a two floored building with an area 1239.16 sq. mts. Remaining second floor of the building is yet to be constructed. Construction steps were being taken for the completion of remaining portion at the earliest for getting recognition of the NCTE. (Building Plan enclosed-Appendix-1). A detailed building completion certificate in a comprehensive format issued by competent authority is attached. In this building completion certificate plinth area of ground floor and first floor is clearly mentioned. The total plinth area of the building is also clearly mentioned. The total plinth area of the building is also clearly mentioned without any ambiguity. University of Calicut appointed qualified teaching faculty as per the Norms and Regulations of NCTE from time to time on full time basis with scale of pay as per vide order of Kerala Government and University of Calicut (G.O. (Ms.) No. 416/2015/H.Edn, dated 9.7.2015 and U.O.No. 5612/2015 Admn. Dated 03/06/2015 respectively). Approved Staff List prepared in the format of NCTE, with detailed account of teaching faculty duly signed by Registrar, University of Calicut attached here with for your kind perusal. It may kindly be noted that University of Calicut appointed teaching faculty for the concerned subjects with the prescribed qualifications as per the Norms and Standards of NCTE existed at the time of their appointments. The date of appointment of each faculty in the present position is clearly mentioned in the approved staff list of the teaching staffs. A few faculty members appointed as per the NCTE Norms, 2007 and some of them were appointed as per the Norms of 2009. It may please be noted that 2007 Norms became effective on 27th November 2007 and 2009 Norms became effective on 13th May 2009.. It this connection it may also be noted that there is a clarification of NCTE with regard to the implementation of New Regulation 2014 as frequently asked questions (FAQ), For the question about staff, "Shall the vacant positions at present and vacancies occurring in future in the faculty be filled by the institution with candidates having qualifications as per new Regulations 2014?" They replied that, "All future appointments of faculty and staff including those for existing vacant positions shall be as per qualifications prescribed in Regulations (and Norms & Standards) 2014 (without disturbing the existing faculty and staff)", In the Explanatory note issued by NCTE on 03/11/2015 to all the existing institutions, it is clearly mentioned in the item No.4 as "All the existing positions and vacancies occurring in future shall be filled up by the institution with candidates having qualifications as per the New Regulations", Hence I request you to look in to the clarification also while taking a decision in this matter. Institution applied to the NCTE for recognition on 11/09/2014 with necessary documents by paying its prescribed inspection fees Rs. 50,000/-. NCTE, SRC sent two show cause notices to the institution on 05/01/2015 and 18/03/2015 respectively. Institution furnished the required information to these notices but in the Building Completion Certificate University Engineer has not mentioned the total Plinth area of the constructed building. Now in the new Building Completion Certificate it is clearly mentioned the total plinth area. Hence the deficiency in the BCC may be vacated (original Building Completion Certificate present along with this appeal). Moreover the staff list already sent to the NCTE was not in the prescribed format of NCTE. Now University provided the approved staff list in the prescribed format of NCTE with detailed account of the teaching faculty for recognition. It may please be noted that the objections raised against the withdrawal of the Calicut University Teacher Education Centre, Manjeri the University of Calicut complied with most of the objections raised against the withdrawal of NCTE recognition now. Moreover as per the direction of the NCTE, SRC, Bangalore, the University has already submitted an application for recognition by remitting Rupees 50,000/- as inspection fee. Kindly consider the facts furnished above with regard to the objections (item Nos.1,2,3 and 4).

AND WHEREAS Appeal Committee noted that Calicut University Teacher Education Centre, Manieri was granted recognition for conducting B.Ed. course with an intake of 115 students vide order dated 13.07.2004 issued by S.R.C. Bangalore. The University Centre at the time of grant of recognition was running in a temporary accommodation of a school building and was required to shift subsequently. Failure to get necessary infrastructural and instructional facilities by the University resulted in issue of a Notice to the Centre in 2009, followed by a withdrawal Order dated 26.06.2009 which was contested successfully by the appellant university in the Hon'ble High Court of Kerala at Ernakulam (W.P. No. 33636/2007). In the year 2014 S.R.C. decided to conduct inspection of the University centres including the one located at Manjeri for ascertaining adherence to the norms and standards. On the basis of information furnished by the Registrar of University on the basis of a Questionnaire, S.R.C. issued Show Cause Notices on 05.01.2015 and 18.03.2015. After considering the reply dated 15.04.2015 of the University Centre, S.R.C. issued a letter dated 23.09.2015 to the appellant Centre stating that (i) B.C.C. and staff list are deficient and do not fulfil even the 2009 norms/standards (ii) there is no scope for reconsidering the withdrawal order and (iii) the institution may apply afresh as per NCTE Regulations.

AND WHEREAS Appeal Committee presumes that refusal of the S.R.C. to reconsider the withdrawal order is with reference to order dated 26.06.2009 as no revised order as envisaged in the order of Hon'ble High Court of Kerala at Earnakulam are found

placed in the relevant record. The Hon'ble Court had directed the NCTE to treat the University Centres as approved centres for the year 2010-11 and required NCTE to issue revised orders for academic year 2011-12 onwards.

AND WHEREAS Appeal Committee further observes that with the issue of Court's order referred to above, the validity of the withdrawal order dated 26.06.2009 ceased to exist and the S.R.C. was required to issue revised order in terms of Section 17(1) & 17(2) of the NCTE Act which has not been done by S.R.C. Quoting deficiencies and asking the institution to apply afresh through a simple letter dated 23.09.2015 which is also not made appealable is not proper and is violative of the procedure being followed in issuing or withdrawal orders issued under Section 17 of the Act. Appeal Committee, therefore, decided to set aside the subjective letter dated 23.09.2015. S.R.C. is required to examine the case of University centre afresh, if required, by conducting inspection. Revised speaking orders complying the orders of Hon'ble High Court of Kerala, Earnakulam in W.P. case no. 33636 of 2009 and conforming to the procedure laid down under Section 17 of the Act should thereafter be issued.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to set aside the decision conveyed to appellant institution vide letter dated 23.09.2015 issued by S.R.C. Further the S.R.C. is required to reconsider the matter keeping in view the order of Hon'ble High Court of Kerala, Earnakulam conforming to the provision of Section 17 of the NCTE Act.

WHEREAS the appeal of VET College of Education, Vellupuram, Tamil Nadu dated 23/11/2015 is against the Order No. SRO/NCTE/SRCAPP3551/M.Ed/TN/2016-17/76058 dated 13/10/2015 of the Southern Regional Committee, refusing recognition for conducting M.Ed. course on the grounds that "the institution has not submitted registered land document along with application."

AND WHEREAS Sh. R. Murugan, Vice Principal, VET College of Education, Vellupuram, Tamil Nadu presented the case of the appellant institution on 13/01/2016. In the appeal and during personal presentation it was submitted that "the application was submitted through online on 23/06/2015 and hard copy was submitted in person before the NCTE regional office on 06/07/2015. The hard copy was duly acknowledged on the same date i.e. 06/07/2015. All the necessary land documents were verified and the acknowledgement was given and the person who acknowledged intimated that the documents were to be produced during the time of inspection and instructed to take it back. That is the main reason on which the copy of document was not submitted. The Regulation 7(2) says the print out of the application should be submitted along with land documents within 15 days from the date of submission of online application. The fact remains that the printout was duly submitted in time and even assuming the land documents are not enclosed, it is just a curable deficiency and if a communication is addressed on this aspect we would be in a position to send those documents. Nonenclosing of land document is a curable defect and for rectification of defect the institution must have been given an opportunity. The application fee is 1,50,000/- (one lakh and fifty thousand) was not returned along with the rejection order. The present regulation is completely bad in eye of law. Since it not only enables summary rejection but also forfeit's the application fee. If an opportunity is given the institution would have complied the production of document since it's a curable deficiency. The institution is already running B.Ed. course from 2008 and also NAAC accredited one and hence it's not a new institution. Further the appellant is willing to produce a copy of land document before the regional office. Further appellant is prepared to produce a copy of the land document for perusal by the Appellant Authority.

AND WHEREAS Appeal Committee noted that appellant institution submitted online application for M.Ed. course on 23.06.2015 and hard copy was submitted/received in the office of S.R.C., Bangalore on 06/07/2015. Hard copy of application does not contain land documents issued by registering authority. Instead of furnishing land documents issued by registering authority, the appellant had furnished one affidavit stating that the trust is in possession of land measuring 13655 Sq. Meters at khasra no. 33/4, 5, 6 district

Villupuram, Tamil Nadu. Appeal Committee is of the view that affidavit cannot be treated as a substitute for registered land document which is required to be furnished alongwith the application under subsection (2) of Section 7 of Regulations, 2014. The argument put forward by the appellant that 'land documents were produced at the submission counter and the official who acknowledged the application verified these documents and intimated that these documents were to be produced during the time of inspection' is not acceptable. The appellant before submitting application should have been clear about the regulatory provisions. Sub-regulation (4) of Regulation 5 reads as under:

"While submitting the application online a copy of the registered land document issued by competent authority, indicating that the society or institution applying for the programme possesses land on date of application shall be attached alongwith the application."

Subsection (2) of Section 7 of Regulations, 2014 further stipulate that application shall be summarily rejected in case of failure to submit land documents alongwith online applications. Regulations 7(1) also provides for forfeiture of the application fee if any application is found incomplete and rejected.

AND WHEREAS Appeal Committee further noted that appellant institution submitted a letter dated 13.01.2016 stating that original land documents were pledged with City Union Bank, Villupuram for obtaining a loan of 1 crore and the manager of CUB Villupuram has endorsed the fact that VET Trust land document is with the bank. Appeal Committee thereafter, invited attention of the appellant to the provision 8(4) (1) of the Regulations, 2014 which lay down that the land should be free from all encumbrances. Pledged land cannot be treated to be free from encumbrance. Appeal Committee, keeping in view the circumstances of the case, decided to confirm the refusal order dated 13.10.2015 issued by S.R.C.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the SRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the SRC is confirmed.

In the appeal and during personal presentation it was submitted that "the NOC is acquired from Rani Durgawati University, Jabalpur is submitted hereunder."

AND WHEREAS Appeal Committee noted that appellant institution had submitted online application for integrated course of B.A/B.Sc./B.Ed. on 30.06.2015 and hard copy thereof was received in the office of W.R.C. Bhopal on 15/07/2015 (through speed post). The hard copy of the application did not contain N.O.C. of affiliating body though a reference to it was made in the list of enclosures at serial no. 11 (E 11a 11b). As N.O.C. from affiliating body is one of the essential documents to be enclosed alongwith application under clause 5(3) of the NCTE Regulations, 2014, the application was summarily rejected. Appellant during the course of appeal presentation stated that N.O.C. from affiliating University was forwarded to W.R.C. by courier on 13.07.2015. The copy of courier receipt furnished as evidence is for an article weighting 300 gms which cannot be the weight of a single page N.O.C. Moreover, no such document is found in the relevant records contained in W.R.C. file. Appeal Committee therefore, decided to confirm the refusal order dated 30.09.2015 issued by W.R.C., Bhopal.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the WRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the WRC is confirmed.

The institution did submit a written application vide letter no. - ACK/ETT/1004 dated 25.11.2014 to make an inquiry into developments pertaining to the D.El.Ed. course. Further, the institution also submitted written application vide letter no. AC/Edu-1646 dated 27.01.2015 along with the affidavits as per prescribed format and willingness to get the pending application processed. In addition to existing Endowment and Reserve Funds, Bank Certificate of increased fixed deposit receipts sent in original:- a) Bank certificate of fixed deposit no. 084300PU00013194 dated 23-01-2015 of Punjab National Bank, Rehan, Kangra (H.P.) OF Rs. 2,00,000/- (Rs. Two lacs only) towards Endowment fund. b) Bank Certificate of fixed deposit no. 084300PU00013200 dated 23.01.2015 of Punjab National Bank, Rehan, Kangra (H.P.) of Rs. 2,00,000/- (Rs. Two lacs only) towards reserve fund. The letter of rejection of D.El.Ed. proposal was received vide rejection order letter no. File No. NRC/NCTE/NRCAPP-7317/225th Meeting/118533 dated 14 July, 2015."

AND WHEREAS Appeal Committee after noting the request dated 27.10.2015 made by appellant to grant another opportunity, decided to give another (second) opportunity to the appellant for submitting evidence through relevant documents. Appellant appeared before the Committee on 14.10.2016 and stated that reply to deficiency letter was submitted vide letter dated 06.06.2013. The N.R.C. after processing the reply to Deficiency letter issued Show Cause Notice (S.C.N) dated 28.10.2013 on the ground that "The State Government vide letter dated 15.01.2009 has allotted land for B.Ed. course and not for D.El.Ed. course." Appellant during the course of appeal presentation submitted copy of a reply dated 20.11.2013 to the S.C.N. sent by speed post on 21.11.2013. The appellant in its above reply had made efforts to clarify that basically land is allotted for education purpose and mentioning the name of a particular education

course is symbolical and not final. The refusal order dated 14/07/2015 on the ground that institution has not submitted reply to S.C.N. dated 28.10.2013 is not justified for the reason that appellant has furnished evidence of having sent a reply by speed post. Also the logic stating the 'land use for B.Ed. course' and not for D.El.Ed. course' is not tenable. Appeal Committee decided to remand back the case to N.R.C. for further processing of the application. Appellant should furnish a copy of its reply dated 20.11.2013 to N.R.C. as it is not found available on the relevant file.

AND WHEREAS After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to N.R.C. for further processing of the application after taking on record the reply dated 20.11.2013 a copy of which shall be furnished by the appellant institution. Appellant is required to furnish a copy of its reply dated 20.11.2013 to N.R.C. within 15 days of the issue of appeal order.

AND WHEREAS After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC for further processing of the application. In the appeal and during personal presentation it was submitted that "University has delayed staff approval."

AND WHEREAS appellant during the course of appeal presentation stated that in reply to Show Cause Notice, F.D.Rs were submitted to N.R.C. on 28.05.2015. The appellant submitted that list of selected faculty has also been sent to affiliating University for approval. Appellant made a request to Appeal Committee for granting another opportunity to furnish evidence in support of his claim. Appeal Committee decided to grant another (second) opportunity to the appellant to furnish documentary evidence in support of faculty having been selected and letter seeking permission of the affiliating University having been issued.

AND WHEREAS Dr. Yogendra, Administrative Officer and Sh. Vinod Kumar, Administrative Officer again appeared before the Committee on 14.01.2016 and submitted before the Appeal Committee a track report issued by Sub Record Office. Ghaziabad City Post Office certifying that delivery of speed post letter, booked by the appellant institution on 29.07.2015, was made in the office of N.R.C. Jaipur on 03.08.2015. The above letter is not placed in the file but has been found placed below the file cover. It is therefore, clear that the contents of above referred letter dated 29.07.2015 were not taken cognisance of by the N.R.C. in its 240th Meeting held between 20th to 22nd July, 2015 and based on the decision taken in this meeting a refusal order dated 18.08.2015 was issued subsequently. The appellant had also furnished copies of two letters dated 23.07.2015 by which Mahatma Jyotiba Phule Rohilkhand University, Bareilly had conveyed its approval to the selection of Principal and fifteen faculty members. Crux of the problem is that the institution did submit a reply dated 27.05.2015 and informed that after getting approval of the University, list of faculty will be submitted to N.R.C. The appellant did not furnish any reply to the two Show Cause Notices as such but have furnished the original Fixed Deposit Receipts. N.R.C., was also informed vide letter dated 27.05.2015 that the particulars of selected faculty have been furnished to the affiliating University for approval which is awaited. Appeal Committee is of the opinion that N.R.C. should have accommodated the request of the appellant institution particularly when selection was finalised and list was under submission to the affiliating University for approval. The letter dated 29.07.2015 of the appellant institution received in the office of N.R.C. on 03.08.2015 should have been placed in the file duly doated. Appeal Committee also noted that the F.D.Rs stated to have bene returned to appellant institution alongwith refusal order dated 18/08/2015 are still found placed on the file. Taking note of the circumstances of the case, Appeal Committee decided to remand back the case to N.R.C. for consideration of the contents of reply dated 29.07.2015 submitted by appellant and placed beneath the file but not taken cognisance of.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee decided to remand back the case to N.R.C. Jaipur for consideration of the submissions made by appellant institution <u>vide</u> its letter dated 29.07.2015 received in the office of N.R.C. on 03.08.2015.

ORDER

WHEREAS the appeal of Gurgaon World College of Education, Gurgaon, Haryana dated 03/10/2015 is against the Order No. NRC/NCTE/NRCAPP-9142/239th Meeting/2015/120320-325 dated 07/08/2015 of the Northern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "the institute did not submit reply of SCN."

AND WHEREAS No one from, Gurgaon World College of Education, Gurgaon, Haryana appeared on behalf of the appellant institution on 28/10/2015. Another (second) opportunity to the appellant institution for making a personal presentation was given. Sh. Ombir Dewatwal, Secretary of the Society Managing the appellant institution appeared before the Appeal Committee on 14.01.2016. The appellant submitted that "Reply to deficiency letter was given on 18/10/2013 and the Show Cause Notice (S.C.N) dated 18/12/2013 and 07/01/2015 were not received." Appellant also requested that their application should be considered as a new file for B.Ed. and all the discrepancies will be removed."

AND WHEREAS Appeal Committee noted that a deficiency letter dated 20th August, 2013 was issued to appellant institution pointing out 12 deficiencies on which clarification was required. The appellant institution did not furnish any reply to the deficiency letter and resultantly a Show Cause Notice (S.C.N) dated 18/12/2013 was issued in which a reference was also made to the negative recommendation of the State Government. Processing of applications was kept pending during 2013-14 due to revision of NCTE regulations. The matter was taken up afresh and another Show Cause Notice was issued on 07.01.2015 seeking written representation from the appellant institution within 30 days. Committee also observed from the copy of reply dated 18.10.2013 to deficiency letter (DL) that institution has not addressed all the 12 points raised in the D.L. Appellant's plea that the institution has not received any of the two S.C.Ns is not acceptable. There is no other communication from appellant institution addressed to N.R.C. seeking information on the status of pending application during the intervening period. Appeal Committee, took note of the indifferent attitude adopted by the appellant institution by not trying to communicate with N.R.C. during all this period and furnish reply to S.C.Ns. Committee therefore, decided to confirm the refusal order dated 07.08.2015 issued by N.R.C.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 07.08.2015 issued by N.R.C. Jaipur.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of I.B. Women College of Education & Management, Rohtak, Chandigarh - 160049 dated 01/07/2015 is against the Order No. NRC/NCTE/HR-1570/234th Meeting/2015/98834-839 dated 14/05/2015 of the Northern Regional Committee, withdrawing recognition for conducting B.Ed. course on the grounds that "1. the land documents attached with the application of the institution for B.Ed. course received by NRC on 31.03.2008 show that a plot of 3500 sq. yards bearing plot no. 169/25/2/2/1 situated in Ram Gopal Colony, Nagar Palika, Rohtak has been purchased through a registered Sale deed dated 08.12.2005 by Mother Teresa Educational Society from one Sumer Singh S/o Sw. Nand Ram for its proposed B.Ed. course. 2. The reply of the society (received by NRC on 09.03.2015) shows that the building of B.Ed. couse is situated on a land measuring 2500 sq. mts. and it has been obtained by the society through private lease deed dated 22.07.2007 Amarjeet S/o Sw, Jagbir. This lease deed specifically mentions that only I.B. College of Education and Management shall be run on this leased land/building whereas the name of the Institution which is being run at present (as is being claimed by the institution) is I.B. Women College of Education and Management. 3. VT inspected the institution on 17.09.2009 under section 17 of NCTE, Act, and its report reveals the address of institution as "Plot No. 111, Delhi Bye Pass Road, Rohtak". This VTR also mentions that the building of the institution is being used for Dreamland Public School only and no Teacher Education programme is being run from this building. 4. A letter no. CH-IX/11/3559-66 dated 16.02.2011 from Superintendent Colleges, MDU Rohtak reveals that the concerned institution has no land and building in the name of college and the same is being run in the school. The institution does not posses any land on ownership basis/Government lease basis since 2nd September, 2008 (the date of grant of recognition) till date. 5. The institution does not have its own building built exclusively for running B.Ed. course. 6. A list of teaching staff (attached with the letter of institution dated 06.03.2015) reveals that there is no Principal in the institution since 01.07.2013 which means that this B.Ed. programme is being run for last 01 year and 09 months without any Principal. Furthermore, the list of teaching staff has not been approved by the affiliating university. 7. The institution has not submitted the building completion certificate duly approved by the Competent Authority, with regard to the building built for the proposed B.Ed. course on the Plot No. 169/25/2/21 purchased on 08.12.2005 by the Society. 8. VT Report under Section 17 (dated 17.09.2009) reveals the following: Dreamland Public School is being run in the inspected building & no teacher education programme is being run in this building. Faculty has not been appointed as per NCTE norms for B.Ed. On the basis of above mentioned facts, it gets established beyond doubt that the institution has tried to mislead the NRC and has obtained recognition by concealing, distorting and fabricating the facts. Hence, NRC decided to withdraw the recognition of the institution for B.Ed.

course from the end of the academic session next following the date of order of withdrawal on the above points."

AND WHEREAS the appellant did not appear before the Appeal Committee on 03.09.2015 and 28/10/2015. As per extant appeal rules, three opportunities were provided to appellant to appear before the Appeal Committee to make personal presentation. Ms. Daya Yadav, Principal and Sangeeta Bhandari, Vice Principal appeared before the Appeal Committee on 14.01.2016 and submitted that "Building is already complete for running B.Ed. course and Dr. Daya Yadav is appointed as Principal w.e.f. 1.1.2013. The Building Completion Certificate was issued by E.O., Municipal Council on 05.03.2012. The premises in which B.Ed. course was conducted belongs to institution and the allegation in regard to Dreamland Public school being run in the premises is not correct. The affiliating University was approached for selection of faculty. The land was leased for 30 years dated 08.12.2005 in name of Mother Terasa Educational society and the society is powered to run the B.Ed. college.

AND WHEREAS Appeal Committee noted that recognition for conducting B.Ed. course was granted to the appellant institution in the year 2008 and it was withdrawn in March, 2013 on the basis of a report submitted by Asstt. Registrar, Maharishi Dayanand University and consequent deficiencies detected in an inspection conducted under Section 13 of the Act. Committee further noted that the withdrawal order dated 14.03.2013 was appealed against by the appellant institution and the matter was remanded back to N.R.C. vide appeal order dated 10.01.2014 for reissue of the deficiency letter dated 6.08.2012 and Show Cause Notice (S.C.N) dated 15.01.2013 as the appellant denied having received the above communications issued by N.R.C.

AND WHEREAS Committee further noted that on a number of occasions, the affiliating University had conducted inspection of the institution and reported deficiencies to N.R.C. on the basis of which the University had decided to place the college under 'No admission category'. Inspection conducted on 20.05.2012 under section13 of the Act revealed that (a) I.B. Women College is situated near Telephone Exchange, Rohtak (b) furniture in classrooms is not according to the size of B.Ed. students, (c) Teachers are not approved by University and (d) library books are substandard. Committee noted that land and building documents furnished from time to time by the appellant institution do not match. Whereas inspection under section 14 of the Act was conducted on 06/05/2008 with institution address as 'Ram Gopal Colony, opposite Sector 1 Telephone Exchange, Rohtak, the address of the institution is mentioned as 'Plot no. 111, Delhi Bye Pass Road. Rohtak' in an Assessment Performa dated 17/09/2009. Appeal Committee noted that there is a copy of letter dated 9/07/2012 written by affiliating University addressed to the society and Principal IB Women College of Education and Management wherein it is reported that on inspection on 13.03.2012 nobody was found in the college and on reinspection conducted on 1.06.2012 there was no sign board of the college anywhere on the building although at the time of first visit, there was a signboard of the college. At the time of re-inspection there were two sign boards; one was of Dreamland Public School and the other was of B.M.J. College of Education affiliated to G.G.S. I.P. University, Delhi. It is further reported that nobody from IB Women College was present and hence it was decided not to grant provisional affiliation.

AND WHEREAS Appeal Committee also noted that the case of appellant institution has been under litigation for quite some time for issues relating to grant and continuation of affiliation, declaring the results of admitted students etc and the Hon'ble Court had at once commented adversely by saying that continuance by way of interim orders cannot be legally tolerated.

AND WHEREAS Appeal Committee after going through the relevant records, various inspection reports conducted under section 14, section 17 and section 13 and enquiry reports furnished by the affiliating University is of the opinion that number of deficiencies are found and reported at different levels. M.D. University, Rohtak in its report No. CB-1X/2011/9328 – 36 dated 09.07.2012 states that there were two sign boards, one is of Dreamland Public School and the other is of BMJ College of Education affiliated to G.G.S. I.P. University, Delhi in the same premises. N.R.C. should have examined how two teacher education institutions affiliated to two different Universities function within the same premises. Regarding the status of faculty and Principal, it is understandable that affiliating University which has placed the institution under the label 'No Admission List', would not in natural course recommend selection of faculty and staff. There has also been a confusion over the place where institution was initially granted recognition and the present place of its existance. This confusion has arisen because the recognition order dated 02.09.2008 does not mention the precise address of the institution. N.R.C. relied on facts revealed in different reports and had reissued the deficiency letter dated 06.08.2012 and Show Cause Notice dated 15/01/2013 in pursuance of the appeal order dated 17/01/2014. The appellant thus got a fair chance for redressal. Appeal Committee also noted the submission made by appellant in his letter dated 07/09/2014 addressed to N.R.C. stating that no opportunity was given to college. Committee noted that the institution has been given enough opportunities for furnishing explanation on the points raised in the deficiency letter dated 06.08.2012 and S.C.N. dated 15/01/2013 and the Regional Committee has issued a detailed/speaking impunged order to which the appellant institution has not furnished a valid pointwise Memoranda of Appeal. Appeal Committee, therefore, concluded to confirm the withdrawal order dated 14.05.2015 issued by N.R.C. The appellant institution has prima-facie been found lacking with the approved faculty and infrastructure.

AND WHEREAS After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the withdrawal order dated 14/05/2015 issued by N.R.C.

WHEREAS The appeal of Ambigara Chowdaiah College of Education, Bangalore North, Bangalore Rural District Karnataka - 560064 dated 01/07/2015 is against the Order No. SRO/APS02219/B.Ed/KA/2015-16/64446 dated 12/05/2015 of the Southern Regional Committee, withdrawing recognition for conducting B.Ed. course on the grounds that Building Plan is not legible. BCC is not approved by competent authority. Institution had shifted without permission. Encumbrance Certificate is not submitted.

AND WHEREAS No one from, Ambigara Chowdaiah College of Education, Bangalore North, Bangalore Rural District Karnataka - 560064 appeared on behalf of the appellant institution on 03/09/2015. Appeal Committee therefore, decided to grant another (2nd) opportunity to the appellant to appear before the Appeal Committee for making a personal presentation of the case.

AND WHEREAS Prof. P.S. Edway, Member, Society managing the appellant institution appeared before the Appeal Committee on 28.10.2015. The documents which the appellant proposed to submit before the Committee were in Kannada language and were not acceptable as such. The appellant requested for another opportunity to submit English version of the documents for a better understanding. Committee decided to give the appellant another (3rd and final) opportunity to present the case.

AND WHEREAS Appellant appeared before the Appeal Committee on 14.01.2016 and furnished copies of following documents:

(i) Building Completion Certificate in respect of Property no. 18/1 and 18/2, Chokkanahalli Village

Built up Area

269109 Sq. Meters

(Issued by Gram Panchayat Kattigenahalli, North taluk, Bangalore.)

(ii) Encumbrance Certificate

(Property at 18/1 & 18/2 purchased by Nija Sharana Ambigara Chowdiah Maha Vidya Petha represented by its Chairman)

Ball

- (iii) Change of Land use Certificate dated 15/12/2011 issued by O/o Dy. Commissioner, Bangalore
- (iv) Copy of relevant page of Mutation Register.

AND WHEREAS Appeal Committee noted that a Show Cause Notice (S.C.N) dated 27.02.2015 was issued to the appellant institution seeking appellant's clarification on following points: -

- (i) Certified copy of land document.
- (ii) Upto date Encumbrance Certificate.
- (iii) C.L.U. issued by Tehsildar.
- (iv) Approved Building Plan.
- (v) B.C.C. from P.W.D. Engineer.

AND WHEREAS Appeal Committee further noted that the Building Plan and Building Completion Certificate submitted by the appellant in response to the Show Cause Notice do not match with the documents submitted alongwith appeal memoranda. Signatures on the B.C.C. are different but name of architect remains same. Building plan is prepared and signed by the same architect who has subsequently issued the B.C.C. Type of roofing in both the B.C.Cs has not been mentioned and builtup area is also different.

AND WHEREAS Appeal Committee is of the view that the appellant institution should not have shifted premises without getting approval of the S.R.C. Permission for shifting can be granted only after verifying the suitability of new premises and preparedness of the institution with regard to all the infrastructure including appropriate space for instructional purpose.

AND WHEREAS Appeal Committee also observed that S.R.C. Bangalore had accepted inspection fee of Rs. 10,000/- & Rs. 40, 000/- from the appellant institution which is for making inspection under relevant provisions of the NCTE Act. If Inspection is not conducted, the fee should be refunded.

AND WHEREAS Appeal Committee is of the view that appellant institution has failed to furnish compliance on points raised in the S.C.N. dated 27.02.2015. Committee therefore, decided to confirm the withdrawal order dated 12/05/2015 on grounds of failure

to submit a valid building plan, B.C.C. issued by competent authority and the institution's shifting premises without seeking permission.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the withdrawal order dated 12/05/2015 issued by S.R.C., Bangalore. Shifting fee remitted by the appellant institution should be refunded immediately.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the SRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the SRC is confirmed. Shifting fee remitted by the appellant institution should be refunded immediately.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

AND WHEREAS No one from, S.N.S. Institute of Education, 27, Residential, 27, Balarai, Mathura, Uttar Pradesh-281005 appeared on behalf of the appellant institution on 04/09/2015 and 28.10.2015 Appeal Committee decided to grant another (3rd & final) opportunity to the appellant for making a personal presentation.

AND WHEREAS Sh. Kamal Singh, Manager of the Society appeared before the Appeal Committee on 14.01.2016 and submitted that "the institution had already withdrawn its application for B.Ed. course and as such its application for D.El.Ed. should have been processed."

AND WHEREAS Appeal Committee noted the refusal order dated 18/05/2015 is on the ground that the appellant institution did not submit reply to Show Cause Notice (S.C.N) dated 22.01.2014. The above S.C.N. was on the ground that appellant institution had simultaneously applied for one unit each of B.Ed. & D.El.Ed. Appeal Committee noted that under Clause 8(2) of NCTE Regulations, 2009 no institution was allowed to apply for two courses simultaneously. The above restriction has been done away with in the revised regulations of 2014 and so the grounds on which S.C.N. dated 22.01.2014 was issued had become redundant. Appeal Committee further noted that appellant during the course of appeal presentation submitted copy of a speed post receipt dated 10.02.2014 as valid evidence of having submitted reply to S.C.N. dated 22.01.2014. The appellant vide its reply dated 10.02.2014 had opted for D.El.Ed. course withdrawing B.Ed. application bearing APP no. 6172.

AND WHEREAS Keeping in view that NCTE Regulations, 2014 donot forbid making simultaneous applications for more than one teacher education course and the appellant has also furnished reply to S.C.N. Appeal Committee decided to remand back the case to N.R.C. for processing of the application. Appellant is also required to furnish to N.R.C. copy of its letter dated 10.02.2014 alongwith copy of the speed post receipt within 15 days of the issue of appeal order.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to N.R.C. for further processing of the application. Appellant institution is required to furnish copy of its letter dated 10.02.2014 alongwith copy of speed post receipt to N.R.C., Jaipur within 15 days of the issue of appeal order.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC for processing of the application. Appellant is also required to furnish to N.R.C., Jaipur copy of its letter dated 10.02.2014 alongwith copy of the speed post receipt within 15 days of the issue of appeal order.

ORDER

WHEREAS the appeal of Hiralal Ramniwas Post Graduate College, Mill Road, Saraiya Khalilabad, Sant Kabir Nagar, Uttar Pradesh -272175 dated 05/08/2015 is against the Order No. NRC/NCTE/NRCAPP-2755/235th Meeting/2013/112262 dated 06/06/2015 of the Northern Regional Committee, refusing recognition for conducting M.Ed. course on the grounds that "the institution has not submitted the certified copies of land documents. Notarized copy of CLU issued by the competent authority has not been submitted by the institution."

AND WHEREAS No one from, Hiralal Ramniwas Post Graduate College, Mill Road, Saraiya Khalilabad, Sant Kabir Nagar, Uttar Pradesh -272175 appeared on behalf of the appellant institution on 04/09/2015 and 28/10/2015. Appeal Committee decided to grant another (3rd & final) opportunity to the appellant for making personal presentation.

AND WHEREAS Dr. Ajay Kumar Pandey, Principal of the College appeared before the Appeal Committee on 14.01.2016 and submitted that "the purpose of asking for registered land documents is to ensure that whether the concerned institution has land of its own or not. Under transfer of Properties Act there are several modes for acquiring ownership of land i.e. Will, Gift, Possessory title etc. The concerned institution is too old and at that time deed was not required. The C.L.U. of competent authority has already been submitted."

AND WHEREAS Appeal Committee noted that application of the appellant institution was first rejected <u>vide</u> N.R.C. order dated 18/12/2012 on ground of not submitting certified copy of land document. The N.R.C. order was remanded back by the Appeal Committee <u>vide</u> its order dated 03.04.2013 on the ground that impunged order inadvertently mentioned the name of course as D.El.Ed. whereas the course applied for was M.Ed.

AND WHEREAS Appeal Committee further noted that N.R.C. again issued a Show Cause Notice (S.C.N) dated 20.09.2013 on two grounds i.e. certified copy of the land documents and notarised copy of C.L.U. Incidentally the name of the course is again mentioned as D.El.Ed. instead of M.Ed. The appellant institution vide its reply dated 26.10.2013 furnished certificates issued Tehsildar Certifying that possession of land at R.G. no. 281/2.108, 282/0.100, 203/0.99 etc lies with Hiralal Ramniwas Post Graduate College.

AND WHEREAS Clause 5(4) of the NCTE Regulation, 2014 mentions that copy of registered land documents issued by competent authority shall be attached with application. Appeal Committee is of the view that mode of possession of land may be different i.e. sale/purchase, gift, allotment by any agency but documentary evidence has to be registered with details of source of acquisition. Simple possession certificate cannot be treated at par with the registered land documents. Appellant informed the Appeal Committee that the appellant institution is already conducting B.Ed. course since 2001 on the same land. Appeal Committee could not accede to this logic as land related norms were made stringent subsequently and wherever there are changes in the norms and standards, the institution shall comply with the requirements for additional programme/intake. Appellant has failed to furnish copy of registered land documents even in response to the S.C.N. Appeal Committee therefore, decided to confirm the refusal order dated 06.06.2015 issued by N.R.C.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 06/06/2015 issued by N.R.C.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Vatsalya College of Education, 140, Sri Hosamath, Shankarmath Road, Mysore – 570004, Karnataka dated 14.08.2013 is against the Order No. APSO4077/B.Ed./KA/ 2013-14/52167 dated 07/06/2013 of the Southern Regional Committee, withdrawing recognition for conducting B.Ed. course on the grounds that "the institution has not submitted the approval of the appointments of Principal from the University. 2. The building plan is not in the name of institution. 3. As per the copy of the sale deed submitted by the institution at Sy. No. 140/1AF3/1A situated at Hosamath, Shankar Math Road, Fort Mohalla, Mysore the institution is having a land area of 140x30 sq.ft. i.e. 4200 sq.ft. and a built up area of 50 squares i.e. 5000 sq.ft. As per NCTE Regulations 2009, the institution should have 1500 sq.mts."

AND WHEREAS Appeal Committee noted that the appeal was rejected and S.R.C. order was confirmed by the appellate authority vide its order no. 89-552/2013, Appeal/15th Meeting, 2013, dated 12.11.2013. Aggrieved by the withdrawal order dated 07/06/2013 and Appeal order dated 12.11.2013, the appellant had filed a Writ Petition no. 2397/2014 in the High Court of Karnataka at Bangalore. Hon'ble High Court in its order dated 27.08.2014 remitted the matter back to the Appellate Authority to reconsider the matter by assessing additional material if any put forward by the appellant institution. The appellant however, failed to appear before the Appeal Committee in its hearing held on 04.09.2015 and 28.10.2015 Since there was an embargo that proceedings shall be completed before the admission process for the ensuing academic year commences, NCTE issued notice of hearing to the appellant institution specifically mentioning that if the appellant fails to make appearance before the Committee in its next meeting and submit any additional document, the case will be decided on the basis of available documents without any further opportunity to the appellant for making personal presentation. Ms. Sujatha, Trustee and Sh. Mahesha, Principal of the College appeared before the Appeal Committee on 14.01.2016 and submitted before the Committee:-

- (i) Copy of order dated 17/12/2014 issued by University of Mysore recommending selection of a retired Principal 'Sh. Basavaraju' as principal for one year from the date of order.
- (ii) Building drawing of the property situated at 140/1A, F-3/1A, 140/1B, F-3/1B, 140/1, F3/3 and 140/8A, F3/8A, Shankar Matt Road, Fort Mohalla, Mysore.
- (iii) Copy of Property Tax Notice dated 19.06.2015 issued by revenue Inspector.
- (iv) Copy of a Rectification sale deed Property Measuring 30x140 feet situated at 140 Shanker Matt Road, Fort Mohalla, Mysore.

(v) Building Completion Certificate issued by Mysore City Corp. (Built up area 15218.13 sq. feet.) 5072 sq. feet on each floor.

AND WHEREAS Appeal Committee noted the background of the case. The impunged order dated 07/06/2013 was appealed against in August 2013 and was considered and confirmed by the Appeal Committee <u>vide</u> order dated 12.11.2013. Appellant filed a Writ Petition No. 2397 of 2014 in the High Court of Karnataka at Bangalore and the Hon'ble Court passed an order dated 27.08.2014 directing as under:

"Therefore, keeping these aspects in view if an opportunity is provided to the petitioner to put forth all materials before the Appellate Authority and if the Appellate Authority is directed to reconsider the matter taking note of all materials, interest of justice would be met. Hence, to enable the same, the order dated 12/11/2013 (Annexure-Z) passed by the second respondent - Appellate Authority is quashed. The matter is remitted to the second respondent - Appellate Authority to restore the case in F.No.89-55/2013. The petitioner is granted liberty to produce additional material if any before the Appellate Authority shall thereafter provide an opportunity to the petitioner, reconsider the matter and pass fresh orders in accordance with law.

In terms of the above, the petition stands disposed of. Needless to mention that the proceedings shall be completed before the admission process for the ensuing academic year is commenced."

Appeal Committee noted that by virtue of the directions issued by Hon'ble Court, the appellant has got an opportunity to remove the deficiencies on the basis of which recognition was withdrawn. Appellant was called upon to submit necessary evidence and the documents submitted by the appellant in the appeal hearing on 14.01.2016 are analyzed as under:

- (a) Copy of the order dated 17/12/2014 issued by Mysore University pertained to selection of a retired personnel 'Sh. Basavaraju' as Principal for one year from the date of issue of order. Mysore University order having been issued on 17/12/2014, the approval is no longer valid on 14.01.2016 i.e. the day of appeal. The appellant also did not submit any valid document to prove that Sh. Basavaraju continues as principal.
- (b) Building drawing submitted is not legible and the structure appears to be of a building containing ground + two floors.
- (c) Property Tax Notice dated 19/06/2015 mentions the address as Mutt Road, Khille Mohalla whereas in the rectification deed the address of property is 'Fort Mohalla'.
- (d) Rectification deed excepted on 23.01.2012 clearly indicates the property size as "East to West 30' and North to South 140" and constructed building on it with a plinth area of 50 square ground, first and second floor with R.C.C. roofing. Unit size after the words 50 square has been found to be blank. Appeal Committee is of the opinion that unit size at the most can be in Meters.

(e) As per copy of the Building Completion Certificate the details of construction are 5072.71 sq. feet area R.C.C. on each of the ground + first floor+2nd Floor.

Appellant could not convince the Appeal Committee as a how a plot measuring (30x140) total 4200 sq. feet can have a built up area of 5072 sq. feet on each of the floors.

AND WHEREAS the appellant was granted liberty to produce additional material before the Appellate authority by the Hon'ble High Court. Keeping in view the documents and submissions made by the appellant in the appeal hearing on 14.01.2016, Committee is of the view that appellant has only tried to mislead the Committee and it is still deficient for smooth conducting of the course even if the intake is reduced to 50 as the total strength of students in the second year of the course will be 100. Appeal Committee decided to confirm the withdrawal order dated 07/06/2013 once again.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the withdrawal order dated 07/06/2013 once again.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the SRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the SRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Ch. Shri Ram Yadav Mahavidhiyalav, Pativali, Pradesh dated against Kushinagar, Uttar 30/05/2015 is the Order NRC/NCTE/NRCAPP-6152/236th Meeting/2015/9849-952 dated 18/05/2015 of the Northern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "(i) As per online application the name of the institution is Ch. Shri Ram Yadav Mahavidyalaya, land is situated at Khasra No. 419 and 414, Vill. Pativoli, Dist. Kushi Nagar, U.P. but as per letter head the name of the institution is Ch. Shri Ram Mahavidyalaya situated at Patiyali, Kasganj, Etah, U.P. (ii) No land documents in respect of Khasra No. 419 and 414 have been submitted by the institution. (iii) The institution has submitted land documents with application in respect of plot/khasra no. 4195g, 3200g, 4148k, 4201g, 4225g, 4219kh, 4226kh, 4227g, 4228ch, 4234ch, 4235kh, 4236k, 4237k, 4238k, total 18 kita in favour of Sh. Shri Ram Yadav Mahavidyalaya, Paliyali, Etah. The institution has submitted Khatoni attached in page. No. 143, as per Khatoni the aforesaid land is mortgaged to Central Bank of India, Branch Patiyali."

AND WHEREAS Sh. Dharmendra Singh, Secretary, Ch. Shri Ram Yadav Mahavidhiyalay, Patiyali, Kushinagar, Uttar Pradesh presented the case of the appellant institution on 17/07/2015. In the appeal and during personal presentation it was submitted that "land is not mortgaged to Central Bank of India, Branch Patiyali."

AND WHEREAS The Committee noted that the appellant has not made any submissions in the appeal about two other grounds mentioned in the refusal order. The appellant, in the course of presentation, gave a letter dt. 17.07.2015 stating that he could not furnish explanation to all the grounds of refusal. He therefore requested that he may be given another opportunity to make submission. The Committee acceded to this request and decided to give the appellant another opportunity i.e. the second opportunity to present the case before the Appeal Committee. Accordingly the appellant was given second chance to appear before Appeal Committee on 28.10.2015 but the appellant failed to attend the hearing. Committee decided to grant another (third and final) opportunity to the appellant institution for making submission relating to the grounds on which recognition was refused. The appellant was accordingly given third & final opportunity to appear before the Appeal Committee on 14.01.2016. The appellant failed to make appearance before the Committee and therefore, Committee decided to settle the appeal on the basis of submission already made and the available records.

AND WHEREAS Appeal Committee noted that the appellant institution submitted online application in the name of 'Ch. Shri Ram Yadav Mahavidhiyalay' and the name of society was mentioned as 'Ch. Shri Ram Yadav Shiksha Samiti. Address of the institution and society was village Patiali, The. Patiali, Dist. Kushinagar, Uttar Pradesh. The institution was further proposed to be located at Khasra No. 419 & 414. Appeal Committee further noted that the building plan submitted alongwith application pertained to property at Khasra No. 90, Patiali, Kasganj.

AND WHEREAS N.R.C. Jaipur after initial processing of the application decided to conduct inspection of the institution at its address at Patiyali, Kushinagar, Uttar Pradesh. Secretary of the society furnished an affidavit dated 20.11.2013 stating that in the application address of institution was wrongly mentioned as Kushinagar and the correct place is Kasganj. There was no declaration made about the khasra numbers which were mentioned as 419 & 414 in the application and subsequently found to be khasra no. 90 in the building plan. Copy of khatoni mentioning that land is mortgaged to Central Bank of India as on 26.10.2013 was submitted by the appellant institution. The appellant also did not make use of the repeated opportunities given to him to appear before the Appeal Committee and justify his claim. Appeal Committee, therefore decided to confirm the refusal order dated 18/05/2015 issued by N.R.C., Jaipur.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Marwar B.Ed. College, Barmer Highway, Jodhpur, Rajasthan dated 22/06/2015 is against the Order No. NRC/NCTE/RJ-785/100025 dated 18/05/2015 of the Northern Regional Committee, withdrawing recognition for conducting B.Ed. course on the grounds that "reply to the Show Cause Notice dated 11.03.2015 submitted by the institution is not acceptable. There is no University in the name of Jodhpur University. Jodhpur National University is a private University which cannot be an affiliating University. The institution has misled the N.R.C. by submitting wrong information."

AND WHEREAS No one from, Marwar B.Ed. College, Barmer Highway, Jodhpur, Rajasthan appeared on 17/07/2015, 18/09/2015 & 28/10/2015. The appellant however, informed that due to some sudden exigencies he was not able to attend hearing on 18/09/2015 and 28/10/2015 and may be provided opportunity in future. Committee decided to grant a final opportunity to the appellant. Appellant was issued notice dated 22.12.2015 for making appearance before the Appeal Committee on 14.01.2016 but appellant again failed to make appearance. Appeal Committee noted that four opportunities on different dates were provided to the appellant to make appearance and appellant failed to make use of these opportunities for making a personal presentation of the case of appellant institution. Appeal matter is thus taken up on the basis of available records and the appeal memoranda.

AND WHEREAS Appeal Committee noted that appellant institution was granted recognition for conducting B.Ed. course by N.R.C. through its order dated 26.03.2008. The affiliating university to whom the copy of recognition order was endorsed was mentioned as 'University of Rajasthan, Jaipur'. N.R.C. issued a corrigendum on 23.09.2008 rectifying the name of affiliating University as 'Jai Narayan Vyas Vishwavidyalaya, Jodhpur. Another corrigendum was issued by N.R.C. on 02.12.2008 amending the name of affiliating University as 'Jodhpur University, Jodhpur'.

AND WHEREAS appellant institution has furnished copy of a letter dated 29.05.2010 addressed to Regional Director, N.R.C. by Registrar Jodhpur National University requesting that name of affiliating University of Marwar B.Ed. College, Jodhpur be changed because Jodhpur University, has been renamed as Jodhpur National University, Jodhpur. Relevant file of N.R.C. does not contain any evidence of this letter having been received and processed. Appeal Committee further noted that suo moto taking note of a news item published in "Dainik Bhaskar' of 21.01.2015 alleging distribution of fake degrees by Jodhpur National University involving Marwar B.Ed.

college, N.R.C. issued a Show Cause Notice (S.C.N.) dated 11.03.2015 on grounds of awarding degrees in excess of the approved intake. The appellant institution in reply to the S.C.N. informed N.R.C. Jaipur, by e-mail dated 14/04/2015 that degree is awarded by the affiliating University and as such desired information may be obtained from University. Appellate institute also denied having exceeded the approval intake.

AND WHEREAS Appeal Committee observed that N.R.C. decision to withdraw recognition was a hasty decision having been taken without proper investigation. N.R.C. should have verified the list of B.Ed. students admitted each year by the appellant institution vis-a-vis list of passed out candidates and degrees given to these candidates by the University. Authentic information about the status of Jodhpur University being renamed as Jodhpur National University should also have been collected and placed on record. Newspaper report alone does not justify imposing penalty before a final decision on the pending appeal is taken N.R.C. Jaipur is required to examine the matter thoroughly based on documentary evidence of the status of affiliating University. Decision on the appeal in kept pending. N.R.C., Jaipur is required to complete the exercise within 30 days of the issue of appeal orders.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record, Appeal Committee concluded to remand back the case to N.R.C. for furnishing the status of renaming of affiliating University as 'Jodhpur National University' and exact number in particular academic year in which the appellant institution has exceeded the approved intake.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records, the Committee concluded that the appeal deserves to be remanded to NRC, Jaipur for a detailed examination. N.R.C. Jaipur is required to complete the exercise within 30 days of the issue of appeal orders. Decision on the appeal is kept pending.

NOW THEREFORE, the Council hereby remands back the case of Marwar B.Ed. College, Barmer Highway, Jodhpur, Rajasthan to the NRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of SMD Girls College of Education, VPO-Kot Sukhia, District – Faridkot, Punjab dated 07/12/2015 is against the Order No. NRC/NCTE/NRCAPP-4752/238th Meeting (Part-IV)/2015/117355 dated 18/06/2015 of the Northern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "The institution was issued SCN on 11/05/2015 on the ground that land document submitted by the institution was on private lease which is not as per the provisions of NCTE Regulation. The institution vide its reply dt. 22/05/2015 has informed that a piece of land has been purchased in the name of SMD Girls College, Kot Sukhia on 08/05/2015. This establishes that applicant society/institution was not in possession of land on the date of application submitted on-line i.e. on 27/12/2012."

AND WHEREAS Sh. Raj K. Thapar, Chairman, SMD Girls College of Education. VPO-Kot Sukhia, District – Faridkot, Punjab presented the case of the appellant institution on 14/01/2016. In the appeal and during personal presentation it was submitted that "on 26/11/2012, the NCTE issued Public Notice inviting fresh applications from institutions desirous of seeking recognition for various Teacher Training courses for academic session 2013-14. The trust sponsoring the Appellant institution had desired to start B.Ed. course from 2013-14 academic session. Smt. Kamlesh Kumari one of the Trustees of the Trust was owner of certain piece of land. By a registered lease deed dated 27/12/2012 she leased some portion of the land owned by her to the trust for a period of 99 years for the purpose of establishing the Appellant institute. Possession of the land was handed over to the trust. On the basis of this registered lease deed dated 27/12/2012, the Appellant submitted an application with the Respondents for seeking recognition for B.Ed. course from academic session 2013-14. True copies of the lease deed dated 27/12/2012 and covering letter dated 27/12/2012 submitted by appellant with NRC are annexed. On 15/02/2013, the appellant submitted duly attested copies of the land documents in the office of the NRC. A true copy of letter dated 15/02/2013 submitted by appellant with NRC is annexed. The NRC processed the file of the appellant and vide letter dated 23/07/2013 it pointed out certain deficiencies requiring the appellant to cure the same within a period of 60 days. A true copy of deficiency letter dated 23/07/2013 sent by NRC to Appellant is also annexed. The appellant rectified all the deficiencies and vide covering letter dated 27/09/2013 submitted its reply with NRC alongwith supporting documents."

AND WHEREAS Appeal Committee noted that recognition for B.Ed. course applied by the appellant institution on 27.12.2012 has been reused by N.R.C. Jaipur <u>vide</u> its order dated 18/06/2015 on the ground that "appellant institution was not in possession of land

on the date of application and the land document submitted by the institution was private lease which is not as per the provision of NCTE Regulations'.

AND WHEREAS Appeal Committee noted the relevant provisions of NCTE Regulations, 2009 and NCTE Regulations, 2014 prescribe that 'no institution shall be granted recognition unless the institution or the society managing the institution is in possession of required land on ownership basis as on the date of application'. Land taken on lease from private bodies is not acceptable.

AND WHEREAS Appeal Committee having regard to the NCTE Regulations decided to confirm the refusal order dated 18/06/2015. Appeal Committee expressed its grave concern over the long delay of about 2 and a half years taken by N.R.C to take a decision on a case which merited summary rejection. Not only the application was processed but the inspection was also conducted on 04.04.2014 N.R.C. also decided to issue a Letter of Intent in its 233rd Meeting held on 18.02.2015. Notwithstanding the errors committed by N.R.C., Appeal Committee decided to confirm the refusal order date 18.06.2015.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 18/06/2015.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against

Hapur, Ghaziabad, U.P. - 245205 is dated 01/07/2015 the refusal Order of the Northern Regional Committee is on the grounds that "One of the documents submitted by the institution shows that land is on rent basis. Demarcated map submitted by the institution is not signed by Competent Authority."

AND WHEREAS Sh. A.C. Sharma, Director and Sh. Vipul Goel, Account Officer, Rajkumar Goel Girls Degree College, Garhmukteshwar Distt. Hapur, Ghaziabad, U.P. -245205 presented the case of the appellant institution on 03/09/2015.

AND WHEREAS Appeal Committee noted that relevant file from N.R.C. was not available. After obtaining the file from N.R.C., Appeal Committee considered the appeal matter in the 1st Meeting of Appeal Committee held on 14.01.2016. Committee noted that recognition for D.El.Ed. course was refused on two grounds i.e. (i) land is on rent basis and (ii) demarcated map submitted by institution is not signed by competent authority. Appeal Committee noted that appellant has not denied having land on rent (lease basis) and has only submitted that B.Ed. course was sanctioned on the same land. Appeal Committee observed that appellant society submitted application for D.El.Ed. course on 31.12.2012 under the NCTE Regulations, 2009 which lay down that no institution shall be granted recognition unless the institution or the society is in possession of land on ownership basis. The existing institutions not having land on ownership basis were allowed to run but were not allowed to expand by seeking additional intake or additional courses. Appeal Committee taking note of the regulatory provisions decided to confirm the refusal order dated 07/05/2015 issued by N.R.C.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 07/05/2015 issued by N.R.C.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.
